EITHER WAY, YOU MUST FIRST OBTAIN AN ELECTRONIC TRAVEL AUTHORIZATION (ETA) PRIOR TO BEING ISSUED THE VISA. CLICK HERE TO APPLY ONLINE FOR YOUR ETA APPROVAL BEFORE TRAVELING. VALIDITY: VISAS ARE VALID FOR UP TO TWELVE(12) MONTHS FROM THE DATE OF ISSUE FOR A MAXIMUM STAY OF (6) SIX MONTHS.

VISAS VALID FOR LONGER THAN SIX (6) MONTHS ARE USUALLY ONLY ISSUED FOR SPECIAL CIRCUMSTANCES AT THE DISCRETION OF THE VISA OFFICER. THE VALIDITY, DURATION OF STAY, AND NUMBER OF ENTRIES OF ALL VISAS ARE ISSUED AT THE SOLE DISCRETION OF THE VISA OFFICER. ONCE THE ETA HAS BEEN APPROVED IT MUST BE USED WITHIN 90 DAYS FROM THE DATE OF ISSUE.
