Thank you for your interest and support of the Fairfield County Hunt Club June Benefit Horse Show. The 93rd Fairfield County Hunt Club June Benefit Horse Show will be held June 21-25, 2016 and as always is open to the public. We are very excited this year to have returning as our two beneficiary charities associated with the horse show, the Equus Foundation and the Bridgeport Hospital Foundation.

In a typical year the Hunt Club welcomes more that 3,000 competitors, owners, trainers and spectators during the week of the horse show. Our spectators, participants and membership represent an upscale affluent and fashionable audience who are appreciative of the sporting lifestyle. In addition to our exciting competition, we will be hosting events throughout the week, including the Bridgeport Hospital Foundation Reception, on Thursday evening in conjunction with the \$7,500.00 Terex Welcome Stake, with extended hours for our exhibiting vendors. - Electricity is to be arranged in advance of the show so please mark off if you will require electricity in the space below.
- You will have a "check in" day and time agreed to by you and a representative of the Fairfield County Hunt Club.
- A certificate of insurance naming the Fairfield County Hunt Club as additional insured will be required and must accompany payment.
- Contract must be received by May 10, 2016 for listing in the Official Show Program
