

## **Congressional Introduction Letter**

A great way to start building your relationship with your Representative or Senators, and to establish yourself as a resource, is by sending a letter introducing yourself as a new grassroots leader with PAN. You should mail these letters to your Member's district office. We also encourage you to email a copy of your letter to your Member's office, and place a phone call to his or her staff in DC. You can find your Member's contact information by visiting www.House.gov or www.Senate.gov. This is a sample letter; remember to add your personal story to your letter. Please send a copy of your letter to PAN staff.
