ELIGIBILITY CRITERIA

- Must be Canadian citizen or Permanent Resident; and current resident of Fort McMurray
- Household income not to exceed \$135,000 (gross yearly income from all sources, after eligible allowances)
- Must qualify for first mortgage through a lender (minimum \$240,000)
- The majority of household income must be from employment
- Must be a first time home owner in Fort McMurray (cannot have been registered on title or held mortgage in 3 years, except spousal separation with agreement)

- Supporting documents for all applicable eligible allowances (receipts, bank statements, etc)
- Copy of 2009 T1 Notice of Assessment from Canada Revenue Agency or 2010 "T4" from employer for each adult
- Written landlord reference (from current landlord, not required if WBHDC tenant)
- Two written personal / character references
- Mortgage pre-approval from Lender (minimum pre-approval \$240,000)
