1. The downloaded tender should be submitted to Executive Engineer (TR), Kansari D.O. On cover, it should be distinctly indicated as **"Bid against Tender No KNSR – 04/2011"**.

Contractor will have to submit their offer in two bid (1) TECHNICAL BID (2) PRICE BID. They have to put the price bid sealed cover into the technical bid sealed cover other wise offer will be rejected.

2. The tenders must be sent by Registered Post / Speed Post only as to reach this office on or before last date for receipt of tender as stated in the Tender Notice up to 15:00 hours. Tenders which are received late after due date of receipt will not be considered.
3. The rates are to be submitted in price bid. Annexure – I

1. The vehicle is to be hired for a maximum 3000 KMs per month.
2. Rates for excess KM traveled by hired vehicle, beyond 3000 KMs:
 Rates for excess KMs traveled by hired vehicle beyond 3000 KMs per month is admissible occasionally, with written permission of circle head.
3. Any excess travel of vehicle beyond 3000 KMs by the officer in-charge of the vehicle & Shall be under the written/verbal approval of circle head and the same shall be regularized after taking approval from corporate office, Vadodara.
4. All road tolls/bridge tolls shall be reimbursed on production of proof of payment along with monthly RA bills.
5. The vehicle to be offered for hiring shall be in up-to date condition including its tubes, tyres, engine as well as conditions of its outside body. The vehicle to be offered shall not have been registered before more than 2 years as on the date of tender opening. However, in case of a very poor response or to break off the likely cartel, a relaxation can be granted for One year with permission of circle head. However, the officers placing an order should ensure that the condition of such vehicle is tiptop.
6. The period of the contract shall be for one year. The period further one year can be extended on mutual agreed terms as per same rates, terms and conditions. However, in case of poor services provided by the contractor, circle head shall be empowered to terminate the contract after one year.
7. The contractor shall immunize company's personnel against any claim arising out of accidents or misbehavior of the drivers. The vehicle shall be kept properly insured all the time to cover the 3rd party risk and simultaneously immunized company on account of likely claims from public, police dep't. etc.
8. The bills for traveling of the vehicle shall be paid on monthly basis.
9. Driver shall be preferably below the age of 40 years and never above 55 years. The lodging and boarding of driver shall be born by owner.
10. If the contractor fails to provide a vehicle; the deduction from his R.A. bill should be made on prorate considering the monthly rate payable with 26 working days per month or RS. 800/- per day whichever is higher.
11. The Driver should be provided with enough money to cover the cost of Diesel, repairs and incidental expenditure while in journey.
12. If you fail to execute the order successfully, the order will be got completed through other agency and if required to pay higher rates, in that case, difference of rates will be recovered from you.
13. Formula for considering price variation:
 No price variation will be payable on cost of Oil/ tyres, tubes etc. Only charges in price of Diesel will be adjustable. You must quote prices on the basis of prevailing 15 days before the Due date of tender. This basic rate shall be indicated in the offer. For every Ten (10) Paise increase of fuel, the price per KM shall go up by one (1) Paise. This will be applicable to the actual KM traveled during month.
14. For every Ten Paise increase in price of fuel, the price per KM payable shall go up by One Paise. This will be applicable to the actual KM traveled during the month.
15. In case of less use of 3000 KM, Minimum RS. 18500/- will be paid per month.
16. RS. 6/- per KM is to be paid for excess KMs. traveled beyond 3000 KMs. subject to approval of competent authority i.e. corporate office, Vadodara.
17. Rate of extra hour more than 12 hours per day will be paid along with monthly RA bills.
18. The contract includes the maintenance of vehicle periodically. The necessary diesel, oil, etc for vehicle shall be provided by the contractor.
19. During duty hours, no overtime or salary for holiday will be paid to the driver / contractor. Only one weekly off will be given.
20. If required, the GETCO can cancel the hiring contract after issuing one month notice.
21. The duty hours generally will be from 8.00 AM to onwards (Approx. 12 hours) and as per instruction of engineer in-charge.
22. In absence of hired vehicle for repairs or other reason, the contractor has to provide other vehicle with the permission of in-charge.
23. The estimated rates are inclusive of all taxes / charges and on firm basis.
24. During the order period, if you fail to give service on account of any reason, the order will be terminated by giving 7 days notice and security deposit will be forfeited.

1 GENERAL TERMS AND CONDITION

1.1 INVITATION OF TENDER:

The Executive Engineer (TR), 400 KV KANSARI D.O. for and on behalf of "GUJARAT ENERGY TRANSMISSION CORPORATION LTD", having its Head Office at Vidhyut Bhavan, Race Course, Vadodara - 390 007, hereafter called the "GETCO" intends to invite Tender for **"Hiring of Taxi/Maxi Permit closed body Diesel jeep vehicle in up to date condition alongwith driver for EE (TR) Kansari D.O. for one Year (1+8 Passenger passing minimum) {Latest model registered not before the month of January – 2009} at 400KV Kansari s/s"** as detailed in this specification.

1.2 DEFINITION:

1. The "GETCO" shall mean the Gujarat Energy Transmission Corporation Ltd, Vadodara and shall include their authorized representatives.
2. The "Contractor" shall mean the bidder, whose tender has been accepted by the GETCO for award of the contract and shall include his authorized representatives.
3. The "Engineer-in-Charge" shall mean the authorized officer of the GETCO to act as Engineer-in-Charge to supervise the work for the purpose of the contract.
4. The "Specification" shall mean the tender forming a part of the contract along with Performa, Schedules and Drawings.
5. The "Order" shall mean the official letter issued by the GETCO, informing the bidder that his tender has been accepted.
6. The "Contract" shall mean the agreement to be entered into by the GETCO with the contractor and shall include the commercial, technical and general conditions, schedules, drawings and any other conditions specifically agreed between the parties forming a part of the contract.
7. The "Contract Value" shall mean the total amount indicated in the contract agreement as per order placed by the GETCO and calculated from the provisional quantities indicated in the tender.
8. The "Completion Period" shall mean the period starting from the date of issue of commencement given by executing authority and required to complete the work.

1.3 AMENDMENT OF TENDER:

At any time prior to the submission of tenders, the GETCO may, for any reason, whether at his own initiative or response to a clarification requested by bidder, modify the Tender conditions by amendment. The amendment for the same will be declared the same web site.

1.4 THE TENDER:

1. The tenders must be sent by Registered Post / Speed Post only so as to reach this office on or before specified date & time. Due care should be taken to see that the tenders sent are posted early enough to ensure their delivery by the prescribed date or even earlier.

2. The tenders received after time and date specified in the tender notice, will not be accepted. Once the offer submitted by the contractor before due date of submission, the contractor will not be allowed to submit revised / additional / modified / other even before due date. However, if the issue and receipt of tender is extended by the Corporation due to any reason, the contractor may submit the revised offer before due date of submission, if he wish to submit.
3. The EMD will be forfeited by the GETCO in case of successful bidder who after his tender has been accepted, refuses to pay the security deposit, sign & complete the contract document before the validity of the offer. EMD of the unsuccessful tenderer will be refunded within 180 days of placing of the order with the successful Tenderer and when the Tenderer asked for refund to the Executive Engineer (TR), 400 KV Kansari, GETCO, the original receipt of the EMD together with the advanced stamped receipt should be furnished along with application for refund of EMD.
4. The bidder shall be deemed to have satisfied himself with all the conditions and circumstances affecting the prices and possibility of executing the work. The bidder shall fix his prices taking into account the site & its surroundings, approach roads etc. No idling / mobilizing / demobilizing / remobilizing OR any other type of claim shall be admitted and paid on any part of the work.
5. No deviations from the Terms & Conditions of the Contract & or Technical Specification stipulated in this Contract shall be permitted & the tenders received with deviations shall summarily be rejected.
6. The tenderer should fill in all schedules and submit all the details called for in this specification in prescribed Performa only.

1.5 GETCO'S RIGHT:

1. The GETCO reserves the right of terminating this contract or part thereof at time during its tendency without giving notice of Termination or the reasons thereof.
2. The GETCO will be entitled to deduct directly from the bills, to be paid to the contractor any sum or sums payable by him and which sum / sums the GETCO is required to pay as a principal employer on account of contractor default in respect of all liabilities referred to.
3. The bidders shall specifically note that any overwriting or corrections or manuscript in the bid shall be ignored and will not be considered authentic unless the same are signed with Bidder's Stamp / Seal.
4. In case of any doubt or interpretation of the terms and condition, the decision of the Superintending Engineer (TR), Gujarat Energy Transmission Corporation Ltd, Palanpur will be final and binding to the bidder and no dispute in this regard will be entertained.
5. The GETCO reserves the right to accept any bid irrespective of whether it is lowest or not or to reject any or all bids or cancel withdraw invitation to bid without assigning any reason there of. Such decision of the GETCO shall not be subject to question by any bidder or the GETCO shall bear no liability whatsoever for such decision.

1.6 CONTRACT:

1. The work covered by this Specification shall be carried out and governed by the GETCO's / GEB's Booklet of "General Terms and Condition of Contracts" herewith excepting where conditions specified in this Specification conflict with similar conditions in the Booklet. The tenderers will be deemed to be fully aware of this Booklet and any ignorance of the same will not exempt the contractor from his liability to abide the same.
2. The successful contractor will have to sign an agreement as per the GETCO's rules on stamped paper & the necessary stamp duty charges shall be borne by the contractor.

1.7 EFFECT AND JURISDICTION OF CONTRACT:

1. The contract shall be considered as having come into force from the date of issue of order, which is accepted by the Contractor.
2. The laws applicable by the contract shall be the laws in force in India. The court of DEESA shall have exclusive jurisdiction in all the matters arising under this contract.

1.8 FORCE MAJEURE:

1. The following clauses which substantially affect the performance of the contract shall only be considered as force majors conditions.
 - a) Natural phenomena, including but not limited to floods, droughts, earthquakes and epidemics.
 - b) Acts of any Government, domestic or foreign, including but not limited to war, declared or undeclared, priorities, guarantees, and embargoes.
Provided the party affected by the 'Force Majeure' shall within fifteen (15) days from the occurrence of such a cause, notify the other party in writing of such cause with sufficient documentary proof.
2. Notwithstanding any provision mentioned above, the GETCO shall not be in any way be liable for non-performance either in whole or in part of any contract or for any delay in performance thereof in consequence of strikes, shortages, combination of Labor or workman or lockout, breakdown or accident to machinery or accidents of whatever nature.
3. The Contractor or the GETCO shall not be liable for delays in performing their respective obligations resulting from any force majeure causes as defined above. The date of completion will be extended by a reasonable time by mutual agreement.
4. In case of damage or destruction of any property or equipments belonging to the Contractor due to force majeure causes, the GETCO shall not be liable for the same.

1.9 FAILURE TO EXECUTE ORDER:

In case of failure on the part of tenderer to cope up with the work within the stipulated period, the same will be got executed through other agency at the risk and cost of the tenderer even at higher rates and the difference in amount, if any, will be recovered from the bidder. The company reserves the right to cancel the order without assigning any reason.

- 1.10 All Electrical / Safety rules should be observed by the contractor while work. If any occurrence take place during the work, the contractor will be held fully responsible for the same.
- 1.11 Tenderer must quote rates only on firm price basis.
- 1.12 Income Tax as per prevailing rules will be deducted from the bills.

TERMS & CONDITIONS REGARDING INDUSTRIAL LAWS AND OTHER RELATED MATTERS

- (1) Wages to be paid at time of payment etc. by the contractor.
- (A) The contractor shall pay minimum prevailing rates per day or as may be specified hereafter or rates fixed under the minimum wages Act. Whichever is higher. The wages or very contract labour employed by him under this contract shall be paid by him before the expiry of 7th day of the month in respective of which the wages are payable (i.e. wages of a month have to be paid by him in the first week of the next month). The payment shall be disbursed in the presence of management representative during the working hours in factory premises and the contractor shall get the entries certified in the register of wages by the representative of the GETCO. Any default will result in cancellation of contract forthwith or also the contractor shall be paid punishable to the extent of Rs.100/- fine per each day.
- (B) The contractor shall give his telephone number and address to the GETCO so that in case of labour troubles etc. the contractor can be contacted. The contractor shall arrange to have his office outside the factory premises and the contractor shall keep himself present through out the working hours.
- (2) Labour Laws:-
- (A) Person below the age of 18 years shall not be employed for the work.
- (B) No. female worker shall be employed in the night shift between 7 p.m. to 6 a.m.
- (C) Contractor shall maintain a valid labor license under the contract labour (Regulation and Abolition) Act for employing necessary manpower to be required by him. In the absence of such license the contract shall be liable to be terminated without assigning any reason thereof.
- (D) The contractor shall at his own expenses comply with all labour laws and keep the GETCO indemnified in respective thereof. Some of the major liabilities under various labour and industrial laws which the contractor shall comply with are as under :-
- (i) Payment of contribution by way of employer's contribution towards provident fund, family pension scheme, Deposit linked insurance scheme, Administrative charge etc. at the rates make applicable from time to time by Government of Gujarat/Government of India or other statutory authority.
- (ii) Payment of deposit in respect of each contract labour at the rate as per admissible with the office of commissioner of Labour as per the contract Labour (Regulation and abolition Act.).
- (iii) License fee as prescribed under the contract labour (Regulation and abolition Act) and rules framed there under depending upon the number of workmen employed by the contractor.
- (iv) Paid leave facility and wages as per the provision of the factories Act at the rate of one day for every 20 days of working.
- (v) Identify cards as prescribed under the factories Act with photo at fixe there to the same identification. Liabilities as per industrial Disputes Act any payment to the contractor's employees arising out of any claim or disputes under the industrial Disputes Act, 1947 or any other labour laws.
- (vi) Payment of compensation in case accidental injury.
- (vii) Maternity leave as per the provisions of the maternity Benefit Act. The above are some of the major liabilities of the contractor in addition to other liabilities. Prescribed under the various labour laws in force from time to time from statutory authorities like State Government/ Government of India which the contractor shall have to comply with.

- (3) **Provident fund & Family pension Scheme :-**
The contractor shall submit along with his bill (month wise) a statement regarding deduction against employees provident fund and family pension scheme in respective of each concerned employee, provident fund and family pension scheme at the rate at admissible (or at the rate made applicable by the Government from time to time) of the wages. The contractor's contribution and his workers contribution towards provident fund and family pension scheme shall be deposited by the contractor with regional Provident Fund Commissioner, Ahmedabad.
- (4) **Deposit Linked Insurance Scheme :-**
The contractor shall have to deposit ½ % of the wage in respect of employees who is a member of the Provident Fund as the contribution to the deposit.
Linked insurance Scheme with Regional Provident Fund Commissioner.
- (5) **Administrative Charges:-**
Administrative charges for maintaining provident fund A/C shall be deposited by the contractor with Regional Provident Fund Commissioner, Ahmedabad at the rates applicable.
- (6) **Paid Leave Facility:-**
Paid leave facility at the rate of one day for every twenty days worked by the contract labour shall be provided by the contractor to his workers. He shall maintain leave Records/leave cards for individual labourer which shall be duly verified and approved/certified by the authorized officer of the GETCO.
- (7) **Workmen's compensation fund & Employer's Liability Insurance:-**
The contractor shall cover all his employees under workmen's compensation fund and under the liability insurance.
- (8) The contractor shall employ adequate number of experienced staff at site for dial supervision and for maintenance of various register and records required under the law and contract No. payment for supervision shall be admissible.
- (9) **Contractor to indemnify the GETCO:-**
The contractor shall indemnify the GETCO and every member officer and employees of the GETCO also, engineering in charge and his staff against all actions, proceeding, claims demands, costs and expenses which may be made against the GETCO or Government for or in respective of performance of his obligation under the contract documents. The GETCO shall not liable for or in respective of or in consequence of any accident or injury to any workman or other person in the employment of the contractor or his sub-contractor and the contractor shall indemnify and keep indemnified the GETCO against all such damage and compensation and against all claims, demands, proceedings costs, charges and expenses whatever in respective thereof in relation thereto.
- (10) **Workmen's compensation and employer's liability insurance:-**
Insurance shall be affected for the entire contractor's employee engaged in the performance of this contract. If any of the work is subject the contractor shall require the sub-contractor to provide workmen's compensation and employer's liability insurance for the latter's employees unless such employees are covered under the contractor's insurance.
- (11) The GETCO reserves the right to terminate this rate contract at any time during its tendency without giving notice of termination or any reasons thereof.
