SAMPLE - Self Employment

SAMPLE "Sworn Statement"

I, (*Full Name*), of the City of (*City*), in the Province of Ontario, make oath and say as follows:

1. I am an applicant to Brock University's Technological Education Teacher Education Program and make this affidavit in support of my application.

2. I confirm that:

Trim joints and fit parts and subassemblies together to form complete unit using glue and clamps and reinforce joints using nails, screws or other fasteners. Sand wooden surfaces and apply veneer, stain or polish to finished products. As the owner, my duties also included management, supervisory, sales and administrative duties, which represented approximately 33.3% of my normal daily activities (typically XX hours per week of my reported average work week of XX hours).
