

## BOY SCOUT TROOP 282 WESTSIDE PRESBYTERIAN CHURCH, 3601 CALIFORNIA AVE SW

The Troop's next outing is a two-night car camping trip to Camp Pigott near Monroe, and planned activities include canoeing, fishing, cooking, dutch ovens, day or night hike, campfires, games, Camporee practice, and more. Every Scout and parent planning on canoeing must have completed the BSA Swim Test THIS YEAR (i.e., in 2015). We will start the practice by refreshing the "Canoeing 101" basics, then we will get on the water and practice our canoe skills. A swimsuit, hat, sun block, sunglasses, whistle, and water shoes/foot protection are required, as are rain gear and a fleece jacket (Camp Pigott will provide canoes, paddles, and PFDs, but you may want to bring your own paddle and PFD if you have them). A pad to sit or kneel on is a great idea too. Meals will be planned, cooked, and paid for by Patrol Method.

### Scouts are to meet at the church Friday, May 22nd at 6pm.

Scouts will be returned to the Church around 5pm on Sunday, May 24th.

The fee for this trip is \$15 plus a portion of food costs, paid directly to the Scout who buys food in each Patrol. Portable electronic devices (iPod, CD players, radios, etc.) are not allowed (cameras are fine).

Driving Directions: I-90 east to I-405 north to Highway 522 east. Take Highway 522 east to its end at the stoplight where it intersects with Highway 2 in Monroe. Turn left onto Highway 2 and drive approximately .75 miles east. A Safeway and McDonalds will be on your left as you drive. Turn left onto Woods Creek Road. A red barn style gas station and deli is on the left corner as you make the turn. Continue approximately 10.3 miles on Woods Creek Road. Every time there is a fork in the road keep right. Turn right at the Camp Pigott sign and follow signs around the lake to the parking lot on the right.
