Do It Right - Stay Out of Jail: The Work of Treasurers

Do church treasurers go to jail? Separation of church and state does not exempt churches from compliance with IRS guidelines! Few, if any, church treasurers who act in good faith will go to jail for mistakes. The nominating committee may have forgotten to tell you that they are counting on you to know about and comply with IRS rules and regulations relating to churches.

Has your church taken the required steps to be a tax-exempt organization? Or has it merely assumed that all non-profits are tax exempt? Do the pledge statements and donation receipts issued by your church contain the language needed so that donors will not run into problems if audited by the IRS? Do the W2 and 1099 forms issued by your Church comply with IRS regulations? These and other topics relevant to church treasurers will be discussed in this workshop.

Managing Your Congregation's Assets: The Work of Trustees
