If you do not have a copy of the registration certificate as issued by the Jockey Club/
CTHS National office, your yearling may not be accepted for the sale.

2. Please compare markings described on the registration certificates to each horse you intend to consign and ensure that they are accurate. The CTHS Yearling Sales will not be responsible for the charges incurred because of incorrect markings nor will we be facilitating the correction of papers.
3. **You are required to bring your yearling's Jockey Club registration certificates to the CTHS Sales office on the day of the sale.**

The CTHS Board of Directors has implemented some minor revisions for the upcoming 2011 Prairie Lily Sale.

1. This year's Prairie Lily Yearling sale will be held on:

Saturday, September 10th, 2011 at 1 P.M.
2. Horses **MUST** be in the Marquis Downs barn area by 1 pm FRIDAY Sept. 9th, 2011, as Vet checks for the sale yearlings will be done at 3 pm.

Any horses that are late will pay a late fee for their Vet check
3. Horses will be available for viewing on:
 - a. Friday afternoon from 1 pm until 10 pm, and
 - b. Saturday morning from 10 am to sale time.
4. Upset Price: \$1000.00 (can be waived)
5. You will be required to remove your sale yearlings from the grounds by noon Sept.11, 2011.

There are two (2) options (Option A and B) to ensure your yearling is eligible for the 2012 Prairie Lily Sales Stakes Race.

Option A:

Entry (Cataloguing) Fee: \$100.00 plus GST (\$ 105.00; mailed to CTHS along with photocopy of registration certificate)

Commission: 5% (five percent of final accepted bid, a minimum commission of \$100)

In fee: \$200.00 (payable out of sales proceeds)

Out Fee: \$200.00

Option B:

This initiative has been implemented to enable consignors who do not want to sell their yearlings at public auction, but wish to make them eligible for the 2012 Prairie Lily Sales Stake Race.

These yearlings do not have to be brought to the sale and do not have to go through the sales ring but require a nomination fee to remain eligible for the 2012 Prairie Lily Sales Stake Race.

Entry (Cataloguing) Fee: \$150.00 plus GST (\$157.50; mailed to CTHS along with photocopy of registration certificate)

Full (Option B) payment of \$ 600.00 due by Sept. 1, 2011.

(this amount covers both the 'in fee' and 'out fee'.)

**TERMS AND CONDITIONS:**

1. Anyone nominating to the Prairie Lily Sales Stake agrees to abide by the terms and conditions for the Prairie Lily Sales Stake to be run in 2012 at Marquis Downs.
2. The CTHS Board of Directors will determine the purse, whether added or guaranteed as is deemed necessary by the availability of funds.
3. The purse will be determined based on the number of yearlings catalogued, the fees collected, and any additional monies that may be available from the graded scale.

If the CTHS Directors determine that the purse is sufficient and there are an adequate number of yearlings of each gender, the race may be split as a race for colts/geldings and a race for fillies. Alternatively a filly's bonus may be included if only one race is run.
