ADJUSTMENTS TO SCHOOL CALENDAR

Wicomico County Public Schools has made two adjustments to the 2014-2015 school calendar:

UPDATE TO SCHOOL VISITOR POLICY

As the school system strives to create the most positive safe learning environment for our students that we can, and to keep stride with the technology, our visitors' policy will be incorporating the Passage Point Sexual Offenders Registry Identification System. Each visitor will be required to use their driver's license to swipe at their school's visitor kiosk. With successful identification through the system, the visitor will gain access to the desired building location. This protocol is being implemented to assist schools with added safety and security. ELIGIBILITY TO ATTEND PROM

Students who wish to attend prom must meet the dance criteria based on Wicomico County Policy:

- 2.0 or higher requirement per county policy
- No suspensions during the semester in which the dance occurs
- Eligible for extracurricular activities per suspension policy

The qualifying period is from January 24, 2015, to April 24, 2015. The prom is on April 25, 2015. Wicomico County BOE policy requires that a student **must be** in attendance for the school day in order to participate in any school-related activity. **This means that students attending prom must be in school on April 24, 2015**. Appointments to get your hair and nails done, pick up flowers and tuxes, etc., for prom are not excused absences. Please make your appointments accordingly. **If your date is a Mardela student, he/she must also meet the dance criteria**.

ELIGIBILITY TO ATTEND MIDDLE SCHOOL FORMAL

Students who wish to attend the middle school (semi-)formal must meet the dance criteria based on Wicomico County Policy:

- 2.0 or higher GPA
- No suspensions served during the semester in which the dance occurs
- Eligible for extracurricular activities per suspension policy
- No guests allowed from outside the school

The qualifying period is from January 24, 2015, to March 27, 2015. The dance is on March 28, 2015, at MMHS. Wicomico County BOE policy requires that a student **must be** in attendance for the school day in order to participate in any school-related activity. **This means that students attending the middle school dance must be in school on March 27, 2015**. Appointments to get your hair and nails done, pick up flowers and tuxes, etc., for the dance are not excused absences. Please make your appointments accordingly.

The Mardela Middle & High School PTA will present (3) scholarships to graduating Mardela High School seniors. Guidance counselors will accept applications from qualified students for consideration by the PTA committee. The award amount of \$500 will be presented at the Senior Awards ceremony.

To be eligible for consideration for the award applicants must:

- 1. Submit a completed application form by April 30.
- 2. Be a graduating senior who has attended Mardela Middle & High School for a minimum of two years.
- 3. Be a current member of the Mardela PTA or have a parent/guardian who is a current member. Also must have been a PTA member for the Junior year at Mardela.
- 4. Have a cumulative un-weighted GPA of 3.5 or higher.
- 5. Have demonstrated service to Mardela through participation in school organizations, athletics, events or volunteerism.
- 6. Have a history of demonstrating high ethical standards.
- 7. Have documented community service beyond the 75 hours required for graduation.
- 8. Be planning to attend a two or four year post-secondary school.

Preparation for MS District Band Festival (Mardela MS Festival Band)

The Mardela MS Festival Band has been chosen from all the 6th, 7th, and 8th grade band members who auditioned and music has been distributed. We will have 4 practices only (due to snow) leading up to the MS District Band Festival to be held at Stephen Decatur HS on Thursday, March 26 (details TBA). These practices will be on March 4 (Wed) and 12 (Thurs), from 2:45-5:00 p.m., and March 18 (Wed) and 25 (Wed), from 2:45-4:00 p.m.

For those who are not aware the event, the MS District Band Festival is an opportunity for the Mardela Middle School Festival Band to play music from a graded list for three judges on stage and before several other school bands from around Maryland's Eastern Shore. The judges will make comments on note & rhythmic accuracy, tone and balance, and interpretation; they will ultimately judge the band as "Superior", "Excellent", "Good" or otherwise. The same will be done by one judge when the band is given a piece of music to sight read for the first time. In the end, if the four judges' scores average out to "Superior", the band qualifies to go to a second level of judging at the state level.

In 2014, our Mardela MS Festival Band received a "Superior" rating at the District Festival and qualified for the State Festival, where they received an "Excellent" rating; both of these were historical firsts for Mardela Middle School!! Aim just as high for 2015!!

DRESS CODE POLICY

(Revised and Approved 3/9/10) (Effective 2010-11 School Year)

Schools have three primary responsibilities with respect to students. The first responsibility is to foster academic achievement. The second responsibility is to create and maintain a school environment that is safe, orderly, and conducive to learning. The third responsibility is to promote and support positive community standards and values such as civility, respect for others, self-respect, citizenship and other constructive character traits and behaviors. Without these, teaching and learning will be negatively impacted.

Students have the responsibility to choose their attire, arrange their personal appearance, and maintain their personal hygiene in a manner that is safe, healthy, non-offensive, and conductive to the educational process. The student dress code is intended to create a positive school climate of respect for self and others, reduce the occurrence of discipline problems, and maintain safety and order in the school so that effective teaching and learning can take place.

School staff members have the responsibility to report violations of the Dress Code Policy and respectfully address students who are out of compliance with the policy. Administrators have the responsibility to investigate these reports, encourage students to make better choices in attire, and assign appropriate consequences for infractions. It is also the responsibility of the administrators and the staff to maintain an awareness of attire related to gang affiliation so that the Dress Code Policy can be implemented effectively. A teacher or staff member is expected only to report violations and is never expected to measure or touch a student they feel is in violation of the Dress Code Policy. Specific units of measure for widths and lengths are provided to ensure that the policy is measurable and to alleviate misinterpretations of the policy.

This policy shall apply to all students during the regular school day and at such other times as designated by the principal. This policy shall apply in all school buildings and on all school grounds, on all school buses and other school vehicles, and at all school-related, or Wicomico County Board of Education sponsored activities, including, but not limited to school field trips and school-sponsored events.

Principals may grant exceptions to the dress code for disabilities or sincerely held religious beliefs if such accommodations are reasonable and do not pose a hardship for the school. Principals may also grant exceptions for specific, school-sponsored events or situations. This policy includes Physical Education class attire. Guidelines for sports and extra-curricular uniforms worn during the school day are at the discretion of the principal.

Decisions concerning any dress code issues which are addressed or inferred in this policy are ultimately at the discretion of the building principal.

HEAD COVERINGS

Head coverings may not be worn in the school buildings. Prohibited head coverings include:

- Hats
- Head coverings of any kind, including bandanas, visors or hoods
- Sunglasses
- Curlers, picks or combs
- Anything deemed gang related

Head bands should be no wider than one and one-half (1 ½) inches. Hair should be neat and well-groomed. Principals may grant exceptions to the dress code for head coverings for sincerely held religious beliefs or for medical conditions.

TOPS

Tops should:

- Cover the entire back and shoulders (including tank-style tops; razorback style tops are inappropriate)
- Cover the midriff and back when sitting or standing
- Be of sufficient thickness so that undergarments cannot be seen
- Fit modestly so that cleavage is covered (as measured by a horizontal line across the top of the arm pit)
- · Cover undergarments completely (including bra straps, muscle shirts, beaters, and camisoles)
- Fit so they are not tight to the skin or overly baggy

BOTTOMS

All bottoms should:

- Cover undergarments at all times
- Be of safe length (cannot drag on floor)
- Be worn no lower than the natural waistline
- Remain at natural waistline without assistance other than a belt or suspenders (measured by child placing hands on hips)
- Not resemble what is considered bedroom attire
- Fit so they are not tight to the skin or overly baggy (leggings and tights are not appropriate bottoms)

Skirts, dresses, and jumpers should:

- Be no shorter than 3" above the top of the knee while standing (width of a 3" X 5" index card)
- Be no shorter than 3" above the top of the knee even when worn with leggings or tights

Skorts and shorts should:

- Be no shorter than 5" above the top of the knee while standing (length of a 3" X 5" index card)
- Be no shorter than 5" above the top of the knee even when worn with leggings or tights

OUTERWEAR

Outerwear (jackets and coats made specifically for outdoor use) should:

- Be removed upon entering the building and stored appropriately
- Note: Principals may alter this requirement as necessary for the specific conditions within the school

FOOTWEAR

Footwear should:

- Be worn at all times
- Fit secure enough to the foot for safe movement
- Not resemble what is considered a bedroom slipper
- Have a hard or rubber sole
- Not have such a high heel as to cause concern for safe movement throughout the school
- Be appropriate to the student's educational program (i.e. steel-toed shoes for construction classes, tennis shoes for Physical Education classes)
- Elementary students:
 - o May not wear flip flops to school
 - Must wear shoes closed in the back or have a back strap on footwear such as sandals or clogstyle shoes

JEWELRY, PIERCINGS, PERFUMES AND ACCESSORIES

Jewelry, piercings, perfumes and accessories should:

- Be modest without attracting undue attention to the wearer
- Be unobtrusive so as not to endanger others' ability to be comfortable and healthy
- Not have an overwhelming fragrance so as to infringe on others' comfort and health
- Have no parts that may be perceived as a weapon (i.e. spikes)
- Have no chains, large belt buckles or adornments that could cause, or be perceived to cause, injury or damage
- Include only those scarves which are intended for indoor use

APPEARANCE, LANGUAGE ON CLOTHING, SYMBOLS, TATTOOS AND MESSAGES

Student appearance, language on clothing, symbols, tattoos and messages must not show, reference or infer:

- Profanity
- Drugs, alcohol, tobacco, firearms, or weapons
- Violence or abuse
- Suggestive and/or sexual messages
- Language, brand logos or symbols as or on attire that offend, demean, or promote hatred toward an identifiable person or group based on a person's race, color, religion, ethnicity, national origin, ancestry, gender, sexual orientation, or disability

- Words, symbols, or placement of writing on clothing deemed inappropriate for the school setting such as rude, disrespectful, or discourteous expressions that would have an effect on the learning environment
- Anything deemed gang-related

CONSEQUENCES FOR VIOLATION OF THE DRESS CODE POLICY¹

- First Offense:
 - Student conference with administrator to discuss the violation(s) and review the dress code policy
 - Parent contact by the administrator to discuss the violation of the policy and subsequent consequences should more violations occur
 - O Change of clothing by student to rectify violation (provided by the student or parent)
 - O Student will be placed in ISS until appropriate clothing is secured
- Second Offense:
 - Student conference with administrator to discuss the violation(s) and review the dress code policy
 - Parent contact by the administrator to discuss the violation of the policy and subsequent consequences should more violations occur
 - O Change of clothing by student to rectify violation (provided by the student or parent)
 - O Student discipline disposition at the discretion of the administrator
 - O Student will be placed in ISS until appropriate clothing is secured
- Third and Additional Offenses:
 - Student conference with administrator to discuss the violation(s) and review the dress code policy
 - Parent contact by the administrator to discuss the violation of the policy and subsequent consequences should more violations occur
 - O Change of clothing by student to rectify violation (provided by the student or parent)
 - Student assignment to in-school or out-of-school suspension day(s) (at the discretion of the administrator while utilizing progressive discipline²)
 - O Student will be placed in ISS until appropriate clothing is secured

¹Administrators should refer to Code of Conduct when assigning consequences for violation of the Dress Code Policy

²Progressive Discipline – an approach that promotes positive student behavior and enables the administrator to choose consequences in an increasing manner from least to most severe
