Our Big News!

Perhaps you've heard...it's time to get ready for the first low-cost, high-volume, high-quality spay/neuter clinic in Pierce County! Peninsula Spay/Neuter Project (PSNP) has formed a coalition with other local animal welfare organizations in order to start offering affordable spay and neuter services to our community and beyond.

PSNP applied for, and was accepted into, the Humane Alliance National Spay/Neuter Response Team program, a program sponsored in part by PetSmart Charities and the ASPCA. Humane Alliance is located in Asheville, North Carolina and it has created a nationally recognized high-volume, high-quality, low-cost spay/neuter clinic to serve its community.

The goal of its national program is to help other groups develop and start model spay/neuter clinics around the country, providing mentoring and assistance in replicating their best practices model. They have helped create 21 such clinics around the country.

Recently, three representatives from Peninsula Spay/Neuter Project traveled to Asheville, donating their time and travel expenses. Holly Bukes, Patty Rusnak and Kelly Wolff spent a day at the Humane Alliance clinic – touring the facility, observing the operation and gaining important information and training in order to bring a spay/neuter clinic to Pierce County.

Back here at home, Coalition: HUMAnE, a project of PSNP, has been started in partnership with the Humane Society for Tacoma and Pierce County in order to get our community spay/neuter clinic up and running. Several area rescue and adoption groups have also joined this effort to help end pet homelessness.

You know our track record! Peninsula Spay/Neuter Project has been offering spay/neuter assistance for just over five years yet we have become one of the top ten providers in the entire state of Washington. We are excited to take this next step in order to help the animals.

We need to raise \$200,000 to cover the cost of equipment, renovations and start-up operations. To date, we've raised \$55,000 of this funding. Provided we can raise the necessary funding, we anticipate having a clinic operational by the end of 2007. Please visit www.coalitionhumane.org for more information.

Those of us who tirelessly seek to end animal suffering, whether by rescue or through prevention, at times feel overwhelmed and hopeless in our quest. It is at these times that we must remember that great civilizations and movements have been developed by people uniting together for a common purpose when competition has made life more difficult or resources scarce. At the beginning of the year, PSNP and the Humane Society for Tacoma and Pierce County both realized that it was becoming more and more difficult to handle the excessive amount of cats that were overwhelming both organizations.

Recognizing that we needed to share our resources, Project Cat-Nip was started. Project Cat-Nip combines the knowledge that PSNP has gained over the past five years working with feral cats with the generosity of funding and volunteer support from HSTPC and the veterinary services of the Feral Cat Spay/Neuter Project. Through this collaborative effort we are able to trap, transport and alter up to 150 cats each month. Essential to the success of the collaboration is accentuating each organization's strengths and knowledge not our differences. To date, over 400 cats have been spayed or neutered. The challenges we have faced as individual organizations and collectively are the catalyst for Project Cat-Nip's success.

Two Paws Up

To The Humane Society of the United States (HSUS) for their six years of lobbying efforts that finally led to the U.S. Senate and House of Representatives passage of H.R. 137 (S. 261), the Animal Fighting Prohibition Enforcement Act. This law now makes it a federal felony to transport fighting animals and equipment between states, which gives local law enforcement officials some much needed weight behind their efforts to shut down dog fighting and cock fighting

"This victory reminds us to never to give up, and that there are rewards for compassionate action and perseverance," said Wayne Pacelle, HSUS President.

Kudos also to Washington's own Senator Maria Cantwell, who helped co-introduce the legislation in the Senate. Interestingly, while the Senate

Two Paws Down

To the U.S. Food and Drug Administration for their tragically bungled management of the recent massive pet food recall. By not providing veterinarians with a channel to report cases of poisoned pets, vets were left searching for much of this information elsewhere. Recent accounts suggest that tremendous numbers of animals have become ill and died from contaminated food, well before Menu Foods and others publicly announced the source of the poison and the voluntary food recall.

According to Christie Keith, editor of Pet Connection, a nationally syndicated UPS feature, the timeline of events surrounding the recall shows that the FDA really missed its mark in protecting consumers from feeding their pets contaminated food.

"Nearly one month passed from the date Menu got its first report of a

death to the date it issued the recall. During that time, no veterinarians were warned to be on the lookout for unusual numbers of kidney failure in their patients. No pet owners were warned to watch their pets for its symptoms. And thousands and thousands of pet owners kept buying those foods and giving them to their dogs and cats," Keith writes in an article printed in the San Francisco Chronicle.

When the FDA finally did step forward, they drastically scaled down the true impact. Their report cited only 12-15 confirmed pet deaths, but these were only the deaths reported by Menu Foods in their lab testing of the contaminated food. In Menu Food's testing, over 20% of cats became ill. Extrapolating this data, and comparing to independent vet reports and a comprehensive report from Banfield vet hospitals, the true number of illnesses and deaths is likely to be in the tens of thousands.




