## A MESSAGE FROM YOUR VNA PRESIDENT

As I'm writing this message it has been raining for three days. I can't tell you how welcome this rain is. This has been a summer of records – the number of days over 100 degrees, the complete lack of rain, and Lake Travis dropping to its third lowest level in history

The VNA wants to thank each and every person who assisted in the Clean Up Lake Travis effort. Lonnie Moore and Al Blunt took leadership positions in making this happen and the results have been amazing. Many industrial size dumpsters were filled with material taken out of our lake and its coves. With the water level are record lows it was a perfect time to remove debris to ensure safe and healthy use of the lake going forward. Regarding our lake levels, please read Judy Graci's update on the activities of the BCRUA. They continue in a singular focus to move forward with construction plans for the water line up Trail's End Road. We must stay vigilant in an effort to get them to seriously consider other alternatives.

Regarding our roads, please read the update provided by Ryan Janda. As your representatives we are trying to stay very updated on the construction plans for WTP#4 and its impact on Bullick Hollow Road, as well as the right of way acquisition progress along 2769 leading up to 620. We will have some interesting traffic concerns once construction starts.

Don't forget to stop by regularly and peruse the new lighted information sign in front of the Volente Fire Station next to the Mailbox. There are three sections – one for the Village of Volente, one for the Volente Fire Department, and one for the VNA. We will all try to have pertinent and helpful information posted there. Many thanks to Lonnie Moore for taking the lead on making this happen and providing a very nice upgrade to the Village.

We also need your MEMBERSHIP in the VNA in order to do the community activities that benefit you all. We have approximately 60 paying members out of a population of near 400. We need your interest, and we need your annual payment of only \$15 per family to give us the wherewithal to do our work.

#### BCRUA WATER INTAKE FACILITY AND PIPELINE THROUGH VOLENTE UPDATE

With all the media attention on the drought, there has been no mention of the BCRUA's proposed plans to start construction on their Lake Travis project this fall. Where would the lake be if the BCRUA was pumping their maximum capacity through the summer? In August of 1950, Lake Travis was at 637msl and in one year it fell to 617msl. With 2010 usage, where could the lake be next year?

With all the media attention on the drought, there has been nothing on the Simsboro Aquifer. Instead of developing this huge second source of water, the BCRUA is planning another project into the same single. over-promised source. These Williamson County Cities don't need another interbasin transfer. The Simsboro Aquifer is in their basin and it is considered drought-proof. The BCRUA should bring a second major source of water to Central Texas. A private water corporation with permits for 51,000af out of the deep Simsboro Aquifer in Milam and Burleson Counties can pipe treated water down Hwy 79 to the SH 130 intersection just east of Round Rock. Why is the BCRUA allowed to use more Lake Travis water?

The LCRA/Leander interbasin transfer permit for an additional 17,600af is pending at TCEQ with many requests for contested case hearings. The TCEQ is in technical review of the application responding to the public meeting information. Leander's Mayor Cowman has no concern in starting construction of the project although this permit is Leander's water right for the BCRUA. 75% of Phase 1 construction would be built to the project's planned capacity. Since Leander is almost 50% of the BCRUA project, what happens if the permit is denied? Leander's City Engineer said that there could be a moratorium on building in the Brazos Basin. Water rights permits should be obtained before constructing the facilities and pipelines.

BCRUA President Mitch Fuller stated that the Village of Volente would have responsive reports in August, but Jacobs Engineering was only authorized to start the due diligence report on the Jackson intake site in July. Jacobs Engineering has not been authorized to work on the cost/impact and benefit reports for the Village.

## **ROADWAY IMPROVEMENTS**

**BULLICK HOLLOW RD** - a contractor was chosen in August 2009 and work will begin this fall and will take about four months. The improvements will include left turn lanes and widening the existing road pavement in locations to accommodate construction traffic at the secondary entrance into the plant, which is located just west of the intersection of RM 620 and Bullick Hollow Road. A climbing lane will also be constructed at the entrance of the raw water pump station to accommodate heavy truck traffic turning out of the pump station and onto Bullick Hollow Road.

<u>ANDERSON MILL RD</u> – the widening of Anderson Mill Road from FM 2769 to FM 620 has been funded and TX DOT is in the process of right of away acquisition.

## LEANDER FILES TCEQ PETITION TO DISCHARGE SEWAGE EFFLUENT INTO LAKE TRAVIS

The cities of Leander and Granite Shoals filed a Petition for Rulemaking at TCEQ that would do away with the current restrictions preventing discharges of sewage effluent into Lake Travis and the other Highland Lakes. Leander wants to build a new wastewater plant that would discharge into a creek that flows into the Sandy Creek arm of Lake Travis, which should be of special interest to Volente.

Granite Shoals would dump into Lake LBJ which, during normal flow years, would result in the effects of their discharge also reaching Lake Travis where water (and contaminants) get stored.

Even worse, the petition does not seek special permission for limited situations, but rather asks for an entire repeal of the rules which protect the Highland Lakes, allowing sewage effluent discharge into the lakes by any number of existing and future operators. Because this threat is imminent and so important, more detailed information will be coming directly from the <u>Protect Lake Travis Association</u> (http://www.protectlaketravis.org) via their new electronic newsletter rather than the Volente e-News. Subscribers to the e-News will automatically receive this information, but can elect to opt-out at any time.

## **RESULTS FROM SHORELINE CLEANUP**



Results are in from the Volente Shoreline Cleanup and they are indeed impressive:

1) Debris: Six 30-yard dumpsters for a total of 180 cubic yards, weighing at total of 18 tons;

2) Recyclable steel: One 30-yard dumpster was filled with steel weighing 4.5 tons;

3) Tires: 76 4) Batteries: 31

We impressed the heck out of the folks at Keep Austin Beautiful and Colorado River Foundation that organized the lake-wide 15th Annual

Underwater and Shoreline Cleanup. They normally see a total of 1-2 dumpsters filled during the event.

Lakeway made a similar effort, also organized by <u>Protect Lake Travis Association</u>. They ran a close second, also with 180 cubic yards of debris. However, their total tonnage was only 12 tons compared to our 18 tons - they just did not pack their dumpsters the way we did in Volente (photo).

We need to single out and thank: Jan Yenawine (top photo) for extensive use of his time and barge to transport materials; Frank (photo right) and Carrie Carter of <u>Highland Lakes</u> <u>Marina</u> who let us use their location, boat ramp and equipment; Todd Kahler of <u>Anderson Mill Marina</u> for use of his facility and personnel; Don Green and his company, <u>Central Texas Refuse</u>, for their donations, reduced pricing and cooperation; <u>Waste Management</u> for donating two dumpsters at Anderson Mill Marina; the city council of Village of Volente, which provided the much-needed



contingency funds which allowed us to keep going long after we exceeded the donated dumpster capacity; <u>Volente Neighborhood Association</u> for additional funds and support; Robert Nelson of R. Nelson Concrete who brought his backhoe/loader to help load and pack dumpsters; Al Blunt for providing planning and coordination; and Walt Thompson, who was the first to take charge of a cove cleanup and showed us all how it could be done. And a big THANK YOU to all of you who participated.

Safe Haven offers sixteen beds and eight semiprivate rooms, three meals a day, and laundry facilities to all of their residents. It also provides a place for residents to heal and prepare for re-entry into society.
