TERMS AND CONDITIONS

1. **Contract:** This application for space, when accepted by Management shall constitute a contract between the Exhibitor and the Management and in addition to its terms, shall include and incorporate the Exhibitors terms and conditions printed on this application.
2. **Qualified Exhibitors:** Show Management reserves the right to decline, remove or prohibit any exhibit or part of an exhibit, which in its opinion is not suitable to, or in keeping with the character of Dogs Day of Summer.
3. **Material Handling:** All material handling is the responsibility of the Exhibitor. Staff of the Welland Canals Centre and Management is not responsible for loading, unloading, transport or set up of Exhibitors' booths or displays.
4. **Exhibit:** Exhibitors agree to confine their exhibits within the contracted booth space only.
5. **Sub-License:** Space contracted by the Exhibitor may not be shared with any other company without the prior written permission of Show Management.
6. **Postponement:** Management reserves the right to postpone or cancel the show at its sole discretion. The option to participate in future shows is at the sole discretion of the Exhibitor/Sponsor.
7. **Insurance/Damages:** The Exhibitor is solely responsible for their own liability and property insurance and assumes full responsibility for any damages caused by their use while on Welland Canals Centre property. Welland Canals Centre's insurance will not protect the vendors if they are sued for an alleged negligence arising out of their products or actions. The Welland Canals Centre shall not be held responsible for any loss or damage as a result of vandalism, theft or an act of God. Exhibitors agree to indemnify and save harmless Welland Canals Centre from any claims arising from their participation while using Welland Canals Centre's property. Management will not be liable for any damages, whether direct, indirect, general, special, consequential or otherwise to the Exhibitor, its agents, employees or visitors to its exhibits.
8. **Non-Delivery:** Management will not be liable for failure to deliver the space in the event of the building becoming unavailable through fire, act of God, strikes, the authority of the law, or any other cause beyond its control.
9. **Regulations:** Management has the right to make such changes, amendments and additions to these Terms and Conditions, as it deems necessary to the proper conduct of the Show.
