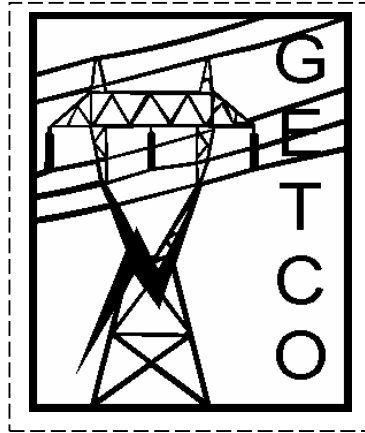

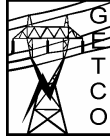

***Technical Terms:**

- (1) Documentary proof of owning the vehicle having minimum 100 MT carrying capacity , R.C. book of RTO indicating the registered laden weight and pay load in respect of articulated Semi-mechanical trailer and notification copy of Surface & Transport in respect of Hydraulic Axle Trailer.
- (2) The photographs of low bed trailer proposed for purpose along with photographic evidence of transporting similar and oversize packages.
- (3) Experience Certificate of such type of works executed for minimum work order value of Rs.10 Lacs in GETCO having completed the works in single work order only.
- (4) Based on the Hon'ble Supreme Court judgment date.9/11/2005 directing all the State Government to ensure that the motor vehicles carry only the specified weight and if any excess weight is carried, the same should be off loaded.
 - In view of above directions, it is mandatory that the transporter should place trailer having appropriate registered laden weight as per the weight of the transformer main tank.
 - In any case articulated semi-mechanical trailer can be placed for transformer main tank where the gross vehicle weight does not exceed 150 Mt gross = weight of transformer main tank plus weight of articulated semi-mechanical trailer.
 - And where the gross vehicle weight 150 MT , only hydraulic axle modular platform trailer should be placed depending upon the weight of the transformer.
- (5) Documentary proof of owning hydraulic jacks, chain pulley blocks and sleepers.

SPECIAL TERMS & CONDITION FOR TRANSPORTATION LOADING & UNLOADING WITH DRAGGING OF DIFFERENT TYPE OF EHV CLASS POWER TRANSFORMER FOR THE PERIOD OF ONE YEAR.

1. The successful tenderer will have to make arrangement for loading the same on his own transport trolley of the required capacity. Along with the tender, he should submit the capacity and dimension of the tractor/trailer to be utilized for shifting the main tank consignment weighing about 90 to 100 MT.
2. The Successful tenderer will have to transport the transformer in his own transport trolley and will have to make his own arrangement to procure the necessary tools and trackles of any sort will be provided by the GETCO.
3. The contractor will be fully responsible for any shortages, breakages or damages to the transformer that may occur during the time of loading transportation unloading and dragging it is to be properly unloaded and handed over to the GETCO after completion of the job in satisfactory manner. The cost of any such shortages, breakages of damages if any will be recovered from the contractor, the assessment of which will be dine by our field officer at his sole discretion and his decision will be binding on the contractor. For any claim lodged by tender with insurance company towards damages to the job and claim passed by insurance will be reimbursed to the tenderer.
4. The contractor shall be responsible for any accident or damage to private public properties etc. during the time of loading unloading and transporting etc.
5. The GETCO will not responsible for any accident injury etc. to the contractors laboures or equipments during the execution of the job, which will be the sole responsibility of the contractor.
6. The successful tender will have to indemnify the GETCO against any possible claim of compensation for damage to his equipment or for injury to him or fatal / non fatal accident to human life, his staff or any other person during execution of the above job. If for any reasons the GETCO is called upon to pay such claim or compensation the same will be recovered from him of his bills.
7. The contractor or his authority agent should always be present at the time of loading unloading of transformer.
8. If at any stage the contractor fails to carry out the job, the work will be get done at his risk and cost without giving any notice or formalities required as per rules as the time is the essence of the contractor. Contractor will not be entertained for any dispute in this regard.
9. The contractor will have to make his own arrangement for PWD road permit, R.T.O. permission or any other permission from local or other authority or movement of tractor / Trailer in Gujarat state Govt. which may be required for packages stated above. If necessary the GETCO will extend all possible assistance to the contractor by way of recommendation , letters for issue of such permission to the various authorities if required exgracia but without any commitment and without prejudice to the other terms and conditions of this tender. The transportation inside railway premises, P.W.D. or local authorities of Roads will have to be done in such a manner that prescribe and in such periods(nights or day) they permit.
10. All taxes will have to be paid by the contractor, out sub station is situated out side Municipal limits and necessary exemption certificate for Octroi duty is acceptable by the municipal Authority will be issued . Otherwise Octroi duty will have to be paid by GETCO.
11. Wherever necessary reinforcement to the small bridge or culvert coming the way while transporting will have to be arranged by the contractor at his cost.
12. The tenderer should quote his rate correctly taking in to consideration all points mentioned in the Schedule- 'B' attached. The rates should be quoted without any condition and should be quoted in ink both in words and figures in legible hand.

16. Monthly statement for execution of work should have to be submitted to SE(TR), GETCO, TR.C.O. Amreli showing details work carried out for monitoring of order quantities / Value.
17. Transformer oil and accessories should be transported separately for which weigh bridge slip or weight of oil on name plate details will be considered for payment.
18. No any separate payment will be made for dragging the transformer in any case.
19. Transit Insurance for newly or old transformer if necessary , it will be taken by the GETCO as per latest Circle of GETCO.

SPECIFICATION FOR THE WORKS OF TRANSFORMER FROM 220KV S/S, NAKHATRANA (NEAR BHUJ)TO 400KV S/S,AMRELI .

1. Scope of work

- 1.1. The transformer lying at (any GETCO Substation) any place within the State of Gujarat to be shafted as per the directive of Engineer in Charge of the work .Contractor will have to arrange for making approach, if required. at his own cost. Without damaging any of the GETCO, or other property during the entire job at his own cost. The cost of any damage shall be recovered from the contractor's bill.
- 1.2. Extra charges for dragging shall not be paid to the contractor . All accessories like radiator, conservator tank, Explosion vent pipes, H.T. Bushing & other accessories will have to be transported by the contractor in his own vehicle / big ben/ truck and trailer of adequate capacity at this own cost.
- 1.3. Transformer main tank along with its accessories is to be transported up to given destination safely at contractor's risk and cost. All necessary labours ,tools, tackles etc. will have to be arranged by the contractor for loading & unloading & dragging the said transformer / main tank should be un loaded at concerned site on plinth in regular posting including fixing of wheels.

2. GENERAL TERMS AND CONDITION :-

- 2.1. Prior intimation in writing for starting the job will be given by the GETCO.
- 2.2. The particulars of heaviest package i.e. main tank to be transported and all its accessories with the dimension details will be given for above job. i.e. shipping weight , length, height and width.
- 2.3. Contractor will have to make his own arrangement for all tools, tackles, wire rops etc. for dragging loading – un loading.
- 2.4. No tools tackles , man power will be provided by the GETCO.
- 2.5. Contractor will be fully & solely responsible for any shortage, damage, leakages, to the transformer, main tank or any of its accessories that may occur during dragging, loading ,transporting and un loading up to the destination and wheels are fixed i.e. during execution and completion of whole entire job.
- 2.6. Works completion certificate of that effect must be taken from Engineer- in change after completion of whole job and should be attached with the bill to be produced in triplicate to the concerned Trans. Division with a copy to circle office Amreli.
- 2.7. The cost of damages, shortages, breakages of which will be done by the contractor's bill. The assessment of which will be done by field Engineer at his sole discretion and his decision shall be binding to the contractor and shall be considered as final and unchangeable.
- 2.8. The GETCO will be not be responsible for any accident, injury etc. to the contractors. Labour or any disability to those persons during executing of whole job. Any damage to the contractor equipment during execution of whole job. Any damage to the Contractor's equipment during execution of work will be liability of the contractor.
- 2.9. Contractor will have to give indemnity Bond to GETCO against any possible claim of compensation for damage to contractor's equipments or staff or any other third party during the execution of whole job. If for any reason, GETCO is called upon to pay any such claim or compensation , the same will be recovered from the contractor bill anywhere pending with GETCO even at any latter date.

- 2.10. For stating above work the transportation contractor will be informed in advance, so as to keep ready skilled laboures, trailor, tools, tackles, and other required materials . the GETCO will not be in any case responsible for any delay in arranging loading / un- bloading and transportation up to destination. No extra charge for any short any delay will be paid to the contractor. All extra charges incurred will have to be born by the contractor in any case GETCO is to execute the job it will be solely done at contractors risk and cost and all pending bills / extra /additional expenditure as per GETCO's rules will be levied upon and all pending bills/ deposits etc. will be forfeited. ,reserving the right of the GETCO to recover balanced dues by ways as deemed fit.
- 2.11. No crane nor any facilities will be provided by the GETCO at any place contractor will arrange every thing required for completion on the job.
- 2.12. Contractor or his authorised representative should constantly remain present while execution of whole job to avoid complication.
- 2.13. Contractor must engage sufficient skilled labours and competent experienced supervisory staff in executing the job, so as to avoid unnecessary delay and to complete the work timely.
- 2.14. Contractor will have complete entire job as per directives if he falls to do so entire work will be carried out at contractors risk and cost. Due intimation for starting the job will be given by the GETCO.
- 2.15. Contractor will have to engage, labours for keeping away telegraph wires, live electric wire away from the transformer, tree cutting if required and for removing other obstacles during transit. Necessary guidance permission form any Government authority, Railway Authority., R.T.O / P.W.D. Deptt. Etc. will be arranged by contractor well in time at his own cost.
- 2.16. Contractor should produce the certificate of having carried out such works and should have experience of execution of such job. i.e. work of handling of heavy equipment of more than 20 tons or so.
- 2.17. Wherever necessary , arrangement for smooth road at diversion will have to be arranged by the contractor at his own cost.
- 2.18. In case of trailer truck to be provided the contractor will have to arrange for all permits, such as road permission from RTO/PWD or other authorities of Gujarat State for movement of his trailer truck etc. Contractor has to comply all updated R.T.O/ safety rules, Railway laws , Laboure Laws, I.T. act. , I.E. rules, Insurance Rules & R&B dept laws etc. and has to bear all such clearing permission / Insurance and all other incidental charges required there of. The contractor shall have to furnish attested Xerox copies of the document of RTO etc. for Truck/ Trailer along with original document for verification.
- 2.19. This order shall remain in force up to one year and can be extended on mutual understanding.
- 2.20. Concerned Ex. Engineer of any division of Amreli Circle shall intimate the contractor telephonically to commence the work and on receipt of the message you have to commence the work within 48 hrs. Based on actual quantum of work ,the bill shall be paid within 30 days by concerned Division, if feasible or otherwise.
- 2.21. This tender is meant for annual work order and Sub order will be placed by concerned Ex. Engineer of TR. DN. GETCO, shall be at liberty either to transport main tank with or without oil and complete accessories as and when needed.
- 2.22. Transporter has to provide escort vehicle equipped with adequate skill man power, tools- tackles etc. required there of to clear any obstacles.

- 2.23. Any other items activities which is not conveniently included in the in the Schedule- “B” but required for transportation / Shifting work should be carried out by the contractor without any extra charges.

- 2.27. If the contractor will fail to arrange for sufficient capacity of the Trailer in time and due to this any revenue loss occurs, the same will have to be born by the contractor.
- 2.28. You will have to pay 5 % Security Deposit of the Tender value, in cash in C.O.Amreli.
- 2.29. You will have to obtain all requires permit for R.T.O. Registration of Trailer, P.W.D. permission if any, and any other formalities required for the commencement of the JOB.
- 2.30. The Contract should be awarded to contractor who has completed such job of similar nature and magnitude satisfactorily right in time. However, Issuance of tender document will not be qualify the tenderers to bid the offer. Availability of 35 MT capacity trailer is an essential condition.
- 2.31. The tender offer without such certificate / Document will be outrightly rejected without assigning any reason there of. The decision of the Superintending Engineer Tr. Amreli will be final & unchallengeable during execution of job.

TERMS AND CONDITIONS FOR TRANSPORTATION OF POWER TRANSFORMERS ANY WHERE IN GUJARAT ON AS AND WHEN REQUIRED BASIS.

1. No tender will be considered if received without earnest money deposit at the time of opening of the tender. The full value 'Earnest Money Deposit' shall be forfeited by the GETCO if the contractor fails to deposit the full amount of specified security deposit.
2. **PAYMENT OF SECURITY DEPOSIT :**
The contractor will have to pay 10 % security deposit of the order value, if he is not registered with the GETCO within week time in cash or by DD. Drawn on local bank at Amreli in the name of "Gujarat Energy Transmission Corporation Limited".
3. **Payment :**
Payment will be made after observing GETCO's general procedure by concerned Division after satisfactory completion of work & as per GETCO's rules.
4. Rates quoted would be inclusive of all taxes, duties etc. as applicable. Nothing will be payable extra.
5. The rates quoted in the tender will remain valid for a period of six months from the date of opening of tender.
6. The work is to be executed in all respect as per the instructions of Engineer-in-charge by arranging all required materials tools, tackles equipment including labours, transportation etc. GETCO will not pay anything extra on this account.
7. The GETCO reserves the rights of retrenching and dismissing any person employed for the work if there is complaint against his misbehavior, misconduct or disloyalty towards job.
