#### SCHEDULE 'A'

#### SECTION – I

#### **TERMS AND CONDITIONS:**

1. SCOPE OF WORK: The scope of work shall be mentioned in Section-III of the tender specification. The details of work mentioned there in are only guide lines. The actual work done will be specified by the Engineer-in-charge of the work. After opening the equipment, the work shall have to be done to his entire satisfaction. All such jobs which are connected works, but are not specified in the scope of work are deemed to be included in the scope of work.

2. SCOPE OF SUPPLY: The details of scope of supply by the GSECL and by the contractor have been given in section. II of the tender specification. Anything not mentioned there in shall be treated in the scope of the contractor in quoted rate.

3. CHANGE IN SCOPE OF WORK: Company reserve the right for changing scope of work to any extent, considered beneficial to Company at any time, even after issue of detailed work order, necessary changes in the part shall be made by Engineer-in charge accordingly.

4. OVERRUN CHARGES: Over run charges are not payable in any case.

5. If any additional assembly or sub-assemblies is to be dismantled to carry out work, same has to be arranged by contractor. After completion of work dismantled assemblies are to be reassembled. Extra payment shall not be made for such work.

6. The period of completion of overhauling of unit shall be 12 days excluding the mobilization of seven days for each unit. Unit under capital OH time period 30 days.

7. EXPERIENCE: The bidders should submit experience certificate for the similar job carried out during the past.

8. Contractor has to fulfill all the statutory requirements as per existing / modified act in consultation with IRO / LWO with all legal aspects without any extra commercial implications in their quoted rates.

9. In case of planning made for overhauling of more than one unit in parallel period. Contractor should keep sufficient manpower to complete the work in stipulated time for synchronizing the unit back.

10. During force outage of unit, party should have to arrange sufficient manpower within 24 Hours to carry out any part of work related to this tender.

#### SECTION – II

(A) SCOPE OF SUPPLY BY COMPANY:

The following items shall be supplied by GSECL free of cost.

1. Steel materials like MS plate, flat, scrap conveyer belt etc will be issued free of cost by GSECL from Main store.

2. Power for lighting and welding sets, water and air at convenient points provided by GSECL free of cost. Necessary extension from release power supply and air and water points are to be done by contractor without any extra cost.

3. All spares parts, insulation etc. required to complete the work. However the contractor shall submit the requisition 4 days in advance.

4. Gaskets and packing ropes.

5. Work shop facility will be provided by GSECL, but party has to inform in advance and to send the material in workshop with proper marking in advance such that work should not suffer.

(B) SCOPE OF SUPPLY BY THE CONTRACTOR.

The following items will be arranged by the contractor and no additional payment over and above the quoted rate will be made to him on account of these items. 1. All consumables like cotton waste, cloth, kerosene, rustolene, wire brushes, O2 & DA Cylinder, argon gas, MS Welding electrode etc.

Erection of scaffolding including scaffolding, piping, clamp, wooden planks etc.
 All normal T&P like welding sets, grinders, safety belts and PPE hand tools, motor operated winch pulleys, pulley and lift machines, cutting and brazing torches, safety appliances, tig welding equipments with consumables etc.

4. Belt jointing solution is to be made of reputed rubber co. like MRF and approved by GSECL

5. All other items which are not listed but required to carry out this work will have to do without any extra cost.

#### SECTION – III

#### SCOPE OF WORK:

(A) Fabrication & Erection of Expansion bellows.

The scopes of work consist of fabrication of various size of expansion as per the existing bellow or part of the bellow as per the instruction of EIC from 2.0 / 3.0 mm plate and erection of new bellow after removing old eroded bellow. If new bellow is available at the site, party has to erect the same after minor setting of dimension. The work consists of mainly as:

1. Fabrication of expansion bellow pieces from 2.0/3.0 mm MS plate which will be issued by M/s GSECL free of cost.

2. Application of two coat of red oxide on the fabricated bellows.

3. The work should be allotted in complete bellow or part of the same as per availability and site situation.

4. Cutting and removal of old damaged bellow pieces from various locations and elevation of flue gas & hot air ducts of Boiler unit-1, 2 & 3 and same is to be credited to main store.

5. Erection of fabricated new bellow pieces to be provided to its locations and welding of the same to be carried out on position with perfect alignment with duct.

6. Preparation of scaffolding at required locations and removal of the same after completion of work.

7. Successful kerosene test of weld joints and rectification/ rewelding if required will be done by the party.

8. Transportation of raw material from store / site and scrape to be credit at main store are to be arrange by party.

9. The measurement will be given as per the actual bellow erected only.

10. Price quoted by the party will remain firm.

(B) Replacement of damaged rubber belt:

The scopes of work consist of replacement of damaged / punctured rubber belt of fabric compensator at various expansions joint to prevent air ingress is to be carried out by the party as per the instruction of engineer in charge. The work consists of mainly as:

1. Removing the piece of damaged belt from damaged / punctured fabric compensator.

2. Removing old insulation and cleaning the bellow.

- 3. Cutting of conveyer belt of required dimension.
- 4. Splitting of conveyer belt of required thickness.
- 5. Cutting of slot on conveyer belt.
- 6. Filling the insulation material on bellow before fitting the belt.
- 7. Inserting the belt and joining the belt by adhesive material.
- 8. Fitting the belt on frame by fastener.

After completion of the work party have to check the proper fitting of belt and ensure that there is no any leakages.

#### ANNEXURE 'A'

- (1) All necessary tools and tackles such as chain pulley blocks, welding generator sets, hook-chooks, wire slings, spanner, gas cutting sets, welding cables, grinding machines etc. shall be arranged by the party at his own cost.
- (2) At any time, if it is found that work force of the party is inadequate and progress of the work is not to the satisfaction of GSECL, other agencies / departmental personnel will be put to carry out work. Amount so incurred will be recovered from the party's bill. In this case the decision of the Engineer in charge shall be final and binding on the contractor.
- (3) The time is the essence of the contract and the party shall have to ensure that work is completed within stipulated period, mentioned in the contract, keeping personnel round the clock otherwise penalty will be charged at the rate 1/2 % per week subject to maximum of 10% of the contract value as per the Corporation's rules.
- (4) Party shall make indemnity to GSECL against any injury and / or damages that may be caused to his man or material. Moreover, the party shall be fully responsible for any damages caused to the corporation's properties done by his men / materials, while executing the work. The Corporation will be entitled to recover the damages from the party's bill.
- (5) Party should take all necessary precautions during execution of the work and all labours of the party should utilize all types of safety appliances during work in plant area to prevent the accident as per factory acts / rules.
- (6) The electrical connection and electricity to the party's welding generator sets and other equipments such as grinding sets etc. shall be given by the Corporation on non chargeable basis required at one point only near to working place, as directed by EIC.
- (7) This is a rate contract valid for a period of 12 months. The Corporation reserves the right to extend this annual contract for further period of 6 months if deemed suitable, considering the balance quantities yet to complete and it will be binding to the party. The rates and other terms and conditions will remain same as per original order for the extended period.
- (8) The tender shall be submitted along with EMD without which no tender will be considered.

- (9) The conditional tender will not be accepted. Withdrawal of conditions unilaterally after opening of tenders will not be permitted.
- (10) The labour laws in existence and which may modify from time to time shall be binding to the party. The party will have to execute an indemnify bond on non judicial stamp paper of appropriate value. The cost of the same shall be borne by the party.
- (11) The Corporation reserves the right to split each item in to more than one agency and place the order accordingly. All parties should therefore, carefully evaluate and fill up the rate item wise, keeping themselves ready to execute order for any one or more, allotted to them by the Corporation.
- (12) The Corporation reserves the right to terminate the contract at any time during its tendency by giving seven days notice to the party without entertaining of claim/compensation.
- (13) The contractor shall have to arrange to remove the day to day scrap materials from site and deposit to GSECL main stores / BMD.I site stores as per the instructions of EIC. The site must have to be kept cleared before starting /commissioning of equipments / unit otherwise 5% of the contract / order value or the amount of expenditures actually incurred will be recovered from the party's bill without assigning any reason in the event of non removal of scraps.
- (14) Rates are quoted to be firmed. Hence no price and labour escalation will be applicable.
- (15) All consumables, like cotton waste, kerosene. Diesel/ rustolene, welding electrodes, oxy-acetylene/ gas shall be arranged by the party at his own cost.
- (16) The spares, pertaining to equipment components, fasteners, packing ropes, MS plates, gasketing etc. will be issued free of cost from GSECL store as per requirement of work.

#### GENERAL CONDITION AT CONTRACT

#### 1. WAGES TO BE PAID & TIME OF PAYMENT ETC. BY THE CONTRACTOR :

- (a) The contractors shall pay minimum rates fixed under the minimum wages act. The wages of every contract labour employed by him under this contract shall be paid by him before the expiry of 7th day of the last day of the month in respect of which the wages are payable (i.e. wages of a month have to the paid by him in the first week of the next month). The payment shall be disbursed in the presence of management representative during the working hours in factory premises and the contractor shall get the entries certified in the register of wages by the representatives of the company. Any default will result in cancellation of contract forthwith or also the contract shall be punishable to the extent of Rs. 100/- fine per each day.
- (b) The contractor shall be give his telephone number and address to the Board so that in case of labour trouble etc. the contractor can be contacted. The contractor shall arrange to have his office outside the factory premises and the contractor shall keep himself present through out the work hours.
- 2. LABOURS LAWS :
- (a) Person below the age of 18 years shall not be employed for this work.
- (b) No female worker shall be employed in the night shift between 07-00 PM to 06-00 AM.
- (c) Contractor shall maintain a valid labour license under the contractor labour (Regulation and Abolition) Act for the employing necessary manpower to be required by him in the absence of such license the contractor shall be liable to terminated without assign any reasons thereof.
- (d) The contractor shall on his expense comply with all labour laws and keep the corporation indemnified in respect thereof. Some of the major liabilities under various labour and industrial lows which the contractor shall comply with are as under
- (1) Payment of contributing of way of Employer's contribution towards provident fund, family pension scheme, deposit linked insurance scheme, administrative charges etc. at the rates made applicable from time to time by Government of Gujarat/ Government of India or other Statutory Authorities.

- (2) Payment of deposit in respect of each contract labour at rate of Rs. 30/- with the office of Commissioner of Labour as per contract labour (Regulation and Abolition) Act.
- (3) License as prescribed under the contract labour (Regulation and Abolition) Act and rules framed there under depending upon the number of workman employed by the contractor License is compulsory it ten or more labours engaged due date
- (4) Identity cards as prescribed under the factories act. With photo affixed there to the same for identification.
- (5) Payment of retrenchment compensation, notice pay and other liabilities as per Industrial Disputes Act. Any payment to the contractor's employees arising out of any claim or disputes under the industrial Disputes Act. 1947 or any other labour laws.
- (6) Payment of compensation in case of accidental injury.
- (7) Provision of creche if female labour employed is more than 30 numbers.
- (8) Maternity leave as per the provision of the Maternity Benefit Act.
- 3. PROVIDENT FUND AND FAMILY PENSION SCHEME :

The contractor shall submit along with his bill (month wise) a statement regarding deductions against employees provident fund and family pension scheme in respect of each concerned employees. Provident fund and family pension scheme at the rate of 8.33% (or at the rate made applicable by the Government from time to time) of Wages. The contractor's contribution and his workers contribution towards provident fund and family pension scheme shall be deposited by the contractor with Regional Provident Fund commissioner, Ahmedabad.

4. DIPOSIT LINKED INSURANCE SCHEME :

The contractor shall have to deposit 1/2 % of the wages in respect of employees who is a member of the provident fund as the contribution to the Deposit linked insurance scheme with Regional Provident Fund Commissioner, Ahmedabad.

5. ADMINISTRATIVE CHARGES :

Administrative charges for maintaining Provident fund account shall be deposited by the contractor with Regional Provident Fund Commissioner, Ahmedabad at the rates applicable.

6. PAID LEAVE FACILITY :

Paid leave facility at the rate of one day for every 29 days worked by the

contractor labour shall be provided by the contractor to his workers. He shall maintain leave records/leave cards for individual labourers which shall be duly verified and approved certified by the authorized officer of the Board.

7. WORKMEN'S COMPENSATION FUND AND EMPLOYERS LIABILITY INSURANCE :

The contractor shall cover all his employees under workmen's compensation fund and under the liability Insurance.

- 8. The contractor shall employ adequate number of experienced staff at site for daily supervision and for maintenance of various registers and records required under the law and contract no payment for supervision shall be admissible.
- 9. CONTRACTOR TO INDEMINITY THE BOND:
