## XII. PUBLIC COMMENTS

Margaret Long, an Orange Beach resident, expressed concern about the diesel fuel spill in Cotton Bayou on Thursday. The fact that it took 30 hours after she reported it to the Orange Beach Fire Department and the U. S. Coast Guard before the clean-up was complete was her major concern. She stated that Romar Harbor Marina knew about the spill but failed to report it to the authorities. The Coast Guard could not determine the source of the spill, but would be going to the marinas in the area and informing them of their responsibilities if this happens again. Mayor Blalock stated that the city's Marine Police can check the marinas on a daily basis.

Pat Chambers, resident of Bayou Place, appeared before the council regarding the number of dead trees on lots in her neighborhood. She stated that some property owners are responsible and take care of the problem immediately, but there are some that totally ignore the problem. She wanted to bring the matter to the council's attention so it can be addressed. She stated that the dead trees are a public nuisance because of the area where we live and the potential we have for bad weather conditions. City Administrator Jeff Moon explained that a dead tree does not necessarily constitute a public nuisance. It has be a threat to public safety or property before it can be declared a nuisance. The city cannot go on private property to cut a tree just because it is dead; it has to be considered an actual public nuisance.

Jeff Nevels, a private citizen, addressed the council on the subject of the Orange Beach Swim Team. He presented a petition signed by approximately 40 people who supported the continuation of a quality year round swim program in Orange Beach. He stated since the Swim Team Coach retired, all the young swimmers have gone to Gulf Shores to swim on their team. He asked the Council to consider hiring another coach and remember the swim team in budget considerations. Mayor Blalock explained that the city has facilities and supports all of the sports programs for children; however, all of the coaches are volunteers. He stated that the city searched for a volunteer coach for the swim team, but no one expressed any interest or had the qualifications.

2. <u>Executive Session to discuss the good name and character of individuals.</u> Motion made (Silvers/Alexander) to go into executive session to discuss the good name and character of individuals. The City Attorney advised the Council that a declaration was required by the Act for an Executive Session if it was in regard to legal advice and counsel.

City Attorney Wanda Cochran appeared before the Council and stated for the record that she was duly qualified and had the personal knowledge to provide the requisite declaration for the stated purpose of the Executive Session authorized by the Act and informed the Council that an Executive Session was necessary for the purpose so stated and that discussions would imperil and/or have a detrimental effect upon the city if disclosed outside of an Executive Session or would otherwise be contrary to law; and,

The Mayor directed the City Clerk to enter said motion, purpose and declaration into the minutes of the meeting and called for a vote on said motion; and,

Said vote in regard to the motion for Executive Session was taken with the "ayes" and "nays" being recorded into the minutes as follows: Carroll, aye; Silvers, aye; Alexander, aye; Holiday, aye; P. Blalock, aye. <u>Passed (5-0).</u>

The Mayor declared that a majority of the votes being in favor of the motion, that such motion had therefore passed and the Council would forthwith recess into Executive Session for the purpose as stated in said motion and no other purpose, in accordance with the Act and reconvene in approximately 45 - 60 minutes. Time: 6:10 p.m.

Mayor Blalock reconvened the meeting at 6:40 p.m.
