PRESIDENT'S CORNER

Budget

It's hard to believe that fall is just around the corner. This time each year we start the process of developing a budget for the next year. Our manager, in cooperation with the Finance Committee, and the Board, will be busy organizing and reviewing this proposed budget. Additionally, each of our Committee Chairs has been asked to provide their input of the needs of their respective committee. Then, on October 23rd there will be a Special Board of Trustees meeting to discuss and take action on a proposed budget. After the Board approves the budget it will be mailed to our membership on November 4th for their consideration. The final part of this puzzle happens on December 4th when a Special General Membership Meeting will be held to announce to results of the budget vote.

New Board Member

At the August meeting the Board approved the appointment of Thad Bickling to fill the vacancy on the Board created by the resignation of Marty Bluewater. Marty has accepted a position of undefined length as the Acting Director of the United Indians of all Tribes Foundation. Thad will serve the remaining two years of Marty's term of office. Thad resides at 140 East Rhododendron with his wife Rachel. I join the Board in offering thanks to Marty for his service to the Board and to wish Thad well in his future involvement with the Board. Member Support Requested

Members are asked to keep their eyes open for needed repairs to the roads in our community as well as home/

lot maintenance issues they may see in their respective neighborhood. When you walk in your local area take notice of the condition of the road and right of way and let us know if you think repairs are needed. You can phone or e-mail our manager or Road Committee Chair with your observations. Your comments are also welcome regarding all of our common property. Thanks for your help on this matter.

Clubhouse Building Repairs

As many of you have probably heard we have some serious problems with moisture damage to the walls of the Clubhouse Building. The majority of these problems appear to be in the area of the building that surrounds the swimming pool and exercise room. We are currently in the process of obtaining bids to repair this building and it is likely to be an expensive repair. Basically all of the exterior and interior walls need to be replaced and selected portions of the framing for the building may need to be repaired and/or replaced. A portion of the ceiling in the pool room itself will also need to be replaced allowing for proper venting of the building. This building is over 30 years old and we should expect to encounter such problems with facilities of this age. The Board of Trustees at their Special Board meeting on August 25th authorized the manager to negotiate final details with a specific contractor to make these repairs. By the September Board meeting we hope to have the final estimate of what these repairs will cost.

We still have \$70,000 in our Capital Budget for 2008 for repairs to the pool itself. The Board, with assistance from the Swimming Pool

Committee and the Finance Committee, are currently in the process of developing a proposal for the repairs and maintenance of the pool. Some of the items in this a proposal may not qualify for use of reserve and thus will need to be paid for in another manner including the possibility a membership assessment. Of course such an assessment would have to be approved by the general membership. More information will be forthcoming as we proceed with the development of this proposal.

SHORELINES AND BLUFFS

I learned quite a bit from a summer Shore Stewards newsletter about our beaches and bluffs. According to Cammy Mills at WSU, "Our shorelines are basically slow moving rivers of sand and rock."

Our bluffs were deposited during glacial and interglacial periods and when you walk the beach you can look up and see the different layers. Then, as the bluffs erode, they actually provide the material for our beaches. Erosion material is spread by waves and wind action, sometimes for miles!

When this erosion material moves along the beaches in something called a littoral drift, as it reaches headlands or human structures, it can pile up on one side and erode away the beach on the other side. Bulkheads do not actually prevent beaches from eroding; it does stop the natural zigzag activity of the littoral drift, sometimes changing the structure of a beach downstream from it to only cobble or hard clay, for example.

One of the things volunteers have started doing at Cape George is something called soft shore armoring. You can anchor large logs parallel to the shoreline or plant salt-tolerant vegetation which helps slow erosion near areas like our pool and clubhouse while allowing for sediment drift to reach and restore beaches further down the way.

Are You Prepared?

At the Ice Cream social last Sunday afternoon, I joined other Cape George residents pressed against the windows watching the lightning over the Olympics and Diamond Point. I was sobered Monday when I read about the wildfires the lightning strikes started in the mountains. Those of us who live on the open hillsides may not need to worry about wildfires; but our neighbors up in the Highlands are much closer to the forest and fire threats. Now would be a good time to clear the brush around your perimeter and to make sure you have your 'Grab and Go' kit in the event you need to evacuate.

Bats

Jefferson County Health Department reminds all of us that there is a significant incidence of rabies in the local bat population. If you find a bat on the ground or acting strangely or one gets into your house avoid touching the bat and keep any pets from playing with it. Call the Health Department at 385-9444 for suggestions about what to do with the bat. That said, most bats are healthy and non-aggressive. They just want to be left alone to eat flying insects.

Manager's Report:

We are leasing a new copier for the office, the old one died after about 8 years of service. Thanks to Brian Ritchie the old tractor has been sold for \$1,000.00

A Cape George member who also is the Grand Master for the local Mason Lodge is sponsoring a Lunch-In for about 70 members of the Mason's Motorcycle Club at the picnic area on the 24th of August. The mason's are doing a scholarship fund raising ride for local schools and will have a quick lunch here and continue on their ride.

Well # 4 is operational again after a faulty valve that was allowing pumped water to flow back into the well was replaced. Well # 4 was also tested for arsenic, the sample taken before going through our filtration system and the results read .008 parts per billion. The acceptable count is .010 parts per billion. A sample has also been submitted for Well #6. We now have two operational wells.

We have received a report from Robinson & Noble who performed a video inspection of Well # 5. It showed a crack about 10 feet down that was allowing surface water to enter the well. The most interesting thing, the video showed that about 278 feet down a baler is obstructing the well. The baler was possibly lost by Gresham Well Drilling. Robinson & Noble feel that the well can be returned to normal service if the baler can be removed without damaging the well screen. I am recommending to the Board that Cape George hire Robinson & Noble to represent us in our claim with Gresham, in our effort to make Well #5 operational again or if need be to assist in the drilling of a new well.

We have received three proposals for the pool building project and there will be a Special Board Meeting on the 25th of August to make some decisions.

USE CLOTH INSTEAD OF PLASTIC BAGS WHEN SHOPPING

As part of Cape George's commitment to the environment, we should be aware that we use 500 billion to a trillion plastic bags shopping every year. These bags are made from petroleum, which raises the cost of fuel for us all. Did you know that we recycle less than 1% of all plastic bags, and it costs about \$4000 per ton to recycle those plastic bags? In addition this recycled material can only be sold for about \$32 a ton. This means there is no profit in recycling plastic bags.

Many sea animals are killed every year from ingesting plastic bags which they think are food. These animals die horrible deaths that could easily be avoided if we eliminated the use of plastic bags. Recently they dissected an orca whale that had died. They found his intestines were blocked by plastic bags and that had killed him.

America needs to find another method to cut down on the use of plastic bags and thus save fuel costs. If we, as Cape George members, used cloth bags instead of plastic bags, we could prevent hundreds of thousands of plastic bags from contaminating our landfill and from polluting the environment. Also, without the competition for oil that plastic bags causes, we could perhaps lower the cost of oil a little.

Most of us have cloth bags that we have received from various organizations, etc. You can also purchase them at grocery stores. Why not put them to use? Every time we walk into the supermarket or a store, take them with you and use your own cloth bags instead of using the plastic bags. Not only will each one of us help to save our landfills and decrease the price of oil, but we will also save money, as some stores and markets give discounts if you use your own bags. Safeway, for example, pays 3 cents a bag for each bag you use. That works out to a saving of about \$15 to \$30 a year for each person.

Also, do you know that Safeway has a recycling bin for your used plastic bags? It is in right entrance as you face the building. You can recycle any plastic bags that you have there.

Another way you can help our community is to donate your plastic bags to the doggie boxes placed around the Cape George community in the common areas. This will help to keep our community clean. If people will use plastic bags to remove their doggies waste, it would benefit us all. You can take your plastic bags to the CG office for this purpose or just fold them and place them in any doggie box yourself and save the office staff's time.

If we truly want to nurture the Earth, lower the price of gas, and save money on landfill space, then let's start by using only cloth bags. It is a painless way to help the country. If you do occasionally get plastic bags, don't just throw them in the trash. Reuse them, recycle them, or donate them to be recycled.
