## **General Information**

### **Siding Subcontractor Services Agreement**

This Siding Subcontractor Services Agreement is between a contractor and a siding contractor who will provide subcontracting services. This agreement sets out the specific details regarding the subcontract including the services the subcontractor will provide, how long the project will last and how much the subcontractor will be paid.

It is imperative that this type of subcontract be set out in writing rather than by oral agreement. A written Siding Subcontractor Services Agreement will be valuable in the event of disagreements or miscommunication regarding the scope of subcontractor's services.

## **Instructions and Checklist**

### **Siding Subcontractor Services Agreement**

- The parties should read the application carefully.
- Insert all requested information in the spaces provided on the form.
- The parties should read the "Terms and Conditions" provisions carefully. If there are disagreements, they will likely focus on one of these provisions.
- This form contains the basic terms and language that should be included in similar agreements.
- This agreement must be signed by the contractor and the siding subcontractor.
- The parties should retain either an original or copy of the signed agreement.
- All legal documents should be kept in a safe location such as a fireproof safe or safe deposit box.

**TERMS AND CONDITIONS:**

1. Both contractor and subcontractor are authorized carriers of logs, poles, and piling or cordwood, sawdust, hog fuel, wood chips, or bark dust .The transportation performed by the subcontractor shall be with a vehicle registered for use under a valid and active authority of the subcontractor and shall be within the terms of operating authority of both contractor and subcontractor.
2. That contractor and subcontractor will maintain records of all transportation performed under this agreement.
3. According to this agreement, the contractor hereby agrees to obtain the services of the subcontractor for the purpose of installation of siding materials for the property mentioned above.
4. The subcontractor shall have to install and check for any anomalies in the siding of the building walls, besides supplying all the materials, tools, machinery and equipment required for these tasks besides supplying labor to complete these jobs.
5. The Subcontractor needs to follow all the rules and regulations of the housing complex and maintain safety while doing the siding work.

**6.** The subcontractor is responsible for maintaining the safety of his employees or should any accident occur and also maintaining the quality of the materials used for the siding work.

**7.** The subcontractor agrees to finish the work within \_\_\_\_ months of signing this agreement.
