MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class.

Board of Directors Meeting
August 5, 2005

Minutes

Meeting began at 7:04 PM

Flag Salute – Rick Baldwin led the flag salute.

Attendance – All directors were present except the following: Steve Andrews, Jim Dotterer, Bob Greenman, Jim Greeves, Ron Morton, Rich Montecucco, Jerry Rheault, Greg Squires, Noel Vaughn, Bill Wright and Jeff Young.

Treasurer's Report – Waive Assessment: John Cadoo reported a request received from Jordyn Mitchell, an NRA Life Member, that we waive his assessment for this year. Jordyn's wife died last year in childbirth. He had made a request to waive his assessment then but apparently CCRP did not respond at that time. As a single parent, he didn't expect that he would be able to come to the range at all. After some discussion, and in light of the fact that Jordyn made this request a year earlier, the directors agreed to refund his current assessment payment and waive his assessment for next year. Late in the meeting, John was directed to write a letter of apology to Jordyn for the club's failure to respond to his 2004 letter.

New Treasurer: As announced at the last meeting, both Jim Dotterer and John will sign all club checks. However, because of family commitments, John has not been able to keep up with all the requirements of being Treasurer. Darrell Gehlsen has done a remarkable job of reconstructing the club's accounting records and therefore Jim has appointed Darrell Gehlsen as Treasurer/Bookkeeper. John will continue to pick up the mail from the club's PO Box and deposit all incoming checks, but will forward copies of the checks, deposit slips, receipts issued and any bills received to Darrell for processing. Darrell, in turn, will draft any required checks and forward these to Jim/John for signature.

Accounting Balances: Again, as reported last month, Jim D. and John C. opened a new account at Heritage Bank. Since then, the contents of the other three Heritage accounts have been transferred to the new account. As of 8/5/05, the checkbook balance at Heritage was \$15,171.62; there were \$370 in undeposited checks and \$857.03 in outstanding bills. As of 8/5/05, the balance at Homestreet Bank was reported to be \$84,630.86. However, the bank reported that the \$4,000 check sent to Everson to bind CCRP's paving contract had not been cashed so the actual balance of the Homestreet account was estimated to be about \$80,000.

Fire Insurance – John C. had previously circulated a proposed draft of a letter to be sent to CCRP's insurance agent requesting a proposal for more appropriate insurance coverage. The draft letter now requests coverage for the main clubhouse, permanent covered firing points and range sheds at the Black Powder, Multipurpose and Hi Power and Action Pistol ranges and the archery building, but excludes the Hunters Ed building from the coverage. After some discussion about coverage of the range structures, and the location of CCB inventory in the main clubhouse, it was agreed that John should forward the letter to the insurance agent as written.

Financial Reports – Because he has reconstructed CCRP's accounting records, Darrell G. was able to provide the BOD with a balance sheet as of 8/5/05 and an income/expense sheet for the period 1/1/05 through 8/5/05. He pointed out that if Match Directors could provide greater detail in their reporting, these reports, in turn, would be more detailed. Mike Iyall commented that, with this type of detail, the club could start to make year-to-year comparisons. Ray Crisp expressed concern regarding reporting of the archery income. Darrell also reported that CCRP will have a record of who worked and who paid their assessments. Rick B. questioned how often the club auditor would examine CCRP accounting records; Darrell said twice a year. It was moved, seconded and passed that the financial reports be accepted.

Membership – Based on club accounting records, Darrell indicated that there are 407 members. Bob Gietz said that he is expecting quite a few new members.

Road Work – Chris Moffet indicated that Everson will commence tear out next week (week of August 8-12). Everson has already placed marks for locating utilities that pass under the road.

Relationship between CCRP and CCB – Chris M. pointed out the need to clarify the relationship between CCRP and CCB. Ray C., Bill Wright, Jim Dotterer and Will Ulry as a committee are charged with doing this. Ray C. said that the important thing was to remove any uncertainty in the language of the agreement between the two clubs. He reiterated that CCB is a separate club with a separate identity that files its' own taxes. Will U. said that Jim D. needs to convene the committee. Ray C. commented that the meeting should take place soon because of the imminent archery hunting

season. Chris M. wanted the first committee meeting to take place during August but no date was set. Mike Iyall suggested that a redraft of the agreement should be presented to the December BOD meeting.

Hunters Ed – It was reported that Greg Squires was ill and that he will not be able to continue with the Hunters Ed program at CCRP. Rick B. volunteered to take Greg's place.

Second Gate Card for Families (Associate membership) – Chris M. read an email from Rich Montecucco describing the informal issuance of second gate cards to families that currently takes place. There followed a wide-ranging discussing of the pros and cons of issuing additional gate cards to families. Darrell G. said that if, for example, a member's spouse is using the range without the member being present, CCRP's liability insurance is void. Shirley Rheault said that spouses should pay membership fees and complete orientation, but that initiation fees could be dropped. No conclusion was reached. However, Bob G. offered to draft a proposal for restoring associate membership.

Incident Report Form – Shirley R. distributed copies of a two-page incident report form. Bob G. took exception to the form length and Chris M. said that he would forward a copy of a one-half page form to Shirley for her review.

Review of Assessment Program – Chris M. reminded directors that when the assessment program was instituted, the BOD committed to a review of the program after one year. After some discussion, it was moved, seconded and passed that the assessment program be continued. Rick B. suggested that completing the assessment should entail some form of physical labor. However, several members took issue with his position saying that there were many different ways to work off the assessment (e.g. gun shows, hunter sight in, etc.). Jim Zobrist stressed that the assessment program led to member involvement in the club and that any form of involvement was valuable. Darrell G. estimated that the club had received \$10,000 worth of labor as a result to the program.

Club-Wide Work party – Several directors advocated for a single, annual club-wide work party to get the work done and to avoid frequent shut downs of the ranges. Shirley R. suggested that the single annual work party be scheduled for a 5th weekend in June, July or August thereby avoiding any impact on normal monthly schedules. She noted that based on her check of annual calendars one of these months always has a fifth weekend. Chris M. agreed that one work weekend be scheduled for the 5th weekend in whichever month has five weekends.

Completing Signs – Will U. pointed out that the plastic letters purchased to renovate the clubhouse sign had been picked up by persons unknown and were missing. It was moved, seconded and passed that Will obtain the needed letters for no more than \$150.

Range Safety Officer Class – Bob G. reported that John Mickel will be scheduling an RSO class, that class size is limited to seven individual, that prospective participants will be enrolled on a first come, first served basis and that each needs to send the \$20 fee to John. Participant total fees will include \$30 for textbooks. Bob offered a motion that the club compensate successful participants for their fees on their request. The motion was seconded but, failed passage.

Match Report Form – Shirley R. agreed to send out a copy of the new Match Report form to the BOD.

Flea Market – Bob G. noted that Ron Lohman was selling out his reloading supply business and he might be willing to offer portions of his inventory for sale if CCRP supported a flea market for supplies. Bob suggested that the flea market might be scheduled in the first week of October to include supplies and sporting equipment but no guns. There was further discussion but no conclusion was reached.

Historical Gun Makers Meeting – Bob G. reminded the BOD that the Washington Historical Gunmaker's Guild would be meeting in the clubhouse August 25-28. Will U. pointed out that the clubhouse should be cleaned prior to the guild's meeting. No decision was reached.

Meeting of Nationwide Archery Group – Ray Crisp briefly described a proposed meeting of a nationwide archery group. He asked if CCRP could serve as the venue for such a meeting, time and date as yet unspecified. No objections were offered.

Adjournment – The meeting adjourned at 9:03 PM.
