From the President's Desk:

Comments on the Draft EMERY COUNTY PUBLIC LAND MANAGEMENT ACT OF 2011

Two of the primary purposes of the San Rafael Backcountry Horsemen are: **To perpetuate the common sense use and enjoyment of horses in America's back country and wilderness; and To work to insure that public lands remain open to recreational stock use.** Our local Chapter has spent hundreds of hours and thousands of dollars maintaining and improving non-motorized trails in Emery County on both Bureau of Land Management and Forest Services lands.

Members of the San Rafael Backcountry Horsemen have attended most of the Public Lands Council meetings concerning the Draft Emery County Public Land Management Act of 2011. We have reviewed the various drafts of the Land Management Act and the associated maps and appreciate how our comments and concerns have been addressed.

We agree with the management as proposed in the draft act, however we have a concern that wilderness designation may be interpreted by some organizations and agencies to mean that the use of motorized equipment to maintain existing trails will not be allowed. Many of the trails in Forest Service wilderness areas will become impassable if they are not cleared annually. Because of the large number of dead trees that fall across trails it would be extremely costly and nearly impossible to maintain them with only cross cut saws and no chainsaws. It is also much more practical to use power drills to remove rock barriers and other safety hazards.

House Report 95-540 (Endangered American Wilderness Bill) admonishes the Forest Service for their "purity criteria" and provides specific instruction on how the 1964 Wilderness Act is to be interpreted as it relates to certain uses and activities that are important to many of our members – including hunting, fishing as well as trails, bridges and signs. In the report, Congress specifically stated that trails, trail signs and bridges "... are often important to the recreational access and use of a wilderness area. Trail construction or maintenance can include the use of mechanical equipment where appropriate and/or necessary." It is our opinion that the use of mechanical equipment IS necessary. As such we request that language allowing the use of such equipment be included in the Emery County Public Land Management Act of 2011.

In addition to the congressional record, as noted above, case law provides valuable insights as to legislative intent. Case law regarding wilderness is somewhat sparse, but the judgment regarding Wilderness Watch and the Forest Service in the Frank Church River of No Return

Wilderness would appear applicable: "Thus the statute clearly directs defendants (Forest Service) to administer the Wilderness with an eye not only toward strict conservation, but also to ensure the use and enjoyment of the American People. The Wilderness Act does not direct defendants to pursue a single, limited purpose, as plaintiffs (Wilderness Watch) suggest, but it instead requires them to serve a number of public purposes, and to foster recreational, scenic, scientific, educational, conservation, and historical use... For this reason defendants management decisions must consider all these purposes, and defendants must undertake a minimum of administration, in order to make the Wilderness accessible to those Americans who wish to use it."

Without the regular use of motorized equipment for trail maintenance not only would recreational uses be adversely impacted but livestock grazing, search and rescue, fire control and other emergency needs would be greatly hindered. Thus "use and enjoyment" of the Emery County wilderness areas by the American People would be limited.

We therefore request that language allowing the regular use of motorized equipment to maintain trails be included in the Emery County Public Land Management Act of 2011.
