#### **Admission Modalities**

The Admission modalities are with reference to the B.Tech. Program (2012-16) offered by ICFAI University, Jharkhand.

#### Eligibility

The eligibility criteria for admission into the B.Tech. Program is 45% aggregate and above in 12th Class examinations or its equivalent with pass in each of the Mathematics, Physics, Chemistry and English subjects. The applicant should fulfill the minimum age requirements as prescribed by the respective board through which the applicant has appeared for the qualifying examination.

If an applicant is found ineligible for whatever reasons even after admission into the Program, his/her admission will be cancelled. All admissions will be subject to verification of facts from the original certificates/documents of the students. The decision of the Admissions Committee regarding eligibility of any applicant shall be final.

#### **Admission Process**

The admission into the B.Tech. Program is made through application and interview. Eligible applicants are required to apply for the program using the Application Form (given on page 5). The University will offer provisional admissions subject to the students satisfying all the eligibility criteria. The admission would be confirmed only after all the required proof of eligibility have been produced by the student and verified by the Admissions Office. Due weightage is given to past academic record, academic distinctions, achievements in sports and extra-curricular and co-curricular activities.

Alternatively, applicants can purchase the Application on payment of ₹ 600 from the admission office (address given on page 4).

#### E-mail

It is mandatory for all applicants to indicate their e-mail ID, as all important information will be intimated to the students by e-mail.

#### Affidavit regarding "No Ragging"

Duly signed affidavit is required to be submitted by every student on the day of registration to the Program as per rules.

#### Reporting date for First Semester

All selected students have to pay the requisite fees through Demand Draft before they report to the University campus on July 16, 2012. The

Preparatory Classes will commence on July 16, 2012 for new students.

#### Admission Fee

Admission fee of ₹10,000 is to be paid by all the selected candidates on or before July 10, 2012.

#### **Program Fee**

The total program fee (for 8 semesters) is ₹ 4,21,000 for domicile students and ₹ 5,41,800 for non-domicile students. The fee includes campus activity fund and alumni society membership fee. The semester fee is ₹ 52,625 for students domiciled in Jharkhand and

₹ 67,725 for non-domiciled students. Students should pay the fee as per the due dates indicated in the Student Handbook. The first semester program fee is payable on or before July 16, 2012.

#### Caution Deposit

All students are required to pay a caution deposit of ₹ 10,000 (refundable) along with the first semester fee

#### Remittance

All payments should be made by way of Demand Draft drawn in favor of "IUCF A/c IUJ", payable at Ranchi.

- f) DD for ₹ 600 / Receipt of ₹ 600 paid to the admission office.
