- A. The deadline date for submitting completed applications and supporting documentation is **Wednesday, January 6, 2010**. Incomplete applications will not receive consideration from the Scholarships, Awards and Bursaries Committee.
- B. The scholarships, awards and bursaries listed in this booklet, including their availability and amounts, are subject to change and/or become unavailable.
- C. Scholarships, awards and bursaries are taxable under the Canadian Income Tax Act. A T4A will be sent to the recipient by March 1, 2010. Students who receive OSAP are required to report their scholarships and awards to the Ministry of Training, Colleges and Universities.
- D. Applicants must be full-time postsecondary students attending a minimum of 40% of a course load if he/she has a permanent disability. To be considered for scholarships, awards and bursaries a minimum grade point average of 2.40 in the fall semester is required. **AS YOUR G.P.A. WILL NOT BE AVAILABLE UNTIL AFTER THE DEADLINE DATE, PLEASE APPLY WITHOUT KNOWLEDGE OF YOUR GRADE POINT AVERAGE FOR THE FALL SEMESTER.** A student will not be eligible for scholarships, awards or bursaries if he/she withdraws from full-time studies in the winter semester.
- E. Need, as well as academic achievement, are factors in selection and will be used for selection of recipients.
- F. Scholarships, awards and bursaries requiring supporting documents, research papers etc. are to be submitted with your application by the deadline date.
- G. Only recipients of scholarships, awards and bursaries will be notified by mail at the end of February 2010.
