Physician Orders for Life Sustaining Treatment (POLST) is a medical order that enables seriously ill patients to designate their desired treatments and to ensure that medical professionals honor those preferences.

The Georgia POLST Collaborative, one of only 16 approved programs across the nation, is part of the National POLST Paradigm and aims to educate patients, families and health care professionals throughout the state about the GA POLST. The mission of the Collaborative is to improve the health care at the end-of-life through:

- Promoting the utilization of the POLST form by health care professionals and institutions across the state
- Educating Georgians about advance care planning and the role of the POLST in having their wishes honored

MEMBERSHIP CATEGORIES

Organizational Member

A group or organization involved in end-of-life care and interested in promoting the mission and participating in activities of the Georgia POLST Collaborative may join and extend membership benefits to two members of that organization. The organization will be recognized on the POLST website.

Facility Member

A long-term care facility, hospice, hospital, assisted living facility, or government agency may join as an entity and extend the benefits of active membership to two individuals who are involved in the clinical or administrative functions of that facility. Individual representatives from a facility may include physicians, nurses, lead administrators, and owners. The facility will be recognized on the POLST website.

Healthcare Professional

Healthcare administrators and licensed healthcare professionals whose professional/clinical work includes end-of-life issues may join this category and may register for symposia at the member rate.

General Member

Members of the clergy and general public who have an interest in end-of-life issues are eligible for this category.
