We are pleased to announce the successful grant application submitted by the Neighbour to Neighbour Centre entitled, 'Kids Can Succeed' Reading Tutor Program.

The amount of \$2 000 will go towards the Centre's reading tutor program in the Hamilton mountain schools. The targeted students are those in grades 1-3 who just need that extra help to be successful. The program has been a huge success for some time now and we are delighted to be a part of it in the coming year.

In addition, District 13 has granted \$500 to the Camp Marydale and Urban Hoops Basketball Camp towards this year's summer program. Bus transportation is provided to those children in the inner city who would otherwise never have the opportunity to attend a day camp program. Special needs children are also accepted at this camp at no charge. We are pleased to be a contributor towards the outstanding program offered at Camp Marydale.

Oppose the Lock-Out of the Stelco Workers

The 900 members of Local 1005 USW were locked out by U.S. Steel Canada on November 7, 2010. The workers were locked out because the union would not agree to give up the indexing for 9000 pensioners and they would not agree to give up the pension plan for new hires, which will eventually lead to the elimination of the pension plan that workers at Stelco have had since 1956.

U.S. Steel is part of the North American trend of companies wanting to get out of pension plans for workers and replacing pension plans with a savings plan. U.S. Steel is using its monopoly position in North America and the fact that they have excess capacity in the U.S. to try to dictate to the workers that they have to give up their pension plan, or they will starve the workers out.

This lockout occurred three years after U.S. Steel purchased Stelco and is the

second time in three years that they have shut down the Hamilton plant. The first time they shut the Hamilton plant was in 2009 and this forced the Federal Government to sue U.S. Steel for violating the commitments U.S. Steel made to the government promising to keep full production and employment going for three years. After two years, the case still has not gone to court.

The workers at 1005 are fighting to preserve their pensions in the context of fighting for the retirement security for all and we are opposing the wrecking of Canadian manufacturing, especially by foreign monopolies coming into Canada and buying up Canadian companies and then shutting them down, either to wring concessions out of the workers or to steal their markets.

McMaster University –RTO/ERO Hamilton-Wentworth, Haldimand Gerontology Scholarship

Congratulations are extended to Emma Mauti, the winner of the RTO/ERO District 13 Gerontology Scholarship at McMaster University. Emma was unable to attend the recent District 13 Spring Annual Meeting Luncheon but did send along a note of gratitude. She stated that "It means a lot to me - recognition of the hard work of students reflects very well on your organization and shows that you appreciate their efforts in learning about Gerontology". Did you know ...

The medical expense tax credit is the second most adjusted claim on the tax returns that are filed each year. Most taxpayers, especially retirees, fail to realize that they can claim the medical premiums paid out-of-pocket -- after a 3% deduction of net income with a maximum -- from a long list of claimable medical expenses. They also fail to realize that

they can go back 3 years with an additional 7 more years using the Fairness Provision in the Income Tax Act. All they need to do is complete a T1-Adjustment form for each year adjusted along with supporting receipts, documents and/or letters and then mail everything to Revenue Canada. Ask your tax professional for more details.

Your Health Matters

Those of you who have RTO medical coverage, be sure that you have received your 2011 Insurance Plan Booklet. In it is included the Out-of-Province/Canada Travel Booklet. If you can't find the information you require in one of these booklets, it is a good practice to call Johnson Inc. to ensure that you are covered, request a pre-determination if costs will exceed \$600, get a treatment plan and know the exclusions. A good example is a Dental Exclusion (page 31 item 5) "A Filling Repair Within 12 Months of the Initial Filling". You should make your dentist aware of this exclusion. Perhaps the work can wait in order to ensure coverage. If you have a lot of work being done, keep an eye on your yearly limit. Let your dentist know your limits.

Make sure your pharmacist knows that the \$100 Ontario Drug Benefit (ODB) deductible is covered. You can claim 85% of the ingredient cost of the \$100 ODB deductible and it might be worth asking your pharmacist to claim your most expensive drug at this point for the reimbursement.

The RTO insurance plan can be an addition to coverage you may already have with a group plan such as with the employer. If you are still with a Board Plan you can easily switch to the RTO plan entirely or in part. No medical required. If you have friends still working in education, they may be required to purchase medical once they turn 65. They can become Associate Members of RTO and purchase the medical coverage needed.

Recently, a few members did a survey of drug stores in the Hamilton area. We wanted to find out if the costs of drugs and dispensing fees varied at different pharmacies. Since the RTO plan does not cover dispensing fees, we thought it would be an interesting research project. The plan has yearly limits so it is important if you take expensive medication that you are aware of some cost savings that may be available from different pharmacies. We looked at Lipitor in our sampling - 10 mg. 90 days supply. We found that dispensing fees ranged from \$9.97-\$11.99 and the Lipitor from \$174.69-\$193.99. Of course, the generic drugs were in the \$58-\$99 price range. If you are interested in our results and which pharmacies we surveyed, e-mail me at: jaird@cogeco.ca and I will be happy to share them with you. I would be interested in results from Burlington, and Haldimand Pharmacies if you would like to add to our survey. Notes: 1. Check to see if letters of insurance coverage are needed when travelling. Cuba was asking for it and now some Eastern European countries are requesting proof of insurance. Johnson will be happy to give you a letter. Carry your plan book in case you need to provide information regarding your coverage.

2. The Shingles Vaccine: Zostavax is the only vaccine indicated to help prevent shingles in individuals 60 years of age or older, and is given as a single dose injection and works by boosting your immune system to help protect you from shingles. If you do get shingles even though you have been vaccinated, Zostavax can also help reduce the intensity and duration of shingles pain. Zostavax does not protect everyone who gets the vaccine and cannot be used to treat shingles or the pain associated with it once you have shingles.

A Remembrance of Things Past: The War



As one's days draw to a close, there is an increased tendency to summon up remembrances of things past and inflict them on other people. Here I am at eighty-six years of age and finding pleasure in recalling those days and the many fine young men with whom we shared our lives. And perhaps , if anyone chances to read these few lines, they will appreciate not only the futility of war, but also the positive results that can mark forever the men and women who are involved in military life.

I feel rather guilty to admit it but I loved flying, most of the time, and if danger was ever present, being young, you couldn't believe that anything untoward could ever come your way, and yet, there really were some exciting moments. There were a lot of positive aspects to military life: there was an opportunity to travel and see parts of the world that were fascinating even in war time. Also, the training developed some positive traits; for example, the ability to work as a team, leadership qualities from the necessity to make decisions often in a few seconds, esprit de corps, pride in belonging to a great organization, the ability to conduct oneself in public "as befits an officer and a gentleman", (although I can't maintain that I have always lived up to that ideal), mathematical skills, a sense of organization and a desire for precision. So many memories!

My later life would have been quite different without that period in the RCAF. Veterans were well treated after the war; for example, I was able to attend university for five years and I couldn't have done so without those veteran's gratuities. And now, sixtyfive years later, the Department of Veterans Affairs provides me with a small pension and assistance with the maintenance of our home. Pretty decent. I benefited from my personal military career - and yet I can't erase from my mind the regrets for the many young men and women who did not come home. They are not forgotten.

Political Advocacy Committee (PAC) Report

Once again the Political Advocacy Committee has gone through a transitional year. As Leo Normandeau's provincial responsibilities increased, it became necessary to appoint a new Chair for the PAC. In February the Executive appointed Marnie Daly as the interim Chair.

The PAC has been involved in promoting the priorities of RTO on issues of health care for seniors, affordable housing and living independently with dignity. With the call of the Federal Election, the Committee quickly formulated a plan of action for advocacy based on these principles. To that end the Committee approved the purchase of a series of radio ads to be aired in the week preceding the election. The radio spots were developed in a nonpartisan format to inform the public of our concerns and to encourage seniors to vote for the candidate who supports health initiatives and affordable housing programs for seniors. The committee also developed a poster to distribute in retirement homes throughout our region which provided information and encouragement for seniors to exercise their rights as Canadians.

The PAC became involved in outreach through a Saturday morning visit to the U.S. Steel plant in Hamilton to lend support and "walk the line" with our USW brothers and sisters who have been locked out for many months. We were able to learn a great deal about the issues for which they are fighting. In fact, there are approximately 900 locked-out workers who are fighting to protect the pensions and benefits of over 9,000 retirees. This issue is very important as we watch the attack on pensions all over North America. The committee presented the picket captain with an RTO flag and, of course, we provided them with sustenance in the form of homemade soup and donuts. (Continued on page 21)

Pension Concerns Committee Report

Estelle Baxter has retired as Chair of the Pension Concerns Committee. Estelle deserves 'a big thank-you' for the fine work, loyal dedication and lively humor that she has brought to this committee over the years. Thank you, Estelle!

Here are some items that you may or may not be aware of that can have an impact on your pension and retirement:

*In January 2011, you received an increase of 1.6% to your pension.

*Effective January 1, 2010 the Ontario budget announced a reduction in the lowest tax rate from 6.05% to 5.05%; and that all the other tax rates have remained the same.

*The Ontario government has introduced legislation to convert the Ontario Property Tax Credit to the Ontario Energy and Property Tax Credit (OEPTC). This tax credit will be paid quarterly, starting in the summer of 2011. The OEPTC is based on property tax or 20% of rent paid. If you did your own tax return, you quickly learned that filling out the provincial tax forms was confusing and many mistakes may have been made which hopefully will be addressed.

*Eligible seniors will continue to receive additional assistance with their property taxes through the Ontario Senior Homeowner's Property Tax Credit.

*The Ontario Teachers' Pension Board has reported a 'healthy looking' return on their investments. The shortfall and liabilities in paying future pensions continue to be a concern. You can get further information at **www.otpp.com**.

*There are currently 1.4 working teachers for each retiree. This ratio is projected to fall to approximately 1:2.1 in 10 years. A typical teacher retiring in 2010 has 28 years of pension credit and is expected to receive a pension for 30 years. This demographic profile necessitates an investment risk tolerance that is lower than that with a higher-to-retiree member ratio.

*Private pensions are being unfairly eroded by companies who are no longer in business or are reconsidering their liabilities and do not want to continue funding pensions to their retirees - just think of Nortel or US Steel.

*For seniors the Tax-Free Savings Account is an excellent way to save money. You can shelter the interest income from taxes and if you follow the guidelines, you can withdraw the money tax-free.

*The RTO/ERO Provincial Pension and Retirement Concerns Committee, with administrative support, has concentrated on both Pensions and Fact Sheets. The RTO/ERO Provincial Pension and Retirement Concerns Committee have been working on the development of Fact Sheets on numerous topics of interest to all teachers. Available are 66 Fact Sheets: Financial Issues (10); Government Benefits (5); Health Issues (11); Insurance Issues (7); Legal Issues (11); Marital Issues (9); Surviving Spouse Issues (5); and Retirement Issues (8). All of the Fact Sheets can be viewed and obtained from the Provincial RTO/ERO website: www.rto-ero.org. These Fact Sheets are made available at all meetings. Please feel free to take a copy of any fact sheet that may interest you.
