ALL AMERICAN DOGS: Owners of All American dogs must obtain an AKC Canine Partners listing number before they may enter an AKC agility event. Under "Breed" on the entry form, dogs must be listed as All American Dog and not as a breed hybrid.

<u>SITE INFORMATION</u>: There is ample crating space in the Little Paws building. Indoor crating is on a first-come, first-served basis. Restrooms are on the grounds. NO ON-LINE ENTRIES.
