The Golden Retriever Club of America is pleased to invite you to the Western Regional WC-WCX tests to be held on Sunday, May 20, 2007, at the Anna's Achers near Terrell, Texas . Map is included on the reverse.

The test is open to all golden retrievers.

No wingers or mechanical launchers will be used in these tests.

We will also host the following events directly after the completion of the WC/ WCX land tests:

(a) A non-competitive get 'em out and throw 'em some birds stake for all retrievers of any age, regardless of titles, legs or placements, that are NOT entered in the WC/WCX. Minimum of two (2) retrieves: pheasants, pigeons, or ducks (you call it). Cost: \$5.00.

(c) A junior handler stake for any retriever, regardless of titles, legs or placements, or entry in any other event, handled by a junior under the age of 14 years. Minimum of two (2) retrieves: pigeons, pheasants, or ducks (handler's choice). Ribbons for all entrants. Cost: \$5.00.

(d) A senior dog@ stake for any retriever, regardless of titles, legs, or placements, or entry in any other event, who is over the age of nine (9) years. Minimum of two (2) retrieves: pigeons, pheasants or ducks (handler's choice). Photo opportunity for the oldsters. Bring them out to play one more time. The older the better. Cost: \$5.00

Entries for all non-regular events (junior handler, senior dog and all-age stakes) will be accepted the day of the event.

Lunch) will be available on the grounds and will be \$5 if you order ahead, \$6 if you buy the day of the test.

A photographer may be on hand to take action or portrait pictures of your dog. You may elect not to have him take pictures of your dog during the test.

Refunds in full will be given for bitches in season with appropriate documentation. Remember they are not allowed on or near the trial grounds. No phone or fax entries; running order will be published on club web site (dfwmgrc.org)

Please sign the enclosed release form as part of your entry form.

Please, we request no consumption of alcohol until the tests are complete.

Please pick up all trash and debris, including all cigarette butts. If it's raining or muddy, please stay on roads until and unless otherwise directed. We request you sign the attached release form and send it with your entry. Remember, bring water, ice, and shade, but also bring your rain gear, as well as chair, camera and applause. We hope you can come.

RELEASE, ACKNOWLEDGEMENT, AND INDEMNITY AGREEMENT

I hereby acknowledge that I have read, understand and agree to comply with the provisions of this document relating to hunting/dog activities at Anna's Achers, Terrell, TX .

I further acknowledge and understand that no warranty, either expressed or implied, is made by GRCA (collectively, the "Release Parties") as to the condition of the Property, or any, buildings, gates or other improvements located thereon (the "Property"). I understand that my presence and activities on the Property exposes both me and my guests, dependents, dogs, and property to dangerous conditions, risks and hazards that exist on the Property and which could lead to injury, death, illness, disease or other damage to person or property including but not limited to the following conditions: poisonous snakes, insects and spiders; erosion and general condition of the land, both on and off roadways or gullies, creating rough, hazardous and dangerous driving and walking conditions; animals both wild and domestic that may be diseased and/or potentially dangerous; flowing and/or deep water; persons with firearms both on or off the Property; electric or barbed wire fences and other man made debris; and the use of vehicles. I hereby state that I have been warned about the existence of, and expressly assume all risk and responsibility with respect to such dangers, risks and hazards.

In consideration of the right to enter the Property and conduct hunting tests or other activities thereon, I hereby unconditionally release and agree to protect, indemnify and hold harmless, the Release Parties from and against any and all claims, demands, causes of action and damages, including attorney's fees, to or in any resulting from my presence on the Property or the presence or any other person (including, without limitation any minor or dependent) NOT CAUSED BY THE NEGLIGENCE OR GROSS NEGLIGENCE OR ANY ONE OR MORE OF THE RELEASE PARTIES. I hereby further conditionally covenant and agree that I, my heirs, legal representatives, successors and assigns will not make any claim or institute any suit or action at law or in equity against the Release Parties that is based

upon any accident, incident or occurrence arising out of, incidental to or in any way resulting from my presence on the Property or the presence of any other person (including, without limitation, any minor or dependent or dog) permitted access to the Property as my guest or at my request.

I agree that any claims, actions or proceedings arising out of or attributable to my presence and activities on the Property shall be litigated in courts located in Hunt County, Texas. Furthermore, I hereby submit to

the jurisdiction of any local, state or federal court located in said county and waive any right I may have transfer or change jurisdiction or venue of any such jurisdiction.

As used in this release, the terms, I, my person and myself include dogs, minors and dependents in my care while on the Property.

I acknowledge that I have read, understand and fully accept the terms and conditions of this agreement and unconditionally and voluntarily accept same in consideration of the right to enter the Property; and conduct hunting tests or other activities thereon. Because of the high risk nature of this undertaking, the undersigned fully warrants that he/she has knowledge and/or experience in hunting tests and in the outdoors. The Release Parties have relied upon this representation in allowing the undersigned to enter the above mentioned property. I further state that I am of legal age and competent to sign this affirmation and release.

Take U.S. Highway 80 east from Terrell, TX from the intersection of Highway 34

Go 1.3 miles to FM 429. There is a Texaco station on the Northeast corner of the intersection.

Turn left (North) on FM 429 and go 10.1 miles to County Road 338. This is just past FM 2728. There is a sign to Able Springs Cemetery on the left of FM 429.

Turn right (East) on County Road 338, towards the Able Springs Cemetery. This is the only direction you can turn. Follow County Road 338 past the cemetery until it dead ends. Take the left fork of the road and look for the gate on the right side to the test grounds.
