The Department of Energy, Govt. of Orissa, the above named Petitioner,
most respectfully showeth that :

1. The Petitioner herein above, the Deptt. of Energy, Govt. of Orissa, (hereinafter called as "the Govt.") submit that the Hon'ble Orissa Electricity Regulatory Commission (herein after called as the 'Commission' or the 'OERC') passed the Retail Supply Tariff (RST) Order dated 18.03.2011 in Case Nos. 146,147,148 & 149 of 2010 for FY 2011-12 in respect of the various electricity consumers of the State of Orissa to be effective from 01.04.2011.

2. It is submitted that the Hon'ble Commission, while passing such Order for FY 2011-12, have revised the Retail Supply Tariff as well as the slab for various categories of consumers of the State.

The Govt. graciously submits that Orissa has, at present, an existing electricity consumer base of around 39 lakhs out of which about 26 lakhs forming bulk (about 67%) of the total electricity consumers of the State, belong to the domestic consumers. The steep hike in RST applicable for domestic consumers has created an upheaval among the domestic consumers which, in fact, has resulted in a tariff shock to them.

3. It is submitted that the Domestic-LT consumers consuming electricity between the newly introduced slabs of 50 Units to 200 Units per month have been worst hit as the rise in tariff in this case, has been one of the highest as evident from the following:

From the above Table, it may be observed that the existing tariff of 140 P/U in the FY 2010-11, has suddenly been raised to 350 P/U (showing a rise of 150%) during FY 2011-12. This is certainly going to cause tariff shock to the consumers belonging to this slab. Thus, the revised tariff of 350 P/U for consumption between 50 to 100 Units would lead to unbearable burden for them. Therefore, the Govt. is seriously concerned for domestic consumers.

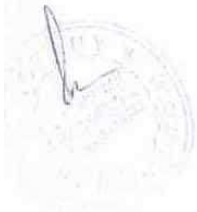
4. It may be worth mentioning here that Orissa is one of the poorest States in the country with 46.41% belonging to the BPL category. Even, people not classified under BPL category do not possess good purchasing power to pay the higher tariff as per the redefined new slabs and rates so determined by the Hon'ble Commission. It may please be seen that such higher tariff of 350 P/U from 140 P/U representing an increase of 150% in one go, all of a sudden, would definitely pose a heavy burden on the domestic electricity consumers of lower class and lower middle class consumers.

5. It is further submitted that the newly revised higher tariff of 350 P/U for monthly consumption between 50 to 200 Units, may lead to rise in non-compliance on their part in so far as the payment of electricity dues are concerned. Consumers will tend to keep the monthly consumption within 50 units for which they may resort to various unfair practices like; meter-tampering, meter by-passing and hooking etc. All these will ultimately affect the revenue of DISCOMs badly.
6. It is, therefore, most respectfully submitted that the Hon'ble Commission may kindly consider to review its decision of implementing the revised tariff.
7. In this context, it may be worth mentioning that the Govt. of Orissa have all along been submitting before the Hon'ble Commission including the State Advisory Committee that the Retail Electricity Supply Tariff prevalent in Orissa does not require any revision at present considering the fact that the Aggregate Technical Commercial Loss (AT&C) of the DISCOMs is still high at around 45% and there are ample opportunities on the part of DISCOMs to reduce such losses to a sustainable level of around 15%. It may be noted that 1% reduction in AT & C loss, would result in increase in an estimated revenue of about Rs. 60 Crore per annum. Thus, the DISCOMs may be directed by the Hon'ble Commission to adopt various possible measures to achieve the benchmarked approved AT&C Loss of 22.49% from the existing of Loss level of 45%. In fact, if the loss reduction trajectory as approved by the Hon'ble

Commission is followed, there need not be any upward revision of RST and a reduction would be imminent.

It is further submitted that at the behest of the Hon'ble Commission, the Govt. of Orissa have launched a CAPEX Programme with Capital Outlay of Rs.2400 Crore in order to reduce the AT & C Loss @3% per annum over a period of 4 years. The State Govt. will contribute Rs.1200 Crore and the DISCOMs will provide matching counterpart funding of Rs.1200 Crore. At the end of the CAPEX Programme, the total reduction of AT & C Loss would be to the tune of 12% resulting in total cash gain of Rs.720 Crore per annum. In view of this imminent gain to the DISCOMs, no tariff hike is necessary.

8. Nevertheless, it is submitted that the Govt. is also conscious of the marginal revenue loss in case the above suggestion for downward revision of RST applicable for domestic category is effected. In the worst scenario of DISCOMs' unwillingness / refusal to accept the challenge of absorbing such marginal revenue losses by way of effecting reduction in their high AT & C Loss, other alternatives of compensating such loss can be explored.

9. In the above circumstances, the Govt. pray before the Hon'ble Commission to consider the above submission and to pass an order by reducing the tariff for domestic consumers in the greater interest of justice.
