The offer will be opened at 3.00 PM on 24th May,2011 in the presence of bidders or their authorized representatives, if any, present.

TERMS & CONDITIONS OF SALE

- 1. The items offered for disposal are "AS IS WHERE IS, WHAT IS & NO COMPLAINT BASIS" in up-packed condition and are subject to levy of Sales Tax, Tax Collection at Source(Income Tax)/Excise Duty and other or Central Taxes that may be extra as applicable on the date of sale.
- 2. The bidder may be allowed to inspect the items at the site of NIO Premises, Stores Section on any working day from 2nd May, 2011 to 23rd May 2011 between 10.00AM to 12.00PM by prior appointment to satisfy himself inter-alia, about the quality and condition of the items offered. No complaints whatsoever will be entertained after the offers are submitted on or before or after the items removed and no request for inspection after submission of offer will be entertained under any circumstances.
- 3. Bidders should quote clearly their rates in the prescribed form attached, both in figures as well as in words. No warranty or guarantee in respect of nos./weights shall be implied. Any over-writing in rates or changes or alterations without attestation are liable to culminate in the out-right rejection of the offer. Offers not indicating rates **EXCLUSIVE** of all other Taxes, TCS and Levies are also liable to be summarily

rejected. It must be clearly understood that Income Tax/Sales Tax/Excise Duty, if any, and other Government levies as may be applicable on the date of delivery will be payable by the bidder in addition to the accepted rates.

4. The Director, National Institute of Oceanography, reserves the right to reject the offers either in part or in full and take alternate steps for disposal of the items in the best interest of the institution.

EARNEST MONEY

- A) Earnest Money Deposit (EMD) has to be deposited for an amount of ten percent of the quoted price. The EMD must be accompanied along with the offers by way of Demand Draft drawn in favour of the Director, National Institute of Oceanography, payable at Panaji/Dona Paula drawn on any schedule bank failing which the offer shall be summarily rejected. No interest shall be payable on the deposit.
- B) The Earnest Money in respect of unsuccessful bidders will be refunded within a week's time.
- C) The Earnest Money of the successful bidder will be refunded within one week of the satisfactory completion of the whole transaction and after lifting the items.
- D) No withdrawal or modifications/amendment etc. of the offered rates will be permitted under any circumstances once the offer has been opened at the scheduled time and date. The offer of any bidders who violates this condition will be summarily rejected and amount deposited by him on account of Earnest Money will automatically stand forfeited.
- E) The bidder shall deposit, within Seven working days from the date of communication of the acceptance of offer, the full price of the material that may be released in his favour by Demand Draft in favour of Director, National Institute of Oceanography, Dona Paula, Goa before removal of the item. No other mode of payment shall be entertained.
- F) In case of failure on the part of the bidder to deposit full value of the items as prescribed at (I) above, the Director, National Institute of Oceanography may at his discretion, allow extension of time for such deposit upto a further period of 10 days, on payment of a penalty of 1% on the full value of offer per day subject to a maximum of 10% of the offered amount. On the expiry of such an eventually, the Earnest Money deposit shall also stand forfeited automatically.

CASH PAYMENT

Cash payment will be received by the Cashier, National Institute of Oceanography, Dona Paula, Goa only towards **Tender document fee is Rs.200/-(Non-refundable)** upto 23rd May, 2011 between 10.00AM to 12.00PM. during working days. This Institute will remain closed on all Saturdays and Sundays, besides approved holidays.

DELIVERY/ DESPATCH

- A) The items shall be removed by the bidder from the site within 10 working days of the Delivery Order. If deliveries are not taken within 10 working days, penalty of Rs. 500/- (Rupees five hundred only) per day per lot will be charged after expiry of initial period till the last day of complete delivery. If the items are not removed within 60 days from the date of release order, the Director, NIO shall reserve the right to cancel the bid, in which case the entire payment made by the bidder will stand forfeited.
- B) The items will be allowed to be lifted/removed only on working days of the Institute from 10.00 A.M. to 04.00 P.M.. The items shall in every respect, remain at the risk of the bidder from the date of bidding. The Director, National Institute of Oceanography (NIO), shall not accept any liability for the safe custody of preservation thereof from that date. No picking, choosing or sorting will be allowed in the premises for the disposal lots.
- C) The bidder shall give at least two days advance intimation in writing of the date(s) on which he intends to lift the items. The bidder shall have to make its own arrangement including, labour, transport for lifting the auction materials.
- D) Should the original bidder wish to tale delivery of the materials/ lots auctioned through a representative, he must authorize the later by a letter of authority, which shall be presented to the Director, National Institute of Oceanography who may at his entire discretion decline to act on any such authority unless bidder satisfies the Director, National Institute of Oceanography, that the authority is genuine. Delivery by proxy will be at the bidder's sole responsibility and risk and no claim shall lie against the Director, National Institute of Oceanography (NIO) on any account whatsoever, if delivery is effected to a wrong person.

GENERAL

- a) The Earnest Money and the payment made for the materials will stand forfeited, without prejudice to NIO's other rights, in case the successful bidder either withdraws or modifies his offer or cancels the offer or part thereof or does not abide by any or all of the terms and conditions of the offer or does not lift the material within the specified time limit.
- b) In the said eventually the Director, NIO will be at liberty to dispose-off the awarded material, or balance thereof, in any manner he may deem fit without any intimation to the bidder concerned and without assigning any reason whatsoever.
- c) The Earnest Money deposit shall also stand forfeited if the offer for sale is not accepted or acted upon by the bidder within the prescribed time limits shown in the offer. All offers will be sent by Registered Post and would be deemed to have been delivered within a reasonable facility.
