Please take the time to read this form carefully and to understand any accompanying information.

The purpose of the research is to increase our understanding of high performance forum groups. EO is interested in supporting and encouraging forums to reach their fullest potential and to offer the best possible value to their participants. Confidentiality will be strictly maintained for all information collected through this survey. The identities of individual participants will not be transferred from the electronic format. Only coded identity tags would be used for electronic analysis. Data by region or city may be compiled and identified, and individual forum groups may be contacted for further, optional, follow up if required. You are also welcome to collect data on a frequent basis and compare it against your individual forum groups past performance. Computer files will be password protected. No published or distributed materials will be created that will in any way identify an individual or an individual forum group without them being contacted and express written permission obtained.

Reports to participants will occur electronically. Each forum will be forwarded a compiled version of the data they provided. At your request a copy of any research report will be forwarded to you prior to its completion so that you may check its accuracy, and to ensure that

confidentiality has been maintained to your satisfaction. You may receive a copy of the final research report at your request.

Your completion of this EO online Forum Health Survey, indicates that you have understood to your satisfaction the information regarding participation in the research project and agree to participate as a subject. In no way does this waive your legal rights nor release the investigators, sponsors, or involved institutions from their legal and professional responsibilities. You are free to withdraw from the study at any time.
