



MORE Drive

On Sunday 7th September 2014 we are staging '*MORE Drive*' – an event aimed at reducing road accidents among 17 to 30-year olds. The event is being hosted at Millbrook Proving Ground and will give young drivers the opportunity to improve their driving skills through practical exercises and workshops to help keep them safe on our roads. The sessions run from 0900 – 1245 or 1300 – 1645.

To take part in the course, you will need to be aged 17-30 years old, hold a full driving licence. If you live within either Central Bedfordshire or Luton Borough Council Local Authority areas the course is free otherwise a subsidised fee of £60 payable at the time of booking by cheque or credit/debit card (for credit/debit card payment please call 01582 546263) .

Places are allocated on a first come first serve basis. If you are offered a place and then find that you cannot attend you must let Luton road safety team know at the earliest possible time and at the latest by 5pm on Wednesday 3rd September 2014. We reserve the right to recover the costs for any cancelled place that we cannot subsequently fill and for any late cancellation. **The charge will be £150 (£90 for participants paid for their place).**
