


During This 4th Week of Advent...



Pastor's Perspective

*FOURTH SUNDAY OF ADVENT

Advent now moves to its final phase, focusing more directly on preparing to remember Jesus' birth. Each year the readings for the Sunday focus on either Mary or Joseph and their own experience as they learn of becoming parents. This year the gospel is the one from the Annunciation, when the angel tells Mary that she will be the mother of the Savior, in spite of the fact that she is a virgin. The angel says "Hail, Mary, full of grace. Do not be afraid." Let's enter the season of Christmas with an openness to whatever life brings us and respond out of love and not fear. Have courage. Do not be afraid. God's grace is stronger than evil. Like Mary, we can also be "full of grace" in every situation of life.

*SACRAMENT OF RECONCILIATION

The final scheduled time for the sacrament of Reconciliation prior to Christmas is this Tuesday from 4:30 to 6:30 p.m. Think about celebrating this sacrament as a way to open one's heart to whatever life will bring and in a way that will allow us to be instruments of God's healing and peace.

*CHRISTMAS MASSES

In most parishes the earliest Christmas Eve Mass is packed to overflowing, often because it is a child-centered Mass. Here at SS. John and Paul we try to alleviate some of that crowding by designating the last Mass on Christmas morning, the 11:30 a.m. Mass, as the child-centered one. I also think it is a good encouragement for families to have the tradition of getting up on Christmas morning and coming to Mass, not just opening presents or playing with the gifts opened the night before.

Our first Christmas Eve Mass is at 5:00 p.m. and it is usually very, very crowded. If it is necessary for your schedule, then please come. But if you can come on Christmas Day or join us for the beautiful Midnight Mass (and, yes, we celebrate it at midnight!), then I strongly encourage you to avoid the 5:00 p.m. Mass and its crowd.

No matter what, make Christmas first and foremost a spiritual celebration of Jesus' birth and remembering that birth, rather than mostly the day for Santa and his gifts. Families have to be so much more intentional about how they celebrate Christmas so that children are able to resist the watered-down, secularized version of Christmas, which turns giftgiving into the equivalent of the Christmas message. Whether there are a few gifts or even none, Christmas is about the awesome wonder—God's becoming fully one with our humanity in the birth of Jesus so that we might have a way to become fully one with God.

*YEAR END ENVELOPE

In the mailing for Advent two weeks ago you received a year-end donation envelope. Each year I send this out, because a number of people are in a position to make a more significant contribution at year's end. This is not meant to be another collection nor is there an expectation that most will use it. Your usual Christmas donation is fine. The year-end envelope is intended for those who can give a little bit extra and do so significantly at the end of the year.

It is the second best way to get money to the parish in the sense that 94% (all but the 6% diocesan tax) stays with the parish. The best, of course, is the C.S.A. collection in the spring, where 100% directly helps or stays in the parish. Christmas is also a good way to help in that the 6% diocesan tax is not assessed, though it does factor into how our annual C.S.A. target is assessed (in effect, about 14% goes toward the increased target, 86% remains in the parish). The year-end envelope has no affect on the C.S.A. target, and so no matter the amount, does not change that target.

*PRIEST PENSION BOARD

I was recently elected by the priests of the Archdiocese to serve on the priests' pension board. It advises the archbishop and oversees the way that pension money for Detroit priests is being handled. Currently each parish or institution at which a Detroit diocesan priest (not religious order, they have their own pension funds) serves is assessed a significant amount of money to cover current pension costs and build toward a fully funded pension fund.

In addition, the parishes are allowed to have a collection each year (in September), which invites people to give directly to that fund, in order to offset some of the parish's costs (or, in rare instances, if the collection is more than the assessed amount, to add to the fund).

*END-OF-LIFE ISSUES (continued)

Please see last's week bulletin (online at www.ssjohnandpaul.org) for a summary of what has been covered thus far and for a more detailed look at the specific and rather rare case of someone who is permanently unconscious and has no hope of recovery (so-called permanent vegetative state). What about the more usual cases of people who need to be put temporarily on ventilators or receive nutrition and hydration, especially by assisted means? Are such treatments now mandatory? Once started can they be removed? Does someone need to be near death before they can be removed? What is the Church's wisdom here?

Here are the current pertinent directives from the *U.S. Bishops' Ethical* and Religious Directives for Health Care Facilities (4th edition).

• Directive 32. While every person is obliged to use ordinary means to preserve his or her health, no person should be obliged to submit to a health care procedure that the person has judged, with a free and informed conscience, not to provide a reasonable hope of benefit without imposing excessive risks and burdens on the patient

or excessive expense to family or community.

- Directive 33. The well-being of the whole person must be taken into account in deciding about any therapeutic intervention or use of technology. Therapeutic procedures that are likely to cause harm or undesirable side-effects can be justified only by a proportionate benefit to the patient.
- Directive 56. A person has a moral obligation to use ordinary or proportionate means of preserving his or her life.

 Proportionate means are those that in the judgment of the patient offer a reasonable hope of benefit and do not entail an excessive burden or impose excessive expense on the family or the community.
- Directive 57.A person may forgo extraordinary or disproportionate means of preserving life.

 Disproportionate means are those that in the patient's judgment do not offer a reasonable hope of benefit or entail an excessive burden, or impose excessive expense on the family or the community.
- Directive 58. There should be a presumption in favor of providing nutrition and hydration to all patients, including patients who require medically assisted nutrition and hydration, as long as this is of sufficient benefit to outweigh the burdens involved to the patient.
- Directive 59. The free and informed judgment made by a competent adult patient concerning the use or withdrawal of life-sustaining procedures should always be respected and normally complied with, unless it is contrary to Catholic moral teaching.

Directives #32-33 and #56-57 lay out the traditional Catholic wisdom

on judging what is morally ordinary (and therefore obligatory) and what is morally extraordinary (and therefore nonobligatory but optional) treatment. Notice that the well-being of the whole person has to be taken into account (#33). That means not just the person's physical or bodily health but also their mental and spiritual health as well. The tradition emphasizes that all we do must be subordinated to a person's spiritual well-being, first and foremost. That's why it is often morally acceptable to stop aggressive treatment and allow a person to move toward death at whatever pace their body, mind and spirit naturally can handle.

Directives #58-59 then applies that traditional Catholic wisdom to the issues of life-sustaining treatments. Note the following: 1) As with all such morally ordinary/extraordinary decisions, the benefits are to be weighed against the burdens. 2) But for nutrition and hydration there is a presumption in favor of using them, even if by medically assisted means. It can be withdrawn (or not started), if the burdens involved to the patient (pain, suffering, physical, emotional, financial costs) outweigh the benefits. But usually one presumes that nutrition and hydration will be provided. 3) What about other life-sustaining treatment such as the use of ventilators, chemotherapy treatments or aggressive surgical options such as by-pass surgery and the like? There is no presumption of using such procedures or not using them. The patient (or proxy) decides, and that decision is honored, unless it is a clear case of being against a moral teaching.

Notice, then, that the Church's teaching authority makes a distinction between providing nutrition and hydration and all other life-sustaining treatments. Various documents and bishops express it in various ways, but there is something natural about trying to get water and food to people. To not do so goes against basic human instincts and so should only not be done, when doing so is causing the person more burden than benefit. To not provide such nutrition and hydration, even by assisted means, in most cases would look too much like wanting a person to die

and so be "euthanasia by omission." But the use of aggressive surgery or chemotherapies or other therapies or even ventilators are not placed in the same category. They all can be done or not done, based on the reasonable weighing of benefits and burdens. There is no presumption that they need to be undertaken or that death has to be imminent to not undergo them.

In this wisdom, although it is usually a more clear-cut and easier decision to not start or to remove life sustaining treatments, when a person is near death or has an underlying illness leading to death, that is not a necessary requirement. The person (or proxy responsible) weighs the reasonably hoped for benefit against the reasonably foreseen burdens and makes the decision. Nutrition and hydration, even by medical assistance, is presumed to be given, unless the specific situation is causing a person an unreasonable burden. All other life-sustaining treatments are neither presumed nor excluded from the decision.

Some final thoughts next time.

*WISDOM BYTES

We will have our next "Wisdom Bytes" on this topic of end-oflife treatments and issues. Remember these are focused and relatively brief sessions of a half hour or so. Join us on Sunday January 4^{th} from 10:40 (after the 9:30 Mass) to 11:10 a.m. Or on Monday from 7:45-8:15 p.m. I encourage you to read my background reflections in the bulletins from November 30 through December 28th but it is not necessary. Bring specific cases and examples and questions and we will apply the Catholic moral wisdom to those specific situations. I will prepare a one page sheet of guidelines as well.

May you find a moment or two in the final week of Advent to once again pray "Come, Lord Jesus" into our world, into our lives.
