1. Executive Summary:

Major outcomes, results and impact of the Chair, including on national policies, in relation to its objectives as stated in Article 2 of the Chair Agreement (between the Institution and UNESCO) (Not exceeding 300 words)

As indicated in article 2 of the Chair Agreement:

"Cette chaire a pour objectifs principaux de promouvoir un système intègre d'activités de recherche, de formation, d'information et de documentation dans le domaine des politiques interculturelles. Elle facilitera la collaboration entre chercheurs de haut niveau et professeurs de renommée international de l'Université et des autres institutions d'enseignement supérieur de Grèce, d'Europe et d'autres régions du monde. "

To that regard the UNESCO Chair has always tried to pursue a structured targeted schedule of initiatives in order to achieve the realisation of the aforementioned aim. The UNESCO Chair uses a variety of versatile features in order to manifest its work that range from conferences and fora to publications and educational programs.

The elements of the work of UNESCO Chair have been to promote the intercultural policy through the information on Human Rights protection, the principle of non-discrimination, respect of human dignity and the rights of others in multicultural society with emphasis on the right to education, and the promotion of human rights education, intercultural dialogue and intercultural education at all levels of our society (academic, civil, etc.) having as a principle the accessibility of information for all regardless educational or social level. This is the prominence of the work of the UNESCO Chair-holder, that most of its activities acquire not only an academic quality but also an extrovert character.

The UNESCO Chair-holder has established a network between the UNESCO Chair and the museums in Thessaloniki and cooperates with the Municipality of Thessaloniki and the Direction of Secondary Education in order to promote the goals of UNESCO to primary and secondary education. The outcomes include a remarkable contribution to research, publications, raising awareness and distribution of information concerning the protection of human rights and cultural diversity in order to achieve an active citizenship, in other words, a democratic citizenship. Another aim of the UNESCO Chair has been to establish cooperation with NGO's, and particularly with the ones involved with the protection of vulnerable groups, such as immigrants, refugees, disabled etc. The most prominent examples would be the cooperation with various NGOs of the city (i.e. UNESCO Youth Club of Thessaloniki, Navarino Network) and NGOs that are dealing with people with disabilities and their rights.

The UNESCO Chair progressively appeals to more and more students every year who wish to be involved in various aspects of the work of the Chair as internees. At the same time Professor P. Naskou-Perraki, the UNESCO Chairholder and a well-established academic, is invited to numerous events and conferences to

lecture on human rights and the promotion of intercultural dialogue, and has contributed significantly to nurturing and establishing networks and links across academic disciplines as well as other social, public policy and civil society areas.

The UNESCO chair has been collaborating with the Hellenic Commission for UNESCO in a series of publications under the title: "Publications of the UNESCO Chair in Intercultural Policy". So far 8 publications concerning topics and issues relating to the work and the scope of the Organisation on topics such as Cultural Heritage, UNESCO Conventions, Human Rights, the Rights of the Child, women etc.

The work of the UNESCO Chair has contributed significantly to raising awareness on the protection of human rights; this is evidenced in the collaboration with schools of primary and secondary education; receiving funding from public bodies on UNESCO Chair's publications; as well as in publishing leaflets and books which are distributed for free to schools and University students on different thematics.

For example, following a number of international conferences on the rights of disabled people organised by the Ministry of Press in Athens where the UNESCO Chair-holder was one of the key note speakers. UNESCO Chair undertook the preparation of a leaflet on the Rules of Behaviour towards people with disabilities. The publication costs for this leaflet were initially provided by the General Secretariat of the Ministry Press. The leaflet was distributed to all public sectors and schools all over Greece. Currently, the UNESCO Chair is in talks with the Greek-German School of Athens with regard to the reproduction of this leaflet. The UNESCO Chair distributed electronically this leaflet on the rules of behaviour towards people with disabilities in order to reach out to the general public and disseminate information on the protection of the rights of people with disabilities. UNESCO Chair has uploaded this leaflet on the website of UNESCO Chair so that it can be accessible to any one. The value of this leaflet is further attested by the fact that the Library of the Ministry of Press has requested for the electronic version of this leaflet in order to upload it on the website of the Library, leading to its second edition one year later. Additionally in collaboration with the Hellenic College of Thessaloniki, two leaflets were published. The first being the Rights of the Child and its Obligation in schools in 2011, and was specifically successful and its success resulted to the publication of the 2nd edition in 2014. Both leaflets were published by the Hellenic College of Thessaloniki and were distributed for free. An electronic version is also available at the website of the Hellenic College of Thessaloniki.

The second leaflet was on the European Citizen's rights which was written and drawn by students of secondary education and was presented in the Municipality of Thessaloniki where representative of the local authorities attended. This successful initiative was further developed after the UNESCO Chairholder gathered a group of postgraduate students and PhD Candidates to work on fully fledged version of the guide for the European Citizen's Rights and European Citizenship with special emphasis on the role of the European Parliament. The initiative was welcomed by the Greek Members of the European Parliament and was funded to be published in 10.000 that were distributed in Universities, libraries schools and public places for free all over Greece.

Along with formal education, the UNESCO Chair offers opportunities for non-formal education and specialisation on the fields that are covered by the scope of the organisation. For that reason the Chair has been providing Specialisation Programs to young professionals and students as well an internship program each year since 2004.

The UNESCO Chair-holder, Professor P. Naskou-Perraki, has been invited to teach in English at postgraduate level the module of "UNESCO and Culture" which is part of the MA in Law, Arts and Economy of the International Hellenic University during the academic years 2012-2013 and 2013-2014. For the preparation of the module, all teaching materials and legal instruments on the protection of culture were prepared by the collaborators of the Chair.

2) Activities:

Overview of activities undertaken by the Chair during the reporting period

a) Education/Training/Research

(key education programmes and training delivered and research undertaken by the Chair during the reporting period, target group and geographical coverage)

i) Education (leading to certificate)

-Various courses are taught at the University which aim in human rights education and the promotion of cultural diversity and intercultural dialogue as a means to gain an active/democratic citizenship.

Courses:

-At the Department of International and European Studies the UNESCO Chairholder Prof. P.Naskou-Perraki is teaching the following courses:

Undergraduate Level

- The course which was introducted after the creation of the UNESCO Chair under

the title "Cultural Diplomacy"

- "International Mechanisms protecting Human Rights" (in Greek and English for the Erasmus students)

Postgraduate Level

- "Human Rights and the Rights of the Child" is taught at the Master on European Youth Policies.
- -Moreover, for the academic years 2012-2013 and 2013-2014, the UNESCO Chairholder, Professor P. Naskou-Perraki, has been invited to teach in English at postgraduate level the module of "UNESCO and Culture, the Artist's Rights and Multimedia" which is part of the MA in Law, Arts and Economy of the International Hellenic University.

Specialization programs

-Specialization programs in the form of seminars, on Intercultural Policy and Human Rights were organised by the UNESCO Chair with the collaboration of the University of Macedonia since 2005 until 2012. In these specialized programmes which were formed in lectures on a different issue each year emphasis was given on the importance of intercultural policy and the respect and proliferation of Human Rights. The programme is addressed to teachers of Primary and Secondary Schools to young practitioners of law and university students or graduates from relevant fields. In those programs esteemed academics from different Universities of Greece and PhD holders were called upon to teach. After the completion of the program the participants were obliged to succeed at the exams in order to receive their certificate of attendance. Please find below a detailed list of the topics that were presented within the specialization programs.

7) Academic Year 2010-2011, 29 Hours in Total Topic: International Organizations and Human Rights

8) Academic Year 2012-2013 (winter semester), 20 hours in Total Topic: Right to Education – Intercultural Education

9) Academic Year 2012-2013 (winter semester) , 18 Hours in Total Topic : Protection of Vulnerable Social Groups: Disabled, Refugees, Rom, Women,

10) Academic Year 2012-2013 (spring semester), 18 Hours in Total Topic: Tools for Intercultural Education. Human Rights in School

The programs were greeted by students and young professional who gave positive feedback and expressed their satisfaction for their rich and insightful content, but their participation rate varied from year to year. Many attendees of the specialization programs decided to follow relevant majors on a professional level.

ii) Training (short term)

Since 2004 Training and research at the UNESCO Chair are materializing through internship at UNESCO Chair. Since 2004 an internship program is taking place within the premises of the UNESCO Chair at the University of Macedonia. The

main subject changes each year and offers sophomore students of all Universities of Thessaloniki (namely: University of Macedonia, Aristotle University of Thessaloniki, International Hellenic University) the opportunity to get acquainted with interesting topics through research and essay writing. The main purpose of offering an internship to undergraduate and postgraduate students at the UNESCO Chair is to familiarize senior students with the purposes and the programmes of UNESCO at global and regional level.

Under the supervision of the Chairholder the students are encouraged to deal with different aspects and perspectives of topics that are within the scope and mandate of UNESCO (Intercultural Policy, Education, Culture, Peace, Human Rights, and Cultural Heritage) and international instruments under with which those aspects are further promoted. Though this procedure the UNESCO Chair gives student the opportunity to enhance and expand their research, communication and organisational skills by participating in the Chair's internship.

Topics that the internship has dealt with (only a selection of topics is presented):

- -Intercultural Policy
- -Intercultural Education (in the Balkan Area and in Europe)
- -Cultural and Natural Heritage (Tangible, Intangible, Underwater, in danger)
- -Human Rights (with special focus on Cultural Rights)
- -Peace and International Organisations
- -Racism and Xenophobia
- -Museums and intercultural policy

Participants are selected after filling in an application form within an allotted time (usually a month) in the beginning of each academic year. The application form includes personal information, educational background and there are required to submit a short CV along with a short motivation letter defining the reasons why they wish to be involved in the internship. The term of the internship usually spawns from 6-9 months depending on the academic year.

This year's research and training (2013-2014) is focused on Cultural Rights and Cultural and Natural Heritage.

The internees at the UNESCO Chair are divided into two working groups. The tasks of each Working Group are the following:

The First Working Group, works throughout the academic year on the collection and of International Acts (Conventions, Treaties and Declarations) and the analysis of provisions on Cultural Rights and their protection in international law. The First Working Groups has been responsible to research on the different mechanisms for the protection of human rights both international and regionally and analyze the jurisprudence of judicial organs around the globe dealing with the protection of individuals (European Court of Human rights, Human Rights Committee).

The Second Working Group aims in the presentation of information on the monuments of the World Heritage List. Here the students prepared were called upon to prepare presentations of all monuments in different countries protected by UNESCO.

The entire student's work is being under process, and the UNESCO Chair intends to upload the students work on the website. All names of the internees can been found on the website of the UNESCO Chair : http://afroditi.uom.gr/chaireunesco/

In total more than 250 undergraduate, postgraduate students and PhD candidates have taken part in the internship program from 2004 till 2014.

iii) Research

Research is being conducted in the UNESCO Chair in different fields and aspects of Human Rights and Education. Below there is a list of the topics that have been covered in the 10 year operation of the UNESCO Chair:

- International and Regional Protection of Human Rights (followed by publication, both in Greek and English)
- Right to Education (under publication)

Training and research at the UNESCO Chair are materialised through researchers that are associated with the UNESCO Chair and are offering additionally administrative assistance. So far 6 researchers have been associated with the UNESCO Chair, mostly postgraduate and PhD candidates of relevant fields. Furthermore, the UNESCO Chair organises events in order to stimulate dialogue between various stakeholders, i.e. academics, postgraduate students, PhD students, non-governmental organisations, public bodies, etc, and to encourage research on issues that are troubling the contemporary Greek society.

b) Conferences/Meetings

(key conferences and meetings organized by the Chair or to which its Chairholder contributed)

i) Key conferences and workshops hosted by the Chair

- 17 October 2005 event hosted by the Chair with the topic "Greek art of Gandara and the Greek presence in Afghanistan during ancient times" with the key note speaker Dr. N.Papageorgiou who was then serving as the President of the Hellenic Commission for UNESCO
- **2005** international youth competition for prosaic and poetic writing with the topic: UNESCO the promotion of the universal values through Intercultural policy and Democratic principles"
- 6 May 2006, UNESCO Chair hosted an event with the title "UNESCO: 60 years", with the presence of the Minister of Culture of Greece, Mr. E. Venizelos and the President of the Hellenic Commission for UNESCO. During the event the awards for the international youth competition for prosaic and poetic writing were presented. In parallel in the venue of the University of Macedonia the exhibition of the 60 posters of UNESCO that were sent by the organization as a response to our request. The exhibition was hosted for a certain amount of period in the premises of the University of Macedonia and visited by numerous people each day. Following the exhibition the posters were translated in Greek. The event was followed by a publication with the 60 posters in three languages Greek, English and French.
- 13 November 2006 in collaboration with the Council of Europe and the Organization for the Security and Cooperation in Europe, the UNESCO Chair organized a conference under the title:" The Greek Roma: a long way to recognition". The aim of the conference was to enhance the dialogue concerning the issues that are being brought to the attention of the public by Greek academic and Roma activists.
- 2 May 2008, the UNESCO Chair under the direction and supervision of the Chairholder of the UNESCO Chair, Professor P. Naskou-Perraki organised a Conference to celebrate the 60th Anniversary of the Universal Declaration of Human Rights with guest speakers Mr. David Roosevelt, the grandson of the late President Roosevelt and Elinor Roosevelt, and Dr, Drhc Erika Daes, Expert of the United Nations on Indigenous People and Professor K. Koufa member of the Subcommittee on Human Rights as moderators within the framework of ThessISMUN(Thessaloniki International Student Model United Nations) with the participation of 450 students from all over the world. The event was very successful and extremely celebrated by the Greek mass media.
- 25 June 2010, UNESCO Chair in cooperation with the United Nations Office of the High Commissioner of Refugees organized an event at the Archaeological Museum in Thessaloniki on the day of the World Day of Refugees. At this event pupils who participated in the Panhellenic Contest of School Creativity 2009 on Refugees were awarded. The event was attended by many representatives of the civil society and had a celebratory note.
- 18-19 October 2010, the UNESCO Venice Office in cooperation with the Greek National Commission of UNESCO, the Museum of Byzantine Culture of Thessaloniki, the Archaeological Museum of Thessaloniki, the International Council of Museums and the UNESCO Chair organized, within the context of the Year of Reapproachment of Civilizations, an international conference in Thessaloniki under the title "National History Museums in South-East Europe: Leaning History, Building Shared Activities". The UNESCO Chair was represented at the conference by the UNESCO Chairholder, Professor P. Naskou-Perraki whose contribution was significantly appreciated as she emphasized the need to establish a partnership between the historical museums and the institutions of higher education in order to better facilitate the purposes of intercultural policy. Her contribution will be published on the proceedings of the Conference.
- 9 November 2010, the UNESCO Chair in cooperation with the Direction of Secondary Education of Thessaloniki organised an event on "Human Rights in High-school". The aim of this event was to inform the stakeholders on the work of UNESCO and the protection of human rights. This successful event cemented the establishment of cooperation between UNESCO Chair and the Directorate of Secondary Education in Thessaloniki.
- 27 November 2010, the UNESCO Chair in cooperation with the two UNESCO Chairs of the Aristotle University and the UNESCO Youth Club of Thessaloniki organized an event on the "Activities of UNESCO Chairs in Thessaloniki". The event was honoured by the presence of Ms. Tzitzikosta, President of the Hellenic Commission for UNESCO, who addressed the audience. This event, which attracted many students and people who are interested in promoting the goals of UNESCO, signalled the establishment of the co-operation between the three UNESCO Chairs.
- 11 December 2010, in celebration of the World Day of Human Rights/Rights of the Child and the Year of the Reapproachment of Civilisations, the UNESCO Chair organized an event on "Intercultural Communication". In this event, UNESCO Chair invited the pupils of the Intercultural School of Pylaia in Thessaloniki to sing Christmas carols in various languages. The event was particularly colourful and had a festive character as pupils of the Intercultural School of Pylaia enjoyed singing carols and songs in their mother tongues while students of the University of Macedonia and members of the academic personnel enjoyed this interactive and intercultural experience. Also, fairy tales with elements of their cultures that have been written by the pupils of the Intercultural Schools were presented to the audience. The event presented a significant momentum of

intercultural dialogue.

- 27 January 2011, UNESCO Chair invited a member of the European Parliament, Professor Ch. Paliadeli, to deliver a lecture to postgraduate students, on the "Report on the proposal for a decision of the European Parliament and of the Council establishing a European Union action for the European Heritage Label". Professor Paliadeli has conducted significant work on the modification of the European Heritage label in order to further promote the idea of a common European identity and emphasise the educational value and dimension of the sites which are awarded this label.
- **9 May 2011**, the UNESCO Chair organized an event on "Pictures of the world: Greece and the global art history", whereby Dr. Christina Stephan-Kaissis, delivered a lecture and presented a critical analysis of keydimensions of the issue.
- **28 March 2012**, the Assistant Professor of the University of Western Macedonia, Mr. Stavros Kamaroudis, gave a lecture on "The geopolitics of the Greek language". The lecture took place within the course of the taught module "Cultural Diplomacy" of UNESCO Chair.
- 6 April 2012, Dr. Angelos Chatzinikolaou, teacher at the Intercultural School of Menemeni in Thessaloniki, and Ms. Magka, Representative of the Roma Women of Dendropotamos in Thessaloniki, were invited to speak to the internees of the UNESCO Chair on Roma children and Roma women.
- 21 February 2012, Dr. Angelos Chatzinikolaou, was invited to speak to the internees of the UNESCO Chair on Roma children and any educational issues and difficulties which arise when teaching to Roma children.
- 15th of April 2013, the UNESCO Chair organized a seminar on "The Role of Diplomacy in Inter-religious Relations", whereby UNESCO Chair invited three experts with differential academic background (one greek Ambassador, one Professor of Theology and one Professor of Political Sciences) to present a critical analysis of key-dimensions of the issue.
- 23-24 May 2013, UNESCO Chair for Intercultural Policy organized a conference entitled "Diplomacy in the 21th century" that took place at the University of Macedonia. The conference proceedings were published afterwards under the same title by the Publications of the University of Macedonia.
- 27 November 2013, UNESCO Centre for Women and Peace in the Balkan Countries jointly organized by the General Secretariat for Gender Equality and in cooperation with the UNESCO Chair for Intercultural Policy organized a workshop on Women Entrepreneurship, which included workshop on "Fundamentals marketing and promotion strategies" and took place at the University of Macedonia.
- 29 November 2013, the Hellenic National Commission for UNESCO and the General Directorate of European and International Educational of the Ministry of Education in cooperation with the UNESCO Chair of Intercultural Policy hosted the Meeting of the Associated Schools of UNESCO (ASPnet) of the Eastern, Western and Central Macedonia.
- **-4 December 2013**, UNESCO Chair for Intercultural Policy along with the Hellenic National Commission for UNESCO and the UNESCO Center for Women and Peace in the Balkan Countries organized an event on the occasion of celebrating 150 years since the birth of Konstantinos Kavafis (Anniversary year UNESCO 2013) that took place at the University of Macedonia.
- **-18 March 2014**, UNESCO Chair for Intercultural Policy along with the UNESCO Youth Club of Thessaloniki on the occasion of celebrating 10 years of their foundation organized an event entitled "Cultural Rights Monuments of World Cultural Heritage" that took place at the University of Macedonia. During the event the best essays from the internees of the academic year 2013-2014 were presented.
- -9 May 2014, UNESCO Chair for Intercultural Policy along with the Institute for Psychology and Health organised an event with the title: "Me and the other: Live testimonies of "different" students within the educational system" which took place at the University of Macedonia.
- -2014 , the UNESCO Chair of Intercultural Policy and the Hellenic College of Thessaloniki under the auspices of the Hellenic Commission and the Ministry of Education organise an Essay and Poetry Competition has been planned for students of primary and secondary education that is still open for submission and will be finalised on October 2014 with an event in which the awards will be presented. The topics on which the students are called to write their essay or poem are the following:
- 1. Prohibition of discrimination
- 2. Right to education
- 3. Prohibition of violence, negligence and exploitation

- 4. Right to leisure and entertainment
- -15 May 2014, the UNESCO Chair in collaboration with the Hellenic College of Thessaloniki, the UNESCO Youth Club of Thessalloniki and the Archaeological Museum of Thessalloniki organised an event/institutional visit under the title "Technology in the service of Art". During the visit the Director of the Museum demonstrated the new and innovative digital technologies of the museum while the young students of the Hellenic College presented their project on the Monuments of Cultural Heritage of Thessaloniki.

ii) Other conferences/organizational activities undertaken by the Chairholder

- **-30 June 3 July 2008**, Professor P. Naskou-Perraki was appointed by the National Committee on Human Rights as a representative of the aforementioned Committee at the 3rd World Forum on Human Rights held in Nantes, France.
- -March 2009, Professor P. Naskou-Perraki was invited to teach «International Protection of Human Rights» at the Faculty of Law in Capital University of Columbus, USA.
- October 2009, Professor P. Naskou-Perraki participated as member of the Greek delegation at the 35th General Conference of UNESCO in Paris. During her visit Prof. Perraki had meetings with Mr. G. Haddad, Mrs. A. Stenou, Mrs. C. Pinan and with the members of the permanent representation of Greece at UNESCO.
- 27 April 2010, Ms. Aikaterini Stenou, Director of Cultural Policies and Intercultural Dialogue, was invited by UNESCO Chair to deliver a speech on "The new international cultural order". The event was attended by Ms. Tzitzikosta and the representatives of associated Schools with UNESCO in Thessaloniki. Ms. Stenou's expertise in cultural policies and intercultural dialogue stimulated a vibrant discussion between her and the attendees. Ms. Stenou, accompanied by the President of the Greek National Commission of UNESCO, Ms. Tzitzikosta, and Professor P. Naskou-Perraki visited one of the intercultural schools in Thessaloniki and had the pleasure of discussing with the teachers and pupils therein.
- 1st March 2012, the UNESCO Chair honoured Mr. Thomas Gerasimidis, Doctor, for his invaluable contribution to the achievement of the UNESCO's aims through his work, as a prominent science.
- 13th November 2012, the UNESCO Chair honoured Mrs. Polixeni Adam-Veleni, Director of the Archeological Museum of Thessaloniki, for her contribution to the promotion and dissemination of greek culture.
- **24 March 2013**, the UNESCO Chair honoured Dr. Mr. Anastassopoulos, for his invaluable contribution to the achievement of the UNESCO's aims through his work.
- 7 April 2014, the UNESCO Chair honoured Mrs Aikaterini Tzitzikosta, President of the Hellenic Commission for UNESCO and the UNESCO Center for Women and Peace in the Balkans for her invaluable contribution to the proliferation of the ideas and the goals of the organisation.





- Since 2002 the Annual Thessaloniki International Student Model United Nations (ThessISMUN) is organised at the University of Macedonia under the academic supervision of Professor P. Naskou-Perraki. ThessISMUN is a simulation of International Organisations such as the United Nations principal organs (General Assembly, ECOSOC, and International Court of Justice) and NATO's North Atlantic Council as well as regional Organisations such as the Council of Europe and gathers students from Greek Universities and from all over the world, willing to demonstrate their diplomatic skills. ThessISMUN is the only Model UN organised in Greece and has supported throughout the years the establishment of other UN Models in neighbouring countries, as well Regional Models in other parts of Greece. ThessISMUN gathers undergraduate and graduate students from around the world for a 5day youth summit to simulate discussions of different bodies of UN and regional organisations by assuming the roles of ambassadors. ThessISMUN offers students educational experience and is an effective educational tool showing the complexities of the world, how international community deals with economic and environmental concerns, human rights violations, disarmament and political conflicts and other global issues. The educational value of ThessISMUN is further enhanced by the fact that it presents a multicultural and multinational forum where students can enhance their communication, negotiation and deliberation skills, learn about other countries, promote democracy, explore conflict resolution alternatives. ThessISMUN has managed to be considered as one of the best conferences around Europe, since 2004 more than 400 delegates, honour us with their presence each year at the University of Macedonia for such a unique experience. Each year the conference is dedicated to a Greek personality that has contributed to the work of International and Regional Organisations.
- Next year's conference (ThessISMUN 2015) will include a simulation of the Executive Board of UNESCO.
- -The UNESCO Chair supports along with the UNESCO Youth Club the nomination of Thessaloniki as a European Youth Capital 2014.
- -Moreover, the UNESCO Chair is actively supporting the Culture of Peace and Non-violence UNESCO Contest (http://www.unesco-hellas.gr/gr/news_display.aspx?id=224) by encouraging pupils and students to participate therein. The Director of UNESCO Chair, Professor P. Naskou-Perraki, has been appointed as a consultant for the above contest by the Ministry of Education.

- Collaboration with NGOs on the integration of vulnerable social groups into the labor market
- Awareness raising programs of educators and students on issues concerning racism and non-discrimination
- Concluding the Essay and Poem Competition which was launched in mid 2014 along with the Hellenic College of Thessaloniki, under the auspices of the Ministry of Education and the Hellenic Commission for UNESCO
- Cooperation with relevant UNESCO Chairs in Europe and in the Balkan peninsula on intercultural education and policy
- Continue the honorary ceremonies of esteemed personalities that have contributed a lot to culture since they have attracted and succeeded the engagement of the civil society
- Extend the cooperation with the ASP net Associated Schools
- Translate our site into the English language
- Conduct a number of conferences and seminars especially on issues concerning:
 - o Racism and Xenophobia during the economic crisis
 - o Problems concerning the integration of immigrants
 - o The impact of intercultural education to public schools
 - Public awareness raising on an active citizenship
