SECTION II

I believe in our system of justice and I care deeply about Seattle Municipal Court (SMC). I love serving as a Judge Pro-Tem and would like to bring my set of skills to the court in a full time capacity.

We need judges who are willing to step forward and bring improvements to the court system. The following are just some of the types of changes I would like to implement: 1) reduce the amount of paper used by the court and try to implement an electronic system similar to the system used in King County; 2) reduce court costs by improving technology in the courtroom. Many courts use video conferencing for minor hearings. I would work to change court rules as necessary to allow for interpreter matters to be held via video conferencing. Police officers often spend hours in court waiting to testify. I would investigate the possibility of allowing police officers to testify without coming to court, which would cut down on the amount of overtime the officers are paid and would increase trial efficiency.; 3) link the information systems used by the various courts in the state. Currently, SMC uses a propriety technology (Municipal Court Information System or MCIS), while almost every other court uses the Judicial Information System (JIS). An accurate flow of information would help all courts.; 4) increasing the stipend that jurors are paid for their service. The current amount of \$10 a day is ridiculously out of date and creates a hardship for many of the citizens called to jury duty.; 5) renegotiate the terms of Electric Home Monitoring (EHM) contracts. EHM provides a much needed alternative to confinement, yet the cost to defendants in SMC to enroll in this alternative is much higher than in other jurisdictions.

My background as a small business owner, a director of a private company, general counsel to an international telecommunications firm, an attorney in private practice, an assistant city attorney, a community volunteer and finally as a Judge Pro-tem for approximately 16 years will help me implement these changes.

Finally, we need judges who are fair, ethical, and energetic. I have earned a reputation as being fair and well-reasoned and I believe I treat everyone who appears before me with respect regardless of their background, what they look like or what their sexual preference is. I have the leadership, fiscal responsibility and administrative skills to make a difference in SMC and will work intelligently and diligently for the citizens of Seattle.

2. Describe your most important personal characteristics or traits as they relate to the office you seek.

It is important that every party before the court have a fair and impartial hearing. I listen closely to each party and treat everyone with respect. I make sure that each party – especially the defendant – understands what we are doing and that he or she has an opportunity to be heard or ask questions, if appropriate. I believe that a judge should never stop learning and should always be prepared. I work diligently to be prepared for each case or type of hearing before me. A judge should maintain a professional demeanor and be highly ethical. A judge needs to be cognizant of public expectations but should never allow those expectations to interfere with the essential rights of individual liberty. A judge needs to balance the needs of rehabilitation and public safety and be willing to impose an appropriate sentence while paying attention to public resources. It is also really important to maintain a sense of humor. I believe I possess all of these skills and attributes and that I have demonstrated this in court.

- 3. Please describe, in sufficient detail, one to three accomplishments or contributions of which you are most proud. These examples should illustrate skills and capabilities you think apply to the office you are seeking. These accomplishments may have occurred at any time in your personal, professional, or public life.
 - 1. In 1994, I presided over a three week jury trial in Seattle Municipal Court in which the president of a Ballard oil company was convicted of creating a fire hazard in violation of the Seattle Municipal Code. This case was unusual, not only for the length of the trial, but also because this may have been the first time that anyone had been tried criminally for failing to install an automatic fire-control device. This was essentially a civil case in a court that hears almost exclusively criminal misdemeanor and gross misdemeanor charges. I was required to make rulings on expert testimony and over 200 exhibits. As part of the sentencing, the defendant was required to get in compliance with the Fire Code. The estimates for doing so ranged between \$30,000 and \$60,000. Despite the high cost of compliance, the case was not appealed; the defense attorneys told the defendant that there were no appealable issues. This was the longest and most complex case that I have been involved in as a neutral decision maker.
 - 2. I also presided over a case in which five advocates for the homeless were tried for criminal trespass. Three of the defendants were represented by counsel and two were pro-se. While the legal matter was not terribly complex, the case was a test of my ability to maintain control and decorum in the courtroom and ensure that each of the five defendants left the court feeling that they had received a fair trial.
 - 3. In 1988, one of the partners in my firm turned a sexual discrimination suit that he had been working on over to me. The claim that he was trying to pursue was that the client had been wrongfully fired because of her pregnancy. After researching the law and the facts of her case, I determined that she did not have a claim after all, and it was left to me to contradict my boss's assurances that she did. I could have gone ahead and filed the suit because she was willing to pay me. In my opinion, that would have been unethical and dishonest and I was unwilling to engage in that type of practice.

- 5. Please describe the duties of the office you seek. Which are the most important duties and why?

A judge in Seattle Municipal Court hears arraignments, pre-trial hearings, motions, trials, probation revocation matters and other sentencing and post sentencing hearings in criminal misdemeanor and gross misdemeanor cases. A judge may also hear traffic mitigation, contested traffic hearings and occasionally, civil code infractions. Trials may be either bench trials or jury trials.

It is important for a judge to apply the law, be fair and impartial and treat each party respectfully, allowing them to be heard and making sure that they understand the court's ruling. Every judge has a duty to promote access to the justice system.
