# Town of Winhall Selectboard Bondville, Vermont 05340 Meeting Minutes for Wednesday, May 6, 2009

### **ALSO IN ATTENDANCE:**

### **CALL TO ORDER:**

Glabach called the meeting to order at 6:02 PM at the former Bernache building, Route 30, Vermont.

#### **POLICE/FIRE/RESCUE REPORT:**

- 1) Whitesell submitted the police activity report for the month of April including traffic tickets and warnings, false alarms, animal control problems and law incidents outside of Winhall and Stratton. Whitesell reported he had increased police presence in the Village of Bondville. He also reported he had written a letter to the US Department of Justice for a COPS grant. Peter Welch, US Congress, had finally replied in support of the Winhall Police Department's efforts for a grant for a community outreach program including a neighborhood watch program for Winhall. Whitesell and the Selectboard discussed the new police cruiser and how it was performing. Whitesell submitted the discussed changes to the Security Agreement between Winhall and Stratton Corporation.
- 2) Whitesell reported that at the request of the owner(s) of the Three Peaks Inn, he and Marcel Gisquet (WPC) had reviewed the Three Peaks Inn parking lot for a proposed farmers market including traffic circulation, vendors parking, egress and ingress, and public parking and circulation; the Selectboard wanted to make sure the neighbors supported the idea as well.

# **TOWN HEALTH OFFICER REPORT:**

### **HIGHWAYS & ROADS REPORT:**

1) Next the Selectboard opened the three (3) bids re: purchase of a front end loader for the Town of Winhall. Discussion followed with Randy Kimball.

Nortrax quoted a John Deere at \$100,750.00; Hazelton quoted a Komatsu at \$89,000.00; Milton Cat quoted a Caterpillar at \$85,221.00. Randy recommended to the Board that the Komatsu would serve the Town best. The Board authorized Randy to clarify Hazelton's quote of the Komatsu and broom. If the clarification is satisfactory the Board moves the purchase of the Komatsu. Bob Oakes moved, Bill Schwartz seconded; unanimous all in favor.

The Town Treasurer had stated there was \$85,000 available in the equipment fund. Kimball would like to take possession after July 1, 2009. He will discuss with the Treasurer when the best time for full payment would be for the Town.

### TRANSFER STATION REPORT:

Kimball and the Selectboard discussed purchase of a new compactor for the Transfer Station; they also discussed recycling issues. The Selectboard reviewed the Solid Waste Agreement with Casella. Oakes reported there was a huge group of volunteers for Green Up Day.

- 2) The Town Administrator reported he had reviewed the procedures for collection of individual personal information i.e. driver's license, social security numbers, mother's birth name, and individual's date of birth. He reported he had conducted this assessment of Winhall's practices for collection and protection of individual personal information and concluded that the Town of Winhall met all reasonable tests for the protection of individual personal information, and because the Town of Winhall extended no credit for services was not subject to the Federal Trade Commission (FTC) Identity Theft Red Flag Rules.
