HORSES

Entry fee does not include horse rental. Horses will be available to rent by the brace for the handlers, scouts and gallery. Horses rented by the brace must be returned after each brace unless prior arrangements have been made with the wrangler. Priority will be given to the club and to handlers. All rental fees are to be paid directly to the Wrangler. Cash is preferred.

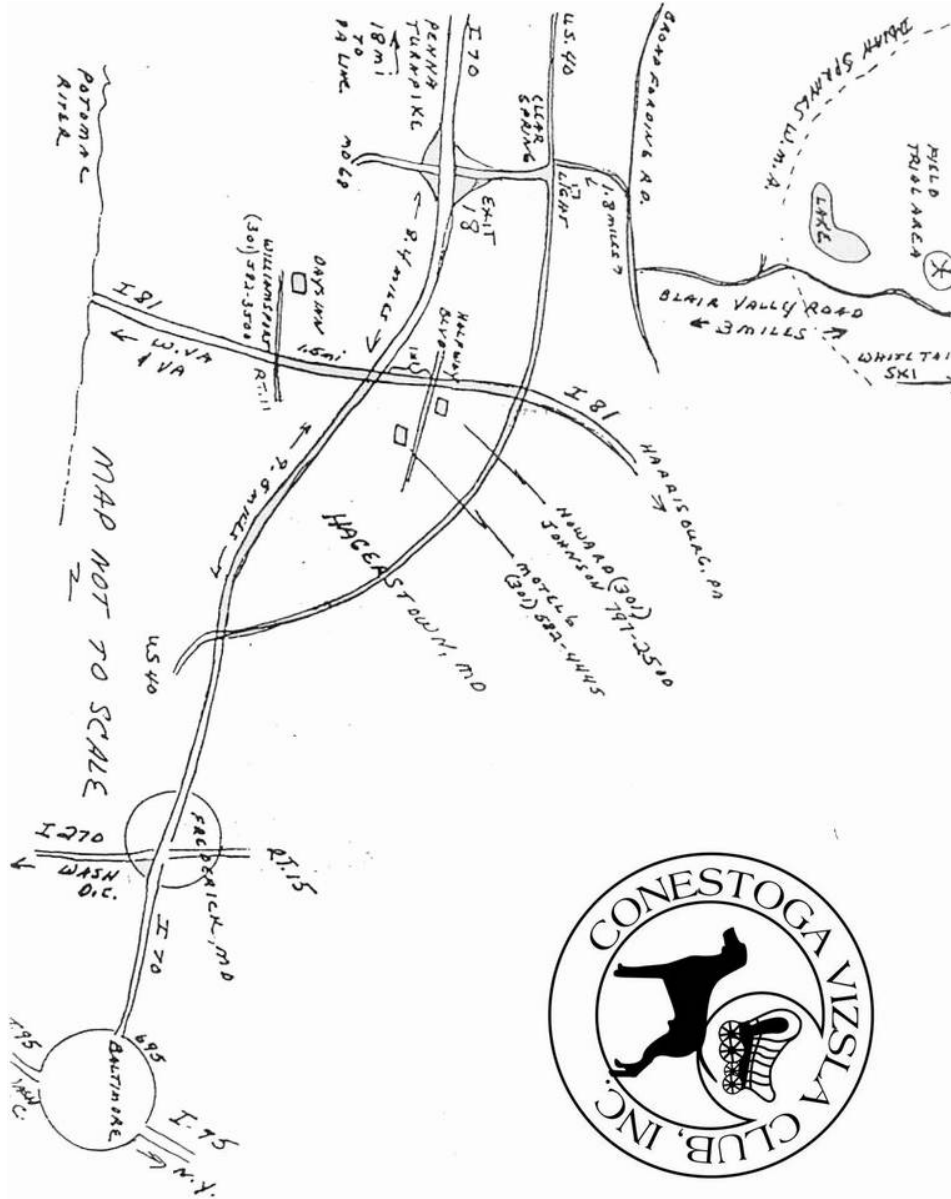

DIRECTIONS

From the I-81/I-70 Interchange: From Hagerstown, MD take 70 West to the Clear Spring Exit (8.4 miles from the I-81/I-70 Interchange); Go North on MD 68 (at traffic light the road jogs slightly to the left); Continue through the light. Follow the brown sign for Indian Springs Ski Area. Follow the veer to the right to Broadfording Road. Take the first left on Blair Valley Road. Go three miles; drive past several farms and houses; Pass the lake and barn on left. Look for CVC directional sign. Turn left on gravel road into the trial grounds. Follow path to pavilion and parking area on left.

Dogs which first qualify at this trial will not be permitted to enter the Limited Stakes. *The Hunting Dog Championship is a non-regular stake where dogs are judged on Gun Dog Standards EXCEPT the dog need only be steady until the handler flushes the bird. Retrieving is a requirement. Only AKC approved tracking collars permitted.

COURSES AND BIRDS

All stakes are non-retrieving, single course without bird field except Open Limited Gun Dog, Amateur Limited Gun Dog, and Hunting Dog Championship stakes - which are retrieving stakes on a single course with birds shot in designated area on course. Quail, Pheasant and/or Chukar, native and/or released, may be used on course for all stakes. Shooting to be done by Official Gunners only. A blank pistol will be fired in the Open Puppy and the Amateur Walking Puppy Stakes. Horseback handling is permitted in all stakes except Amateur Walking Puppy, Amateur Walking Derby, and Hunting Dog Championship.
