On the back is a description of each major component that makes up your dues amounts.

MCA Limited Dues

- This fee is mandated by MCA. It covers the cost of maintaining the limited property which includes the clubhouse, the swimming pools, MacVicar Blvd & MacVicar Park.
- The majority of the increases are attributable to energy costs, landscape maintenance and building reserves.

MCA Common Dues

- This fee is mandated by MCA. It covers the cost of maintaining the common property which includes the office, Meadowcrest Park, and Meeting Tree and Meadowcrest Blvds.
- The majority of the increases are attributable to landscape and irrigation maintenance.

MCA Village Security

• This fee is mandated by MCA. It covers the cost of our sheriff's patrols

MCA Village Cable

• This fee is mandated by MCA. It covers the cost our cable contract

HVPOA Operating Expense

 This pays for the operation of our village. It covers the costs of postage, office supplies, insurance, landscape maintenance and social activities.

HVPOA Road Reserves

 This is money set aside for future paving of our roads and replacement of our landscaping.

HVPOA Trash Pickup

• This covers the cost of our Waste Management contract.
