WOCN is pleased to announce that we will enable **15 OVW grantees** to join 10 non-OVW grantees in attendance at the Women of Color Network Economic Policy and Leadership Southern Regional Forum. This training is free to recipients of OVW Grants, including CSSP, Grants to Encourage Arrests, STOP, Campus, Rural, Sexual Assault, and Tribal Grantees. Registration is limited to 15 OVW grantees and **registrants will be responsible for covering all related expenses**, such as travel, meals, and overnight accommodations. **You may use your OVW training and travel funds to cover all related travel expenses**.

Completing this application form does not guarantee a space at the Regional Forum. Selection of the 15 OVW-funded grantees will be based on order of application forms received and these criteria:

- 1) The 15 advocates must work at an organization based in AL, AR, FL, GA, KY, LA, MS, NC, OK, SC, TN, TX, VA, or WV that is currently receiving funds from OVW;
- 2) Selections may be made to ensure regional and community diversity;
- 3) Priority will be given to diverse advocates seeking to organize an ongoing services and policy response including through sustaining engagement with WOCN's policy development in economic security; and,
- 4) Priority will be given to advocates of color seeking to develop and enhance their leadership skills and impact in economic security for survivors of violence.

We know many advocates work on economic justice on a daily basis given this work is vital for survivors and communities of color who face economic barriers and duress. To attend, advocates' job titles do not need to include economic security nor do applicants' organizations need to focus solely on economic and/or social justice. We will, though, prioritize applicants who see their work as strongly rooted in and aligned with the economic security objectives and content of the Regional Forum.
