Grading

- b. <u>10% SAE</u> (Supervised Agricultural Experience)
 - i. Project Plan, Record Books, Skills learned, Goals Achieved, Hours worked, money invested.
 - ii. PLEASE NOTE: All students regardless of FFA membership, are required to have a Supervised Agriculture Experience Project. This consists of students working on an Agriculture project that is supervised by adults/parents and relating to agriculture. Most students already have a project and will simply keep records on it.

Ex: Growing a garden, owning/working for a lawn care company, raising and selling animals, working at the feed store, working in a floral shop, job shadowing a veterinarian, volunteering at Animal Shelter, volunteering at the senior citizens or for community development. Every student will have one in place by 1st Trimester Midterm.

c. 10% FFA:

- i. FFA is a student leadership organization based around agriculture. Students enrolled in agriculture courses are the only students who have the opportunity to be involved in FFA. FFA makes a positive difference in the lives of students by developing their potential for premier leadership, personal growth and career success through agricultural education.
