It is understood that the Owner, reserves the right to reject any or all proposals, or part thereof, or items therein and to waive technicalities required for the best interest of the Owner. It is further understood that competency and responsibility of Bidders will receive consideration before the award of the Contract. If requested by the Owner, a certified copy of the Contractor's Qualification Statement, AIA Document A-305 will be submitted within five [5] days of receipt of Bids by the Owner. Bidder agrees to a willingness to show the Owner information to clarify scope and completeness of the submitted bid, if an interview is requested by the Owner.

Bidder submits this Proposal with the understanding that the work shall be substantially completed on or before the time frame[s] indicated below, after notification by the Owner to proceed, in accordance with the Project Schedule submitted with this Bid; and, that time for completion of the work shall be considered as of the essence of this Contract.

The selected Contractor shall prepare a Contract utilizing AIA Document **A101, STANDARD FORM OF AGREEMENT BETWEEN OWNER AND CONTRACTOR** where the Basis of Payment is a STIPULATED SUM- Latest Edition, for the Owner's signature within three [3] days of being notified of selection.

If the Contractor desires alterations to the Contract or to the affiliated AIA Document A201, GENERAL CONDITIONS OF THE CONTRACT FOR CONSTRUCTION, a copy of those changes shall be made part of the Bid submission. Otherwise, the submission of this Bid shall be based upon no alterations or supplemental conditions to the aforementioned contract documents.
