

**AN ORDINANCE AMENDING THE OFFICIAL ZONING ORDINANCE OF  
CITY OF CLINTON, MISSISSIPPI AS IT RELATES TO OUTDOOR ADVERTISING SIGNS**

**WHEREAS**, a public hearing, pursuant to Section 3006.05 of the Zoning Ordinance of City of Clinton, Mississippi, was set for the 26th day of April 2016, at 6:30 o'clock P.M.; and,

**WHEREAS**, City of Clinton did cause notice of said hearing to be published in the Clarion-Ledger, a newspaper published in Hinds County, Mississippi, in the manner and for the time required by law; and,

**WHEREAS**, at the time, date and place specified in the Notice, the City of Clinton Planning Commission did conduct a full and complete hearing, and thereafter, did forward their recommendation for approval to the City of Clinton Mayor and Board of Aldermen; and

**BE IT ORDAINED** by the Mayor and Board of Aldermen of City of Clinton, Mississippi that the Official Zoning Ordinance of City of Clinton be amended as follows:

AMENDMENT TO ZONING ORDINANCE

The City of Clinton Zoning Ordinance is hereby amended as follows:

Section 2703.12           Delete

Section 2705.02           Delete

Section 2708.02(10)     Add: Except where allowed in Section 2724

Section 2708.02(11)     Delete

Section 2724.01           Add: 8. Outdoor Advertising Signs (Billboards) as prescribed in Section 2724.05.

Section 2724            Add: 2724.05 Outdoor Advertising Signs (Billboards). Outdoor Advertising Signs may be approved by conditional use in C-2 zoned areas located between Woodchase Park Drive and Highway 80 on Springridge Rd, Woodchase Park Dr, Hampstead Blvd and in all C-3 zoned areas. Such signs are subject to the following restrictions:

1. The maximum square footage for each face shall not exceed two hundred sixty (260) square feet per face.
2. Outdoor advertising signs shall be limited to two (2) faces, except signs located on federal, state, county or city owned properties.
3. There shall be no other billboard sign within one (1) mile on the same street as such sign.
4. No such sign on Springridge Rd shall be located within five hundred (500) feet of Highway 80 right-of-way.
5. The height of outdoor advertising signs may not exceed forty (40) feet from the base of sign.
6. Outdoor advertising signs shall have a brick, stone, EIFS or stucco base. The sign face shall be no further than six (6) inches from the base.
7. Outdoor advertising signs must be set back a minimum of fifteen (15) feet from street right-of-way.
8. Outdoor advertising signs must be digital.

This Ordinance shall be effective on the 3rd day of June, 2016.
