Sample Letter to Notify Tenants of Smoke-Free Building Policy

Dear Residents,

Exposure to secondhand smoke causes many health problems and increases the risk of house fires. In order to provide you and your guests with a healthier environment, our building will become 100% smoke-free. As leases are renewed, we will phase-in a smoke-free policy.

Hazards of Secondhand Smoke

There is no safe level of exposure to secondhand smoke. Secondhand smoke is a serious health hazard. It causes approximately 50,000 deaths each year. Secondhand smoke is especially dangerous to children and the elderly. It is linked to asthma, ear infections, and Sudden Infant Death Syndrome.

Fire Risk

Smoking causes the most fire death in the United States. In 2010, 610 people died in house fires caused by smoking-related materials. Fires caused by smoking are costly, deadly, and leave many people with damaged property and no place to live.

Ventilation

Studies on airflow have shown that secondhand smoke travels from unit to unit. Smoke can seep through electrical outlets, heating and duct work, and structural gaps. Smoke-free policies are the only way to stop the spread of secondhand smoke.

New Smoke-Free Policy

Beginning <u>[date for new tenants]</u>, new tenants must sign a smoke-free lease addendum that explains the policy. Current tenants must sign a smoke-free lease addendum when renewing their lease.
