## Deposit Information

Along with this form, a non-refundable registration fee of \$300 per traveler is due by July 1, 2015. This fee will hold your spot and will be included in your total fare. **Trip balance is due in full, no later than August 1, 2015. Effective August 1, 2015 the airfare portion of the tour cost becomes non-refundable and non-transferable.**

Obtaining or updating a passport is your responsibility. Passports must be valid through March 31, 2016.

Everyone must fill out and obtain a Visa to enter China through the Chamber, the cost being \$165 per passport. Your passport and payment are due to the Chamber by August 1, 2015 to receive your Visa. There is a one time tip of US\$39 per traveler which you will give to the tour guide in China. You are requested to bring this amount in US cash dollars.

We recommend that you attend one of the invaluable pre-tour briefings offered by the McMinnville Chamber to answer your questions and familiarize you with details of the trip. If interested in attending a meeting before signing up please contact the chamber at the number below.
