President's Message

Team Continental has updated the executive board on the status of Oregon Raceway Park's SCCA track certification process. Track certification by a recognized governing body is a requirement before an ICSCC championship race can be approved. It had been originally hoped that the certification of the ORP facility would have been completed by our first ICSCC championship race held at Portland. Unfortunately the certification is not yet complete, which was not unexpected due to the winter weather. ORP has had its initial inspection and is in the process of complying with the recommendations. There appear to be no items that should prevent ORP from obtaining certification before Team Continental's Oct 10/11 race weekend. ORP and TC are working hard to bring this track on line in time for the Oct race date and we are confident in their abilities. Because of this the TC/ORP race date will remain on the ICSCC 2009 Championship Calendar. Due to the lack certification at present, the race however must retain its 'tentative' status.

TC has requested only one weekend for the 2009 championship and with certification of this track; this year's ICSCC championship will consist of 13 races over 11 race weekends. With five member clubs operating on five different racetracks, widely spread through out the Pacific Northwest, I am anticipating a lively discussion at the fall meeting when the topic of scheduling for 2010 occurs. Our member clubs are customers of the "for profit" racetrack operators and subject to many scheduling issues outside ICSCC jurisdiction. We should get the discussion going early within our clubs. Each club accepts a financial risk when staging their events and so must balance their costs against their projected revenue stream. The nucleus of this revenue is our licensed drivers and we must continue to grow this group by bringing new drivers through our driver training and licensing programs. A large group of visiting drivers, primarily CACC and SCCA license holders, are also part of the revenue stream and we should continue to solicit their participation and encourage them to license with us. Many clubs are also staging special events on their race weekends, both adding to their revenue and introducing new people to ICSCC. I encourage all the clubs to continue to grow their territory and bring new people from the community to their tracks. It is much easier to encourage new people to participate at your track if they are local. This is especially true for the volunteers, who are so essential to staging the events.

Some discussion points for consideration

- Who should determine how many race events are scheduled, how many member clubs ICSCC can support, and how many racetracks are acceptable? Are these decisions an ICSCC governing body should decide, or decisions each ICSCC member makes through their participation?
- Does the present championship structure help or hinder driver participation at all championship events? Should the goal of the championship be to determine the best ICSCC racer in each class or to equalize the competition between tracks?

ICSCC is an organization of motorsport clubs putting on some of the best amateur road racing in the area. We are facing some issues brought about by our growth and our success. Ensuring the health of all our clubs will continue our success.

Crossing the Canada / US border to race?

New U.S. Passport Requirements Valid June 1, 2009

Beginning June 1, U.S. citizens traveling by land or sea will be required to have a passport, passport card or other travel document approved by the Department of Homeland Security for entry back into the United States. Travelers were previously able to re-enter the U.S. by land or sea with a government-issued I.D. and proof of citizenship, such as a driver's license and birth certificate.

Canadian citizens travelling to the US are required to show one of:

- a passport
- a NEXUS card
- a Free and Secure Trade (FAST) card
- an enhanced driver's licence (EDL) or enhanced identification card (EIC) from a province where a U.S.-approved EDL/EIC program has been implemented; or
- a Secure Certificate of Indian Status (when available and approved by the United States)
- Canadian citizens 15 years of age or under will only require proof of Canadian citizenship, such
 as an original or a photocopy of a birth certificate, or a citizenship card.



I.R.D.C. EVENT SUPPLEMENTAL REGULATIONS 2009



- 1. Open to cars eligible under I.C.S.C.C. and S.C.C.A. current regulations.
- 2. There will be no starting of any race engines prior to 9:00 a.m.
- 3. No class changes after 1:00 p.m. on Saturday.
- 4. Drivers are responsible for properly and completely filling out their entry registration form(s).
- 5. Multiple Entries: A driver entering the same car in more than one event shall indicate on each entry form whether the entry is for the driver's "primary" or "additional" event. If the entries are oversubscribed for a particular event (entries exceed the number of cars allowed on the track) drivers and cars entered as an "additional" event will be restricted from participating, on a first come, first served priority based on the date the entries are received, in order to allow participation by all drivers and cars for whom the event is their primary event including novices upgrading to a championship event on that week-end.
- 6. Consumption of alcoholic beverages is <u>NOT</u> allowed at any time during the racing event, except in the area covered by the liquor permit issued by the Washington State Liquor Control Board. The time and location is a condition of operation of the track and is enforced by track officials, ICSCC, and IRDC officials or law enforcement authorities.
- 7. All Entrants shall present at tech inspection empty, seal-able, container(s) marked with driver's name and car number, capable of holding 2 gallons of liquids. These are to be used to remove all oil, cleaners, brake fluid, etc. from P.R. Anyone caught dumping oil at the raceway will be fined and banned from Pacific Raceway. There will be a \$10.00 per tire charge imposed by the track for the disposal of tires.
- 8. Damage to the track, grounds or buildings, regardless of cause, will be charged to the driver responsible. Any damage to any equipment or devices utilized by the sanctioning body (ICSCC) or sponsoring club (IRDC) to conduct this race, regardless of cause, will be charged to the driver responsible.
- 9. NOISE RULE I.C.S.C.C. 1112 enforced! 103db @ 50 ft. No exceptions.
- 10. All persons in pre-grid or in racing hot pits shall wear long pants, shirts that cover their shoulders and no open-toed shoes during all practices, qualifying and races.
- 11. A Minor Release form is required for <u>ALL</u> minors upon entry to the track (NO EXCEPTIONS). Minors must be under direct supervision of an adult at all times. No minors under 18 years of age are allowed in the hot pits or pregrid. Operation of any type of wheeled transportation (bikes, scooters, motorcycles, skateboards, skates, etc.) is forbidden for anyone under the age of 16 years. A speed limit of 5 mph will be enforced in the paddock.
- 12. All cars will be off trailers for tech inspection.
- 13. There will be no refunds on prepaid pit passes.
- 14. Driver must appear in person at registration to add a crew-member to the list on their registration form.
- 15. All participants are required to have and display at all times the appropriate pit, crew, guest, or worker pass issued for this event. Passes are required for reentry to Pacific Raceway during this event.
- 16. No overnight camping at the track on Sunday night without the consent of P.R. management.
- 17. There will be no refueling in the grid area unless accompanied by a fire extinguisher and operator.
- 18. No motorized tow or support vehicles allowed on pre-grid unless authorized by the Grid Marshall or Race Chairman. Support vehicles behind pre-grid must be parked along the fence
- 19. No open fires are allowed in the paddock, pre-grid or within the track in-field.
- 20. All gates are locked at 11:00 PM Friday and Saturday nights. The main gate will open at 7:00 AM.
- 21. Only one support vehicle or trailer is allowed in the pits per competition car.
- 22. There will be no saving of pit or paddock areas except as required by I.C.S.C.C. regulations with exception of Novice License director or by Race Chairman for cause. All other pit and paddock areas are on a first come, first served basis. Violators of this regulation can be subject to disqualification.
- 23. The length of scheduled events may be altered by the Race Chairman due to emergency conditions beyond the control of I.R.D.C. personnel.
- 24. I.R.D.C. reserves the right to refuse entry to this event to anyone.
- 25. Line formation to enter the track on Friday afternoon shall start at the main registration booth. The waiver sheet must be signed prior to entry into the pits on Friday.
- 26. No bicycles, scooters, or walking allowed on the access road adjacent to the main straight from the paddock to pregrid. This is a P.R. rule.
- 27. Pets must be leashed at all times and owners are responsible for cleaning up animal waste.
- 28. All in-car timing system transmitter beacons will be placed at a marked location as defined by the Race Chairman. All transmitters outside of the specified area will be confiscated and retained by the Race Chairman.
- 29. Turn 1 / Pit Out blend line violators will be dealt with by the Race Steward.
- 30. The "5- Minute Warning" will be given 9 minutes prior to the start of the race to accommodate the average 4- minute pace lap.
- 31. If you use the escape road at 3A you will be held at the stop sign for a minimum of 10 seconds prior to re-entry under the direction of the worker at turn station 4.
- 32. All request for split or staggered starts must be made to the Race Chairman & Race Stewart before the end of the events on the day prior to the race.

Steward's Goapbox

Where do Results Come From?

Next to "Who cuts your hair?" and "Where can I get really snazzy pants like yours?", the question I'm most commonly asked at the track is: "Are results from my group available yet?"

I'd like to explain how race results are collected, checked, and published so that drivers have some insight into the process. This process is partially undocumented, but most of it is mandated by the Policies and Procedures manual and the Competition Regulations. It's important that drivers understand how the results are put together so that they know the rules surrounding challenges, questions about the results correctness, and the deadlines for making changes.

During a race, cars pass over an antenna buried in the track. If the transponder is working, it sends a radio signal which hits that antenna, which triggers a receiver, which tells a computer that a particular transponder number passed the antenna at what time. The timing signal is recorded down to the thousandth of a second, and the computer figures out which car in this session is associated with that transponder signal.

Incorrect information or incomplete information given to the registrar will result in mistakes in the results. Not having your transponder in the car during the practice sessions will not verify the information given to T&S. Wrong numbers on the car during practice or qualifying gives bad results. Remember: garbage in; garbage out. Make sure your registered class is correct.

At Timing and Scoring, volunteer workers collect the results and produce several copies of the standings: lap tables which show drivers their times lap-by-lap for each session; qualifying sheets sorted by class and best time over two days so the drivers can see their qualifying positions in class; and grid sheets which sort the best two-day time over the whole field so that the volunteers in grid know how to arrange the cars for the race start (P&P 16.9.1.1.7).

When the race starts, Timing and Scoring starts their computer again to record the crossings over the antenna to score the race. They wait for a mark from the start/finish stand so they know exactly when the 30-minute race duration started. This time, the results are tallied and sorted by class so we can see the fastest lap in the race and the total number of laps completed in the allotted 30 minute time - or a longer duration, if we're running a special race group.

At the completion of the race, provisional results are posted at Drivers' Services. Once posted, they go final 30 minutes afterwards. One the results are final, trophies are awarded, and drivers are on their way home.

At least, that's how things go ideally - and sometimes even in real life. But funny things can happen on the way to the podium.

The electronic Timing and Scoring system is a sensitive and complicated piece of engineering ... that sometimes fails. The antenna that's buried under the track; at some tracks, is exposed to heavy trucks, misuse, and moisture which can corrupt the wiring, weakening the signal and causing the computer to miss crossings. The generator that runs the equipment can conk out. Printers jam, facsimile machines run out of toner, stewards crash their bicycles. These problems are worse at some tracks than others, but when problems occur, they can delay the delivery of results.

Let's think of a typical race weekend with about 200 entries, where each entry runs four sessions: practice, two qualifying sessions, and a race. Maybe the practice is short and cars turn only eight laps; the qualifying sessions are long enough for 14 laps, but the race has 22 laps. That's 58 laps each weekend per car, and with 200 entries, that means there are 11,600 crossing events at start/finish. It shouldn't be any surprise that some of them are missed; even with 99.99% accuracy, there's at least one crossing that isn't correct.

When a crossing is missed, it appears to the computer that there's just been one really long lap. While it might seem obvious to simply look for really long laps, it's possible that there really was a very long lap. A driver might have spun, needed assistance, come to the pits for a belt tightening, and so on. With grids of 40 to 50 cars, it's a difficult job for the two-person team to track everything that might - or might not - have happened during a race session.

When the provisional results come back to Drivers' Services, the stewards get their first crack at them. At this point, the report from scales is probably ready and we can disqualify cars that failed to report or who were underweight. The stewards will radio these cars back to Timing to have them disqualified when the final results are printed.

The timing loop at Pacific Raceways was replaced last week with a new 65' pickup antenna. It covers the full width of the racing surface at start/finish. The new loop with a new coaxial cable has been run underground to the fence. The pit out loop was repaired and run underground to the fence as well. The two loops tested statically correct, the final test is with a decoder box. This should be a great improvement to timing & scoring. Steward's Soapbox, continued...

The stewards probably also have reports from the track workers about behavior problems on-track. We'll go off and interview drivers, collect turn reports, watch videos, and listen to excuses and pleas. (Sometimes, we even read reference letters from past employers.) Drivers can bring issues to the stewards' attention after the race, as well--from timing problems to protests against another driver. The job of resolving problems on track can take a few minutes or it can take hours, depending on the problem and the nature of the claim. That work needs to be finished before the results can go final, though, because the outcome of the review might involve penalties that affect the results.

With that work done, the stewards request an updated copy of the results from Timing and Scoring, who sort the changes after assessing the penalties, and send the printed results back to Drivers' Services where the steward(s) reviews them. If enough time has passed and there are no further protests or challenges, they can be posted as final (P&P 15.5.4).

While this is happening, two interesting rules are in effect that drivers must be aware of. One is that a driver should leave the track no sooner than one hour after their race session ends (CR 911). This ensures the driver is available for questions about their session should they arise. If a protest or report is filed against a driver who can't be found after their session, then we've got little choice but to find against them and carry on with the rest of our duties.

Another relevant rule is that results take 30 minutes to go final; this offers an opportunity for protests to be lodged (CR 905). We strongly encourage drivers to review their results. The PA announcer will call when the provisional results are posted, and you can then make sure your lap count and class are correct, and your transponder was working. While it might be completely obvious to you and a couple other guys that you finished third in class, it's not at all obvious to the stewards, the volunteers at Drivers' Services, or the Points Keeper ,because we were all off working on something else.

While I've outlined the process for race results, there's actually a process for qualifying results, too. Penalties can be issued for problems during qualifying sessions, and cars might fail surprise inspections that dash their qualifying times. Similarly, drivers may notice issues with their timing results and request an adjustment.

After the race weekend, the results are collected, put into the appropriate format, and sent to the stewards for one more review. When we receive this email, we go through our notes from the track - all the scale reports, all the incident reports, and the pages in my special notebook - to check that the penalties were appropriately executed. With the approval of the stewards, the results are forwarded to the Memo Editor, the Points Keeper, and the Webmaster (P&P 15.4.1). Each of those people begins their own work to get the results into the mailings, tally the results into points for the season championships, and get the results posted onto the World Wide Inner-tubes (P&P 15.4.1.4).

We wish that timing antennas never failed, that we would never sign off on the wrong copy of the results, that there were never any penalties or protests, and that we could just post whatever came off the printer as final and be done with it. (Of course, I also wish that I had a Ferrari which ran on empty beer cans and blew thousand dollar bills out of its exhaust. That would be totally sweet!)

Given the realistic requirements of the process, the deliverables it creates, and the demands we already place on the volunteers involved, I think this system works pretty well... given a little understanding. I think that running Timing and Scoring is one of the hardest jobs at the track, and hope that you can volunteer to help with the process at some point in your racing career.



Orange-Aid Fresh squeezed by the ICGCC License Director

My experiences as a new License Director, leading up to and at the first two races so far this season, have been both challenging and rewarding. I have gained an even greater appreciation for the volunteers that make Conference work, and been impressed by the quality and character of the new Novice racers.

I didn't really know what to expect when Greg tricked me into accepting his nomination for the position. Well, that's not quite true. I did know that I would be giving up a lot of time on Saturdays at the track, and I wasn't sure how I was going to feel about that. I'm still very much interested in running my own racing program with some optimistic objectives, and that Saturday time has a definite value to preparing for the Sunday races. I also had some apprehension about measuring up to Greg's example. I can say now without reservation that the Saturday time has been worth it, and I guess you all will be the judge of my performance.

In the course of my License Director duties, I've had the opportunity to meet and work with many other Conference volunteers, and to see the inner workings of a Conference race weekend. The benchmark I have to compare against is my experience in an 18 year career (so far) as a firefighter in Seattle. In a way, there are guite a few similarities between emergency services and running a race weekend. In particular, they both have the potential to be guite dangerous with bad consequences for somebody, and as such, both require a very high level of professional and skillful management. There is also a lot of administrative stuff to complete in a timely manner. From a major metropolitan public safety agency, this type of management is expected. From a group of volunteers, you get what you get most of the time. What are you going to do, fire a volunteer?

I can say without qualification that I have been incredibly impressed by the level of professionalism and proficiency demonstrated by our own Conference volunteers. From the beginning of the race weekend to the end, it's been pretty amazing how smoothly things go. One thing that stands out in particular, the radio communications between race control and the various staff and workers is the equal of any professional agency I have ever heard, and the superior to many. Well done, everybody.

It has also been great dealing with all the people new to racing. One would expect the type of person that is attracted to racing to be a type "A" personality, with a lot of ego. Almost everyone I have dealt with looking to get involved in Conference racing has been very easy to communicate with, very gracious, and very modest.

Many people with a lot of previous experience don't mind going through the steps to earn their place on the grid, some even volunteering or requesting some training before diving back into the deep end. It feels like a partnership. Much appreciated, everyone.

I think racing is unlike many other hobbies that people undertake casually. This shines through in how things work, and how people behave. Racing is also different in other ways, and it's showing during these challenging financial times. Racing is not really just a hobby, it's more of a lifestyle. Most racers include their families and extended families, and these family members have some integral role, or enthusiastically follow the progress of the team. When all is said and done, all of these people make that team a success no matter where the car runs in the pack.

In tight economic times, teams might stretch their budgets by putting off new parts for a while, or shopping more carefully for bargains, but the race goes on, unlike other hobbies. Racers find a way to race, or be involved in racing. That says a lot about the dedication racers have and the commitment not only to race, but to continue to keep their racing families together. Speaking for myself, the guys I race with and against I count as some of my closest friends. Even though we're all in a tight points battle, they have selflessly solved issues on my car on a Saturday while I'm away busy with License Director duties. They recognize that it's about the experience, not necessarily the results, and people make the experience. I think the whole country could learn a few things from racers.

We've had 25+ novices at each race so far this season, good numbers for senior race entries, and many people inquiring about volunteering. The entry list for the upcoming race at Portland has over 215 entries, including 33 Novices! Things for Conference racing are looking good. If you have been on the fence about coming out to the track, get off and come on out. If the racing budget means you have to leave the car at home for now, come on out anyway. We'd all love to see you. Maybe volunteer for something, it's been a great experience for me, maybe you'll find it to be the same.

See race announcement for registration and tech hours.

- 1. NSF checks will be charged and additional \$50.00 fee.
- 2. Tire services **MAY** be available.
- 3. Consumption of alcoholic beverages is allowed only after the conclusion of ICSCC racing for the day. Anyone caught consuming or under the influence of alcohol prior to that time will be asked to leave SCR. See ICSCC Competition Regulation 610 Impairment. This rule will be enforced by the Race Steward.
- 4. No smoking is allowed Hot Pits, Pre-grid or any SRP buildings.
- 5. No open fires! BBQ's may be used on pavement or gravel areas only.
- 6. Minor Release Forms must be completed by parent/guardian for all minors under the age of 18.
- 7. Children under 16 years of age are not allowed in hot pits or pre-grid. Children under 12 years of age must have direct supervision at all times.
- 8. Pets must be on leashes at all times.
- 9. No skateboards or roller blades. Bicycles and small motorized vehicles may be operated in the paved/gravel areas of the paddock.
- 10. Pit and pre-grid roads must remain clear. This is a fire department requirement.
- 11. Speed Limit in paddock is **SLOW!!** Please use extreme caution. The Race Chairman will strictly enforce this regulation.
- 12. No racing engines may be started prior to 7:15 am. Due to sound ordinance, all racing engines must be shut down by 8:30 pm each day.
- 13. Refueling is not allowed in pre-grid.
- 14. Family and crew members of drivers are to contact the communication person at pre-grid with any questions regarding their car or driver.
- 15. Damage to the track, ground or buildings, regardless of cause will be charged to the driver responsible. Also, any damage to any equipment or devices utilized by ICSCC or NWMS to conduct this race will be charged to the responsible driver.
- 16. Because of the possibility of hot weather at Spokane County Raceway, damage to the asphalt paving in the paddock, pre-grid or any of the SCR road surfaces may result from the use of jack stands, floor jacks, canopy poles, etc. Please bring something to use under these items.
- 17. All entrants at this event must be prepared to present at tech inspection an empty, re-sealable container(s), marked with the drivers name and license number, capable of holding 2 gallons of liquids. These are to be used to remove all used engine oil, antifreeze, brake fluid, cleaners, etc. from SCR.
- 18. No more tires will be disposed of or abandoned at Spokane County Raceway.
- 19. Be prepared for WARM WEATHER. Drink plenty of fluids!!
- 20. All entry withdrawals must be submitted in writing to registration prior to the time on-track sessions begin for the Saturday or Sunday race group(s) from which the entry is being withdrawn. Withdrawal forms will be available in Registration.
- 21. All cars must exit the track at Turn 4 after all practice, qualifying and race sessions.
- 22. Any car exiting the race track at Turn 4 or elsewhere and proceeding to the pits or paddock during a race, may not re-enter the session. (RACE ONLY). See ICSCC Competition Regulation 712.
- 23. PLEASE NOTE Per ICSCC Competition Regulation 1105 G, all cars are required to have towing eyes. It is very difficult to get cars out of the pea gravel without them.

Any Additions or changes to these Supplemental Regulations will be in the form of a Driver Letter in the Driver Packet you receive at Registration. You, the driver, are responsible for reading these regulations and ensuring that you, your crew members and family understand and follow them. **The Driver is responsible for any infractions.**




