After several years of dashed expectations, contractors are finally seeing preparations of large government road investments pick up pace. Even more such projects should come to the fore between 2010 and 2012. However, the falling prices of construction materials and labour and rising competiti on are a source of a serious price decline in the road works segment.

Yet, the much-awaited acceleration on road work programmes together with the forecast revivals in the overall economy and in large-size construction projects, could help to reverse the down-trend in prices – which would, at the same time, cause many problems for those who won in this year's tenders. The three scenarios drawn in this report for the development

of the road market will assist companies in assessing the pace at which this sector will advance towards Euro 2012 championships and whether it will reach that goal.
