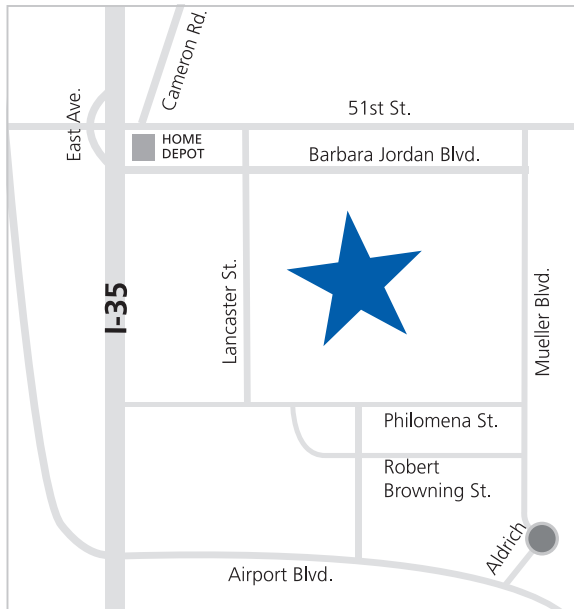

MEDICAL OFFICE

Driving North on I-35:

- Take the 51st/Cameron Rd. exit (237) and merge into the far right hand lane.

- Take an immediate right past the Strictly Pediatrics building into the parking garage.

Driving South on I-35:

- Turn left at Barbara Jordan Blvd.
- Take an immediate right past the Strictly Pediatrics building into the parking garage.

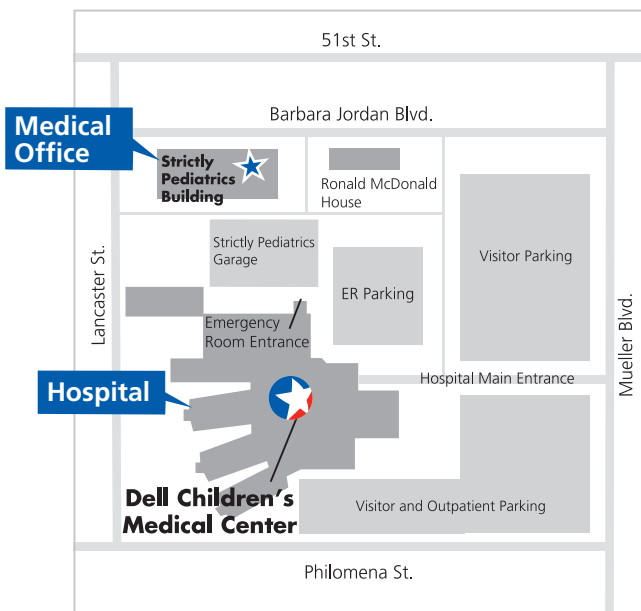
HOSPITAL
