(For Status)

1. Witness should be:

- a. Valid Indian Passport holder**
- b. Valid Green Card holder**
- c. Should not be a citizen of America**

(Copies of (a) and (b) documents should be notarized by Notary Public and submitted along with the affidavit)

2. N/A should not be written anywhere. Complete and correct information should be provided.

3. The affidavit, once completed, should be notarized by Notary Public
