

## RELEASE OF LIABILITY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS,

WHEREAS, each of the undersigned individuals is desirous of using the Ski Rixen waterski cableway at Quiet Waters Park as a skier, and doing so entirely upon his or her own initiative, risk, and responsibility, and is furthermore duly aware of the risks and hazards inherent upon the use of the Ski Rixen waterski cableway.

NOW THEREFORE, in consideration of the Ski Rixen waterski cableway, whether with or without charge, EACH of the undersigned individually and/or as a representative of and on behalf of his or her spouse, child, or ward, hereby releases, waives, discharges, and covenants NOT TO SUE Ski Rixen-Quiet Waters and Broward County and/or their agents, officers, servants, and employees of and from any liability, claims, demands, actions, and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including fatal injury, associated with the use of the Ski Rixen waterski cableway, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF PERSONNEL OR BY THE FAILURE OF THE EQUIPMENT, MACHINE, KNEEBOARDS, WATERSKIS, WAKEBOARDS, WAKESKATES, SLALOM SKI, TRICK SKI, KICKERS, SLIDERS, OBSTACLES, TOWERS, ROPES, SURFBOARDS, KITEBOARDS, OTHER STRUCTURES AND DEVICES, OTHER EQUIPMENT, OR OTHER PERSONS.

This release shall be binding upon the spouse, heirs, next of kin, executors, and administrators of each of the undersigned.

In signing the foregoing release, each of the undersigned acknowledges and represents that he/she has read the foregoing release, understandings and signs it voluntarily; that he/she is at least eighteen (18) years of age and of sound mind; that he/she is legally sober from the effects of alcohol and drugs; that he/she agrees to follow any and all instructions of Ski Rixen Personnel while using the Ski Rixen cableway; and he/she is in good health: suffering from no physical disabilities which might impair his/hers normal cable waterskiing and/or swimming capabilities.
