At the end of February, LWV-Duluth received some special recognition. The Duluth Public Policy Alliance (DPPA) made the difficult decision to disband their organization. As their letter stated, "As we considered where best to make use of our remaining resources, it was decided that the League of Women Voters Duluth would be a viable mechanism to help continue efforts on goals similar to those we have held important. Please accept a donation of \$3425 toward the implementation of your progressive efforts in the Duluth area and beyond." In accepting the award, the Board asked that several of our board members meet with members of DPPA to discuss possible uses for these funds, to ensure they are spent in the spirit in which they were given. If you know anyone who had been a member of DPPA, please express our very sincere thanks for this generous gift!

This year has flown by - It's already March! It's time for next year's nominating slate for the Board and the 2012-2013 Income and Expense Budget to be presented to members in this Voter for your review in preparation for the Annual Meeting which will be held on May 9th at the Radisson. We want to recognize the good work done by those involved in planning the "Women Rising Up for Peace and Justice: Mighty Be Our Powers" event that took place on March 7th. The Teatro Zuccone Theater was overflowing to watch this inspiring (and frightening) film, as mothers, wives, sisters and aunts successfully demanded

an end to the long civil war which ravaged their country, their cities and their families. The film also captured the chaos of war, including the practice of arming of young boys with machine guns to serve as "soldiers." Thanks to Doris Parker, Director of Liberian Women's Intiatives of Brooklyn Park and Aicha Cooper, LWV Duluth member, for facilitating the discussion.

Recently our neighbors, LWVWI, scored a win against voter suppression laws. In a case brought by the LWVWI, the Dane County 9th Circuit Court announced a permanent injunction against implementation of the nation's most restrictive voter photo ID law. The state will appeal this decision. Citizens United (CU) Decision Impact on Minnesota



In January 2010, the United States Supreme Court decision in Citizens United v. Federal Election Commission (FEC) provided that corporations and other entities may make unlimited political expenditures, opening the door to a new flood of money in our elections. In response, a bipartisan group of lawmakers and stakeholders, including League of Women Voters Minnesota ("LWV Minnesota"), began meeting to discuss legislation that would increase the level of transparency in elections, a kind of disclosure specifically contemplated by justices in the CU decision.

As anticipated, the outcomes and complications of the CU ruling are now becoming apparent. In the days prior to the January 3, 2012 Iowa Caucuses, the first of the negative 2012 election cycle independent expenditure and "Super PAC" advertisements hit the airwaves, with an onslaught of ads against Republican presidential candidate and former U.S. House Speaker Newt Gingrich. Currently, the flurry of fundraising and advertising continues on both ends of the political spectrum.

Although neither the LWVUS nor LWVMN currently have an official position on the Citizens United decision; both do have positions on Campaign Finance Reform, relevant to the CU decision impact. The LWVUS Lobby Corps is carrying a message of support for disclosure to U.S. House offices, asking Representatives to cosponsor H.R. 4010, DISCLOSES 2012, introduced by Rep. Chris Van Hollen. The legislation provides essential new disclosure requirements to cover the hundreds of millions of dollars in secret contributions being injected into federal elections by non-profit groups and other entities. The legislation also ensures that there will be timely disclosure by Super PACs. In January 2012, LWVUS leaders requested through Listserv discussions that the LWVUS Board of Directors determine a LWV position on Citizens United and a potential constitutional amendment and also determine if this is a priority for LWV lobbying. Discussion of an official position and related actions is expected in 2012. The LWVMN should be prepared to participate in such discussions.

The completed briefing paper highlights what existed prior to the Citizens United decision, what the decision was, and what the decision has so far meant to Minnesota's campaign finance law and laws in other states.
