TUITION AGREEMENT

I/We understand and agree to the following:

1. Registration fee is due upon signing this agreement and is non-refundable.
2. All outstanding financial obligations must be completely satisfied by June 1st.
3. All accounts must be current by September 1st in order to insure your child's enrollment.
4. Tuition payments are due on the date you agree to. There is no grace period. In accordance with your FACTS agreement, a returned payment fee will be assessed for each payment attempt that is missed. This fee will be automatically deducted from your account **within** 20 days of the date on the letter you receive from FACTS. The student(s) is subject to temporary withdrawal/suspension until the account is brought current.
5. A returned payment fee of \$25 will be charged for each check returned from the bank.
6. Students, whose parents have not paid tuition and fees in full or made arrangements satisfactory to the school, may be denied enrollment for the following school year in any Diocesan or parish school.
7. Students whose tuition and fees are not current at mid-year (end of first semester) may not be allowed to return to school for the second half of the school year.
8. Students whose tuition and fees are not paid in full by the end of the year, or whose parents have not made alternative arrangements satisfactory to the school, may not be allowed to complete final examination requirements.
9. Students who are in the sixth grade and whose tuition and fees are not paid in full by June 1st may be denied participation in end of year activities and graduation exercises.
10. Withdrawing a student from the school after July 1st must be stated in writing and acknowledged by the principal. Withdrawal is subject to the following:

Between July 1 st and July 31 st	- Registration fee (non-refundable)
Between August 1 st and the 1 st day of school	- 15% of annual tuition due
Before the end of the 1 st marking period	- 35% of annual tuition due
Before the end of the 2 nd marking period	- 60% of annual tuition due
After the beginning of the 3 rd marking period	- 100% of annual tuition due
11. In extraordinary circumstances, for good cause, Infant Jesus School may, in its sole discretion, waive the penalty provisions of this agreement
12. Legal recourse may be used to collect outstanding tuition and fees.
