Sanction Conditions:

1. The tournament must be conducted using OSHA rules. Any variance requires a written submission at time of application to the **OSHA** Rules Committee. A written decision to accept/reject such requests will be provided.
2. The tournament must use Hockey Canada certified referees. Sledge experience would be preferable.
3. The tournament cannot be operated by private enterprise, for profit.
4. All players must have insurance coverage.

Tournaments

1.1 Hosting Regulations

- a) Where applicable, hosting regulations will conform with the Ontario Minor Hockey Association (OMHA) regulations except where Ontario Sledge Hockey Association (OSHA) Regulations are different
- b) It is up to tournament organizers to be familiar with OMHA tournament regulations
- b) Sanction fees are set by OSHA, paid to OSHA and outlined on Sanction Permit
- c) Applications are to be made to OSHA Rules Committee
- d) Match penalties and other disciplinary matters are to be reported immediately to Tournament office and all game sheets to be sent to OSHA Rules Committee immediately following the tournament.

2. Participating Regulations

- a) Where applicable, participating regulations will conform with the Ontario Minor Hockey Association except where Ontario Sledge Hockey Association (OSHA) Regulations are different
- b) Particular emphasis must be made to 19.2a (must not take part in any tournament unless sanctioned by OSHA) and 1 (OSHA teams may not enter tournaments nor play in foreign countries without receiving permission)
